## FCBA Annual Seminar – April 30 – May 2

# PRESIDENT'S MESSAGE

## DEAR MEMBERS:

If you associate March with daffodils, basketball and green beer, I encourage you also to start thinking of it as "FCBA Leadership" month. This newsletter contains two important announcements on this score: a request for expressions of interest in next year's FCBA Committee and Chapter Co-Chair positions, and the list of candidates who have been nominated to run for next year's elected positions.

As you may know, the FCBA's fiscal year runs from July 1 through June 30 - which means that the Association's leadership positions will change hands at the end of June. The Nominations Committee, which is comprised of elected and appointed members and is chaired by the FCBA's immediate past president, is charged with generating a slate of candidates for the Association's elected positions: its officers, members of the Executive Committee, a chapter representative and the FCBA's delegate to the American Bar Association. The Nominations Committee also nominates candidates for the FCBA Foundation's Board of Trustees.

The task of the Nominations Committee is a challenging one: there always are many more qualified people for these senior leadership positions than there are slots on the ballot. Under the leadership of Peter Shields and with a lot of hard work, this year's Nominations Committee has selected a great slate of candidates to stand for election. I hope that you will review carefully the information about each candidate that will be included in the ballot materials and participate in the election. Although there will be some tough choices to make, the more members who vote, the better the results will be. I would note, moreover, that the Nominations Committee's work is not over — in addition to overseeing the upcoming election, this year's Committee has decided to continue to work on ways to improve the nominations process, which plays such an important role in the FCBA's governance.

An equally challenging undertaking is the selection of the FCBA's committee and chapter co-chairs - an honor that falls to the incoming President. The FCBA's 28 committees and its 8 regional chapters are extremely active, planning association events and activities, undertaking discrete association projects, and making recommendations about FCBA operations and policies to senior leaders and the Association's professional staff. Simply stated, the FCBA could not function without the dedicated efforts of the 100-plus volunteers who serve as co-chairs of the Association's committees and chapters each year. I know from my own experience that assuming one of these leadership positions is a great way to serve the bar and make a difference. And I also know that striking the right balance that reflects the diversity of the bar when appointing all of the co-chairs is a daunting task for the incoming president. So I encourage those of you who are interested to respond to the request for volunteers for co-chair positions included in this newsletter. Although there is no guarantee that you will be appointed to the specific committee in which you express interest, I know that Harry Martin, our President-Elect, will greatly appreciate having a wide pool of talented volunteers from which to fill these important leadership positions.

### Balancing Work Life and Family Life Brown Bag Lunch

FCC Commissioner Kathleen Q. Abernathy, Debra L. Lee, President and Chief Operating Officer of Black Entertainment Television, and Michele C. Farquhar, a partner with Hogan & Hartson, are the featured panelists for a brown bag lunch on the topic of balancing work life and family life. The lunch will be held on Friday, March 12, from 12:00pm-2:00pm, at the Federal Communications Commission, and is being sponsored by the Diversity Committee.

Commissioner Abernathy is responsible for representing the public interest in each of the policy areas under the FCC's jurisdiction, including regulation of broadcast television, cable, satellite, domestic and international communications, wire-

less telephony, consumer protection and education, and general enforcement of FCC rules. Prior to her appointment on the Commission in 2001, Commissioner Abernathy served in various executive-level positions in the private sector. She was Vice President of Public Policy at Broadband Office Communications, Inc., a partner at the law firm of Wilkinson Barker Knauer, Vice President for Regulatory Affairs at U.S. West, Inc., and Vice President for Federal Regulatory Affairs at AirTouch Communications, Inc. She is also a former president of the FCBA and the mother of one child.

Ms. Lee leads the largest media and entertainment company targeted to African Americans, with BET now reaching more than 74 million homes. Ms. Lee joined BET in 1986 after practicing for five years at the law firm of Steptoe & Johnson. During Ms. Lee's tenure at BET, she has played pivotal roles by serving as the network's executive vice president of strategic business development, executive vice

president and general counsel of the legal affairs department, corporate secretary, and president and publisher of BET's publishing division. She delivered her first baby while overseeing the construction of BET's corporate headquarters, and simultaneously running BET's publishing division and acting as BET general counsel. She now has two children.

Ms. Farquhar is co-chair of Hogan & Hartson's Communications Group, and practices before the FCC, Congress, the White House, DOJ, the Department of Commerce, and international regulatory bodies. Prior to joining Hogan & Hartson, she served as chief of the FCC's Wireless Telecommunications Bureau. She has also held senior-level positions at NTIA, where she was the acting deputy assistant secretary, and at CTIA, where she served as vice-president for law and regulatory policy. She has been nominated to serve as the president-elect of the FCBA beginning in July 2004. She is currently the FCBA secretary as well as a member of the executive board. She is the past president of the Duke University Alumni Association. She has three children, and a black belt in Tae Kwon Do.

Kimberly Kelly

This month, in an ongoing series of articles designed to introduce to you FCBA members and their interests outside of the communications industry, we talked with Kimberly Kelly.

Ladies and Gentlemen, start your engines! We all know that practicing communications law in Washington, D.C. can require deft maneuvering, keen responsiveness and, at times, the desire to control the uncontrollable. So it comes as no surprise that some FCBA members simply cannot leave their work at the office. Kimberly Kelly, however, gives new meaning to bringing your work home with you - well, the attitude for sure!

In Kimberly's off-time, she takes to the race track in her turbocharged, 5 speed Audi A4 Quattro sedan. Through the Audi Club North America, Potomac-Chesapeake Chapter, Kimberly has been trained in the art of performance driving and has put her skills to the test at the Summit Point Raceway Course in Charlestown, WV.

Quite simply, performance driving can be described as a safety-minded, high speed event where you drive (often in your own vehicle) around a race track with groups of drivers that have similar skills and speed comfort levels. However, upon discussing the subject with Kimberly, her knowledge and passion for the activity might make you think she moonlights as Pit Crew Chief for NASCAR's Dale Earnhardt, Jr.

Following days of classroom instruction, course/circuit driving with an instructor and skid pad training in a track-provided Crown Victoria, Kimberly was ready to test the limits - both her own, and those of her Audi A4.

Putting her training to task, she has developed a comfort with gauging track conditions, passing on the straight-away, and taking hairpin turns at speeds in excess of 50 miles per hour. Despite the professional instruction, Kimberly assures us that she is a safe and courteous driver off the track. When prodded about her ability to turn off the need for speed, Kimberly replied, "conscientious and careful driving is necessary both on and off the track. The only difference is the speed limit, which I observe."

With a busy career and an insatiable appetite for travel - Kimberly has been to Trinidad for the annual Carnival celebration four of the last five years - it's hard to believe that there would be any time left for performance driving. To this, Kimberly responded, "it is important to make time for your passions. There is nothing like getting in a good drive now and again...all you need is a little speed, artful corner negotiation and the confidence to know that you have become so intimately familiar with your car that you can direct it to perform in any way you want!" Well said, Kimberly, see you on the road.
