FCBA Comments on New Rules Proposed for Multijurisdictional Practice in California

On July 7, the FCBA filed with the California Supreme Court Multijurisdictional Practice Implementation Committee comments on new rules it has proposed to “ease and clarify current restrictions on the practice of law in California by attorneys who are not members of the State Bar.” The FCBA has suggested changes in the proposed new rules to facilitate communications attorneys and others in specialty fields serving the needs of their clients for assistance in transactional work and other representation that requires the attorneys’ temporary presence in California.

ATT Case In Perspective: A Twenty Year Retrospective

THURSDAY, OCTOBER 16, 2003 — 3:00 — 7:00 P.M.

Throughout the 1970s and early 1980s, the antitrust case against AT&T appeared to be a quixotic quest. But the perseverance of antitrust enforcers and the effective case management of Judge Harold Greene, as well as the efforts of various other backers in the political and business world, gave rise to the biggest antitrust success of the 20th century. The breakup of AT&T spawned competitive sectors in long distance and equipment manufacturing as well as transformed the nature of the telecommunications industry, ultimately paving the way for the regulatory reform effort launched by the Telecommunications Act of 1996. Because of its impact on the telecommunications industry and antitrust law, the repercussions of the AT&T case merit close examination twenty years after its settlement went into effect.

During and after a lunch of delicious sandwiches and refreshments provided by Adler, Pollock, and Sheehan, excellent practical questions and answers abounded, prompting Chairman Germani to comment that more of that type of insightful, open exchange should take place to allow for better proceedings and communication between PUC staff and those practicing before them.

On June 27th in Boston, MA at the host law firm of Mintz, Levin, Cohn, Ferris, Glovsky, and Popeo, P.C., the N.E. Chapter held a two-panel forum on the Triennial Review Order (despite a lack thereof), and the emergence and regulation of Voice-Over-Internet Protocol. Food and refreshments were provided by RNK Telecom. Attendance was good. Appearing on the Triennial Review panel were: Mike Morrissey, AT&T Vice-President of Law and Government Affairs, Eastern Region; Paul Vasington, Chairman of the Massachusetts Dept. of Telecom.; Richard Fipphen, Senior Counsel, MCI for Maine, Massachusetts, and Rhode Island; and Jeremy B. Miller,

Acting Assistant Division Chief of the Policy Division of the FCC's Wireline Competition Bureau. The two-panel event opened with kind opening comments by previous FCBA N.E. Chapter Co-Chair, Cameron Kerry, whose law firm was also the host. Despite the lack of an FCC Order, about which Chairman Vasington remarked that this panel was the third he had spoken on without benefit of the Order, there was lively and productive discussion about the issue of state implementation, appeals, application of the Order, and related topics.

After a brief break and a tasty treat and beverage or two, the VOIP panel started, consisting of Triennial panel holdovers Vasington and Morrissey, with the addition of Julie Patterson, Senior Counsel for

Time Warner Cable, Rick Cimerman, Senior Director, State Telecommunications Policy for National Cable and Telecommunications Association (NCTA), Jonathan Draluck, General Counsel and V.P. Business Affairs for iBasis, Inc. (a Burlington, MA based VOIP carrier), with an introduction to VOIP by Alan Bugos, V.P. Engineering for iBasis. This panel presented view on a variety of VOIP services, from provision of international VOIP (iBasis), to domestic (AT&T and NCTA members), to use of local VOIP (Time Warner Cable). Among the themes that were echoed by most of the panel was that although VOIP should not be regulated, it will still likely be regulated in the near future; and that VOIP is here, here to stay and will replace existing switched exchange in the near future.

Among the topics being researched for future panels are broadband (and telephone) over power lines and eligibility of wireless and other providers for USF compensation.

Save the date — the next **Bread for the City Legal Walk In Clinic** date is **August 9, 2003**. Tell your friends! August is a particularly difficult month to get volunteers, please consider volunteering if you will be in town on the 9th.

The FCBA's Young Lawyers Committee organizes volunteers to spend three hours once a quarter helping lower income individuals through a clinic sponsored by the DC Bar. We co-volunteer with the DOJ Antitrust Division. Attorneys receive a half-hour overview/orientation beginning at 9:30 am over bagels and juice. Volunteers are expected to assist clients only during the time they are at the clinic. No special legal knowledge is needed — attorneys generally need to keep an eye out for potential legal issues while using their common sense to solve a myriad of questions and make referrals to other organizations. Experienced attorneys on-site will assist FCBA attorneys and other volunteers with any questions. Previous attendees have described this as "the most satisfying volunteer experience I've had as an attorney."

You must either be a member of the DC Bar, have an application pending to the DC bar, or be an employee of the federal government to provide advice. Those who are not DC bar members, paralegals and law students are needed, however, to provide intake and triage. Law students can have the opportunity to sit in on advice sessions. Remember, dress is casual, but respectful. Bring a pen.
