

# FCBA Annual Seminar Activity ~ TOUR OF MONTICELLO SATURDAY AFTERNOON, MAY 2, 2020

**A Private Hemings Family Tour:** Opened to the public in 2018, this small-group tour explores Monticello using the stories of Hemings family members, one of the best documented enslaved families in the U.S. Decades of documentary research, archaeological analysis and oral histories provide narratives of struggle, survival and family bonds across generations.

Note that this 1-hour, 45-minute tour includes a fair amount of walking over uneven terrain. It's not recommended for children under 12.

**The Monticello House Tour:** For those with young children, this Day Pass and 45-minute House Tour provides an intimate look at the extraordinary house Thomas Jefferson built and furnished for himself and his family.

Everyone will begin the afternoon as a group with a box lunch in the Café.
