PRESIDENT'S Message

TO THE FCBA COMMUNITY:

It's September! (Wait – how is it September?) Time to go back to school (however that looks), eat and drink all things pumpkin spice, wait for the crisp autumn air to finally hit the D.C. area, and embrace new beginnings. I'm excited to announce several new beginnings for the FCBA.



First, we have two new subject matter committees. The FCBA's bylaws provide for certain standing committees, and other committees may be created on an ad hoc basis before they are potentially considered to become standing committees. We typically use this process to try out ideas that seem like a good fit for the bar, and some of our most compelling programming (e.g., Internet of Things, consumer protection, artificial intelligence, telehealth) has come through ad hoc committees. This year, the Executive Committee has approved creation of an ad hoc committee on cybersecurity. Sitting at the intersection of cutting-edge technology and evolving law and policy, just like our bar, cybersecurity is a perfect focus for the FCBA. Thank you to **Brian Murray, David Redl, Savannah Schaefer,** and **Dana Zelman** for taking on this initiative. We are eager to use this new committee to showcase how the FCBA is constantly growing and changing to reflect the fields in which we work, and to spotlight the expertise and connections of our members as we advertise our virtual programming to an audience that goes well beyond the FCBA membership. On that note, ad hoc committees are also a way to stretch the reach of our bar and promote connection and collaboration with people and organizations who might not traditionally fall under the FCBA umbrella. Thus, the Executive Committee also has approved creation of an ad hoc committee on connected and autonomous vehicles, and we look forward to welcoming members from Ford, Uber, and the California State Transportation Agency to the FCBA's committee leadership for the first time. Thank you to **Brian Barnard, Avonne Bell, Sean Conway, John Kwant, Lori Pepper,** and **Jeff Stewart** for serving as our inaugural connected and autonomous vehicle organizers.

Second, we have created a new committee that will be focused on programming designed to advance, promote, and connect women within the FCBA. As we convened in January for our first-ever FCBA Women's Summit, we celebrated the diversity of women in the bar and a wide range of ideas. One resoundingly uniform message was: We need more of this! I'm grateful to **Melissa Newman** for volunteering to head up this effort, along with **Svetlana Gans, Mia Hayes,** and **Tawanna Lee**. So stay tuned for information on upcoming events and initiatives – including a virtual 2021 FCBA Women's Summit – and how you can get involved.

Third, as we expand our programming and outreach to encompass issues and practice areas in emerging technologies, we want

HOW TO RENEW

1. LOG IN

Every member must log in to renew. To log in to your account, [click here](#) or go to www.fcba.org and click the Log In button.

Like many of you, the FCBA staff is currently telecommuting. For this reason, **we strongly encourage you to pay online by credit card.** We are still accepting payment by check, but the processing of check payments may be delayed.

IF YOU FORGET YOUR PASSWORD

If you don't know your password, please click on the "Forgot your Password?" link and follow the instructions to generate a new password. The system will then email you a link which you must activate to change the password.

Note that the link emailed to you is only good for one hour from the time you request it and that it can be only used once.

2. MAKE YOUR PAYMENT

TO RENEW ONLINE BY CREDIT CARD

- Once logged in, go to the My Transactions link. Here you can see a list of all your orders and invoices.
- Click on the Pay Open Orders button on the right side of the screen.
- Check off the box next to the order/invoice you wish to pay, click Next and follow the instructions to process your payment.

TO RENEW BY CHECK

- Once logged in, go to the My Transactions link. Here you can see a list of all your orders and invoices.
- Click the View More link under the Invoice Details column on the right side, then when the page opens click on Print This Page on the upper right side to print out the order.
- You must include the printed order with your check and mail both to the address on the order.

TO PAY FOR A GROUP OF RENEWALS AT ONE TIME

Some firms and companies prefer to pay for a group of membership renewals at one time with one check. There are two methods to do this:

1. Each individual member must log in and print out his/her own order and submit it for payment through their internal channels. The firm or company must then send us all of the invoices at one time, along with the check.

OR

2. The firm or company must send us a list of renewing members, each person's membership category and the associated fee, along with the check.

If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

to ensure that our content is cohesive, that we're being both as efficient and as comprehensive as possible, and that there aren't any areas we're missing. We have so many opportunities! Thank you to **Jamie Susskind** for serving as coordinator for emerging technology programming, working with each of the applicable standing and ad hoc committees, as well as the tech sector outreach working group led by **Megan Stull**, toward refining and promoting the FCBA's efforts in this area.

Finally, while it's not entirely new or limited to back-to-school, I also want to talk briefly about mentoring. I have personally benefited from the FCBA's culture of mentoring for nearly 20 years, and I believe it's inherent in who we are as an organization. Without the ability to meet for a cup of coffee or invite someone for an office visit, combined with the added pressure of living and working (and, for many of us, parenting and turning our homes into schools) during a pandemic, many of the individual mentoring relationships that might otherwise be created or fostered could disappear this year. We cannot let that happen – not to the detriment of today's students and young lawyers or to the detriment of something that is so ingrained in the FCBA. However, as with so many other things in this unprecedented year, our ability to connect virtually creates silver

linings, such as the prospect of mentoring relationships between members of different chapters or between a chapter member and someone in D.C. We have many paths within the FCBA to establish mentoring relationships: the Young Lawyers Committee and the Diversity Committee have already organized mentoring events this year; the Diversity Pipeline Program team is focused on outreach to diverse law students; the Moot Court Committee's work connects law students to FCBA leaders; the FCBA Foundation assigns mentors for its scholarship and stipend recipients; and the Federal Communications Law Journal seeks to connect its Note writers with FCBA members who can serve as topical mentors. **Justin Faulb**, who previously has served as a YLC co-chair and as chair of the Foundation, will work to coordinate and connect all of our mentoring activities and help identify gaps we need to fill in during this challenging time for students and young lawyers. If you can find time in your schedule to be a mentor this year, or if you'd like to assist Justin in coordinating, please reach out to Justin or me.

The FCBA **Internet of Things Committee** will sponsor a CLE on **Thursday, October 22 from 3:00 – 5:00 p.m.** entitled “Legal and Regulatory Barriers to Widespread IoT Deployment.” This program will be held virtually via the Zoom platform.

The Internet of things (IoT), at a high level, describes the interconnection via communications networks and computing devices embedded in everyday devices (e.g., smart refrigerators or smart speakers) to send and receive large datasets. IoT enables innovative techniques that make our lives better, such as connected health, distance learning, and precision agriculture. However, the continued success of the IoT revolution will depend on consumers and enterprises’ having near ubiquitous access to 5G wireless networks and the IoT devices themselves. Although the United States has made great strides in promoting both, there are still significant legal and regulatory hurdles this innovative ecosystem must overcome to unleash IoT’s full potential.

This discussion will evaluate where the legal and regulatory questions are and how practitioners can advise clients interested in participating in IoT at the infrastructure and device level.

degrees of transparency about what data they collect, how they use it, and what third parties do with it. Consumers, public interest groups, some tech companies, regulators, and governments across the world have increasingly criticized this state of affairs – and called for reform.

This event will present an in-depth discussion of key trends in these reform efforts, including the growing role of consumer data rights, increasing platform regulation, and ongoing debates over the efficacy of enforcement efforts. We will examine the varying approaches that recently implemented laws, such as the European Union's General Data Protection Regulation (GDPR) and the California Consumer Privacy Act (CCPA) have taken on these three topics – and what approach future laws and regulations, including one on the November ballot in California, may take in the new decade.

During the twenty-teens, numerous jurisdictions expanded the obligations faced by companies that collect personal information, particularly in their duty to provide consumers, or data subjects, greater control. Our first panel will critically evaluate the rise and future of legally actionable data subject rights, looking to issues such as: Have new laws given consumers effective and meaningful choices with respect to personal information – or have they just created notice fatigue? What has the effect been on competition? Will the next wave of privacy reform continue to place such a heavy focus on data subject rights? How do property-rights or fiduciary-based proposals, such as New York Shield, fit in? How can organizations cope as rights-related obligations proliferate in different jurisdictions?

SESSION II: PLATFORM REGULATION

The executive branch, lawmakers, and regulators have recently placed a renewed focus on the responsibility that platform providers have for both their own privacy practices and also for the activities of their users. In late 2019, the Federal Trade Commission conducted a workshop to explore whether an update to the Children's Online Privacy Protection Act (COPPA) Rule was needed in light of the increased use of IoT, social media, ed tech, and general audience platforms hosting third-party directed content. This summer the Trump Administration issued a pair of executive orders concerning the popular TikTok app, citing national security concerns and the massive

amounts of user data collected by the Chinese-owned app. Meanwhile, an amended version of the Earn It bill is moving through the Senate which, if enacted, would empower states to prosecute platforms and authorize private lawsuits against platforms who fail to comply with state requirements, which could weaken the ability of platforms to provide users with privacy-protecting end-to-end encryption. Panel II will discuss and debate the current and future states of platform providers' evolving responsibilities and risks.

This event will help Section 230 newcomers get a baseline understanding of the statutory provision and also dive deep on key developments, including whether the FCC has authority to adopt rules interpreting Section 230, how section 230 has been interpreted to date, and the legal and policy implications that would result from changes to the law.

Get to Know an FCBA MEMBER

So, I can't know what your summer has been like, but my summer, while having a few mellow in-person and socially distanced encounters, has been pretty well confined to household members. Thus, I continue to crave opportunities to connect with fellow FCBA members as one way of maintaining important connections, even if the connection comes by way of videoconference. This month, Sean Spivey graciously agreed to be interviewed for the column (in his personal capacity), even though I know he has plenty going on professionally as he recently became the Wireless and International advisor to FCC Chairman Ajit Pai.



Q: What attracted you to the field of communications?

A: I got out of law school in 2009, which was not the ideal time to be graduating and looking for a first job as an attorney given the economy. I started out as a litigator in a firm in Houston, Texas. It turned out that several of our clients were communications companies. So early on, working on litigation matters for them, I got glimmers of what the FCC was about and I was intrigued. Over time, it became more obvious to me that I did not want to be a litigator, but I was interested in seeing more of the scope of communications law and policy. This was as the wireless world was moving from 3G to 4G and all the new capabilities stemming from that transition were becoming apparent. So I did what I counsel others to do that want to make a move; I started looking into who I knew that might be able to plug me into DC communications regulatory circles for potential jobs.

From there I networked (and I networked and I networked)! Eventually, a friend from college connected me to Bryan Tramont who was kind and helped to schedule a number of meetings for me to connect with people in the DC communications regulatory community and to learn about work opportunities. Eventually this led me to Rebecca Murphy Thompson who was then General Counsel of CCA. She and Steve Berry hired me to be Assistant General Counsel of that organization, which ended up being an amazing introduction

to Washington communications regulatory practice.

Q: What happened next? And did things work out as you planned?

A: After a couple of years I left CCA to work as an associate and later as a senior associate in the communications practice at Hogan Lovells. I had worked some with Ari Fitzgerald, Trey Hanbury and Michele Farquhar through my time at CCA, but I knew working at a law firm and in a varied communications practice at Hogan Lovells would be a great way to develop and hone the tools in my lawyer's toolbox. That proved to be the case as over the course of nearly four years I worked on transactions, on media issues and on the Telephone Consumer Protection Act matters, as well as continuing to work on a range of spectrum matters. I was even seconded for a while to one of the firm's clients, which was also a terrific opportunity and a chance to experience working "in-house." Then I had the chance to work at the FCC as a legal advisor in the front office of the Wireless Telecommunications Bureau. Because I had not had that opportunity before, I wanted to make the leap and learn firsthand how matters moved from proposals to final rules. And more recently, I have moved into the Chairman's office. All that to say, while I'm very pleased with how my career has unfolded in the decade since graduating law school, I never would have guessed at the start (much less when I first entered law school) that I would be a communications regulatory

lawyer practicing at a federal agency in Washington, DC!

Q: What is one of the most interesting and challenging things you've done in your career or current position?

A: When I got to the Bureau, I have to say it was both interesting and challenging to work in 2019 and early 2020 on the Digital Opportunity Data Collection and on broadband mapping. Mapping is a really important and complex aspect of being able to size and evaluate the issue of broadband service gaps and potential solutions. I'm from rural Southeast Texas and most of my family still lives there. My parents have some LTE availability in their home but limited options for fixed broadband service. Having reasonably accurate ways of mapping broadband availability pulls together a variety of disciplines beyond law, including engineering, economics and statistics. It has been professionally rewarding to work with a range of subject matter experts to tackle this important issue.

Q: Is there someone who surprised or impressed you during your career and why?

A: Looking back I have to say there were a couple of very kind people such as Bryan Tramont and Rebecca Murphy Thompson who were willing to help someone with an interest in communications but not an established track record. They made all the difference to me in that they were so open and generous with their time trying to help me and others more junior attorneys in the profession find their way. They are not by any means the only folks out there that mentor and guide younger professionals (myself included), but they were particularly important to me as I was getting started.

Q: What do you enjoy reading?

A: I try to make time to read and I like reading across a board all range of

topics and genres. I am currently reviewing a number of American classics and just finished rereading “In Cold Blood” by Truman Capote. Also, I recently enjoyed just for fun reading “Legendary Children: the First Decade of RuPaul’s Drag Race and the Last Century of Queer Life” by Tom Fitzgerald and Lorenzo Marquez.

Q: Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: As I’ve already noted, because in my personal experience networking was pivotal to me becoming who I am now, I would say someone getting started should network, network and then also network. It’s really never a waste of time to make

connections to talk to people who, while they may not be in a position to offer you a job, may instead spark an idea or suggest a new connection to make.

In terms of practical, on-the-job career training tips, I would say that no one expects you to be a subject matter expert on complex communications issues on day one. But I would suggest people always keep firm control over the things that are in their own wheelhouse. This means making sure your work is typo free, features good grammar and is organized, thoughtful and logical. You usually only have one shot at making a positive first impression so that’s something you can absolutely do, even without being an expert on any particular topic.

Q: What is something interesting about you that people are not generally aware of that you are willing to share?

A: Well, I’ve developed a healthy appetite for Peloton biking in the COVID world we are living through now. I have my own handle (@CSeanSpi) that anyone on Peloton can follow. I’ve been thinking that there are other FCBAers that probably use the platform as well, so maybe we should create an FCBA telecom hashtag for FCBA Peloton devotees to connect! That would be a cool picture of a virtual group experience for the next newsletter.

Q: Any other observations about how you are coping working from home in the COVID era?

A: I have to say with being at home so much, my partner and I started out doing a mini open concept “WeWork” using our dining room table as a common workspace. But as things have evolved (and based on my new role) we’ve since found it to be more productive to have slightly separate workspaces. I’m usually in the home office now--just a few steps away from the Peloton.

Q: How long have you been an FCBA member and what to you is the value of FCBA membership?

A: I’ve been an FCBA member since 2012. I think for me one of the biggest values of engagement with the FCBA is an amazing ability of FCBA members to foster the development of young lawyers and other professionals. I look back and think about how significant the Young Lawyers Committee has been for those who’ve had roles in it; so many have developed to become bar leaders like Brendan Carr, Rachel Bender, Mark Brennan, and even Natalie Roisman, our current fearless leader (as just a couple of examples). You can’t do much better than that as a relatively easy way to get your feet wet and meet people and do really positive things for the broader community. Participation in the YLC and the wider FCBA is a wonderful way of helping younger members explore and develop their potential.

FCBA JOINS DIVERSE BAR COALITION ~ Meet Founder Gage Javier

The FCBA Executive Committee has voted to join the new Diverse Bar Coalition – National Capital Region (“DBC”) as a Founding Member. The DBC will bring together bar associations, law firms, companies, and others who are committed to leveraging the resources of individual organizations to collectively advance, promote, and support diverse attorneys and law students in the Washington, DC metro area. The FCBA is proud to be the first practice area bar to join this initiative and will be represented on the DBC by President Natalie Roisman, President-Elect Megan Stull, Bob Branson of the Relations with Other Bars Committee (and FCBA Past President), and Sanford Williams of the Diversity Committee.

We spoke with the founder of the DBC, Gage Javier, an attorney at Buckley LLP and President of the Filipino American Lawyers Association of D.C. (“FALA-DC”), about the creation of this exciting new coalition.

Q: How did you decide to create the DBC?

A: This wasn't a lightning strike, but more the evolution of an idea from working and talking with many different bar leaders over several years. There is not enough representation of diverse attorneys in the legal profession in general, even though every single bar association seems to be doing programming about law student pipelines, judicial diversity, etc. Everyone is reinventing the wheel for their own community and working in siloes, and it's not efficient – or effective enough. So I thought we should blend our resources and information, teach each other on best practices, and try to accomplish things on a bigger scale.

Q: How did you start the process?

A: In theory, I knew people were interested, but I was not sure if anyone had the time to actually do it. I just started doing all the legwork myself, combing websites and social media to find state bar leaders, affinity bar leaders, and more. I sent individual emails and made phone calls, ultimately building out a list of about 80 people over 40 organizations and multiple jurisdictions. Then we set a date to convene.

Q: What are the DBC's key initiatives, and what is the timeline for launch?

A: Our target date for an official launch is late January 2021. We will have a virtual event with one or more keynote speakers, and we hope to be able to showcase the diversity of the groups that are part of the DBC – for example, an opening

ceremony from the Native American Bar Association and video clips that highlight leaders from founding member organizations. The launch will highlight the power, strength, and reach of the DBC and the real change that can happen as we pool our resources. We will also announce our five key initiatives: (1) legal pipeline development; (2) diversity in leadership; (3) a speakers bureau; (4) diverse recruitment and retention in the workplace; and (5) attorney referrals and business development. People will be able to sign up immediately following the launch to work on these areas.

Q: What role do you envision for law firms, companies, and other individuals or organizations that are not bar associations?

A: I have an MBA, so of course I'm always thinking about how to blend what we do in the legal profession with business. Ultimately, I can imagine companies using the DBC as a vehicle through which they can increase the diversity of their in-house and outside counsel. In the short run, we are working on the right structure for engagement by organizations other than bar associations, but I know we will have a path for that type of membership or support. Any interested organization can have their diversity point of contact reach out to me at president@faladc.com about how we can partner.

Q: How can the FCBA and our members help right now?

A: We would love volunteers to help in standing up the organization, whether that's providing pro bono legal services, working on programming, offering administrative support, engaging in outreach, or in other areas. We do not have any paid staff, and at the moment this is an entirely volunteer effort. This would be a particularly great opportunity for young lawyers or law students. I also know the FCBA is a nationwide organization, and although the DBC is a regional coalition at this point, we are interested in learning from and partnering with diverse bars around the country. We are only aware of one other diverse bar coalition, in the Bay Area. We would love for the FCBA chapters to connect us with their local diversity bars.

Q: What do you see for the DBC when you look into the future?

A: I look back at my own experience so far, and I want to build something that would have helped me 5-10 years ago. It's not just about the legal profession, but also about life in general. People can feel lost in their careers, without the right mentors or peer groups to help them navigate. I view this as a true coalition across all communities and practice areas. Everyone should want to strive for equity and equality – we need

allies to be a key part of the conversation and a driving force in the work of the DBC. The legal profession is at the center of change in so many areas of law and policy, so more diversity in the legal profession, particularly at senior levels, is a way of affecting society at its core. If we don't attempt to address this issue now, when it could have such a significant rippling effect in the future, I believe we are failing in our responsibility as

practitioners of law. The coalition we form today will be the first one of its kind in this region, ever. So in our future, I see our primary five initiatives taking off. I see funding for public sector fellowships. I see a hackathon for key priority issues. And I see an event 20 years down the line, where we celebrate that we are on our way to ensuring that these conversations don't still need to be happening generations from now. I recognize that this isn't an easy lift, but if we don't come together now, at this time, I don't know that it will ever happen.
