## PRESIDENT'S Message

### DEAR MEMBERS:

It's finally feeling like fall. The kids are back in school, the temperature is noticeably cooler in the morning, and we are dealing with the post-Labor Day realities of life. Now is the real beginning of the FCBA year, a time when the committees and chapters roll out the fruits of their summer labor...a wide range of CLEs, brown bags and noteworthy networking events. You'll see evidence of this throughout the newsletter.



You may have noticed the FCBA got a little press in the form of a *Communications Daily* article published in early August entitled "FCBA Looking to Focus More on Technology, New Service Opportunities." While the author chased a number of disparate themes in her interviews and review of historical FCBA and FCBA Foundation data, one thing that stood out in the article was the ability of the FCBA and its Foundation to self-assess and to take positive action. We do not stand still. We know the world we work in has and continues to change, and that FCBA members do not have a tight focus solely on regulated industries or issues; we are evolving along with our members. One stated goal for our programming this year is that, where possible, we examine not just law or communications policies, but the underlying architectures or technologies of communications networks and ecosystems, so that our members, through thoughtful programming, gain a broader appreciation of what's already here from the perspective of technology, as well as what's to come. Two near term examples of this focus are the CLE offerings in September from our Homeland Security and Emergency Communications and our Privacy and Data Security Committees. On September 12, the Homeland Security Committee will be examining the architecture of NextGen 9-1-1 in addition to examining the legal and policy issues attendant on its roll out. On September 27, the Privacy and Data Security Committee will sponsor "An Evening with a Hacker," demonstrating a mock data breach, examining network vulnerabilities and potential solutions, as well as discussing legal and policy issues raised by network intrusions.

As for new FCBA and Foundation service opportunities, they are as unlimited as the interest, ingenuity and energy of our members. One example is the leadership of the Young Lawyers Committee, and their work with this year's Charity Auction beneficiary, Transitional Housing Corporation. In addition to hosting youth mentoring events, on September 8 the Auction Committee will be furnishing an apartment and welcoming a family home, in short doing more than simply donating needed funds to the organization. Make sure to contact **Brendan Carr** or **Grace Koh** if you are interested in volunteering for this project and see **page 11** for more information about this initiative and other auction-related information. In the same vein, the Foundation started a new program last year with Martha's Table's afterschool program, taking these youth to DC area communications companies and spending time showing them something of the technologies underlying communications. The idea was to provide Martha's Table afterschool kids with an idea about a possible future career or a lifelong interest in communications. These initiatives are in addition to a number of other well established volunteer opportunities. The FCBA and the Foundation are a part of the community we live in and we contribute in many and varied ways through volunteer efforts. That's a message I hope we can all take to those who would otherwise not have heard of the association or who may harbor antiquated views of what the FCBA and its Foundation are and do.

## Online Membership Renewals

### TO RENEW ONLINE BY CREDIT CARD AND MAKE A CONTRIBUTION TO THE FOUNDATION:

The primary email and password used to sign in MUST be the same as have been used for online registrations in the past, by the individual who is being renewed. If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

**INVITING GOVERNMENT GUESTS**

Pursuant to the Office of Government Ethics regulation on widely-attended gatherings (5 C.F.R. 2635.204(g) (2)), the Chairman's Dinner appears to qualify as a widely attended gathering. The value of an individual ticket to the dinner is \$225.00. Most employees of the Federal Communications Commission and the Commerce Department may be directly invited to attend the dinner as guests of individuals and organizations purchasing tables or tickets. In most cases, individuals and organizations may issue invitations to the Chairman's Dinner without the involvement of the FCBA. Some agencies, departments and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics. Individuals who have signed the Administration's Ethics pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. While this event has qualified as a widely-attended-gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's Office of General Counsel. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State must be issued by the FCBA. Contact the FCBA for additional information.

## Spotlight on the Beneficiary: THC—Housing Families, Transforming Lives

One of this year's Charity Auction beneficiaries, THC, gives D.C. area families the tools and support they need to break out of poverty. Among its many programs, THC offers two affordable apartment complexes for low to moderate income and at-risk families that house a total of 114 units. In addition to helping the residents keep a roof over their heads, THC provides its residents with tools they need to thrive in a digital age. THC offers a variety of educational programs to the affordable housing residents, including computer literacy courses in the two buildings' computer

labs. The approximately four to six week courses are taught by volunteers and paid consultants.
