himself for a lifetime,” TFS believes that children succeed in school when they are provided support in math and reading, develop sound life skills, and when their parents are engaged. TFS supports over 400 students from DC’s most underserved communities in Wards 6, 7, and 8, and engages them in a multi-year program model designed to give them the academic and social tools to succeed in their academic and workplace careers. Last Chance To Renew Your Membership!

This is your last chance to renew your FCBA membership before you will be dropped on September 25. Once that happens, you will no longer receive discounts on events or notices about FCBA activities. Please note that you cannot change your membership type or your contact information online. If you need to make a membership type or contact information change, contact Megan Nazareth at megan@fcba.org BEFORE paying the invoice.

Every member must login to renew.

- Click the **Login** link at www.fcba.org or go to <https://netforum.avectra.com/eWeb/DynamicPage.aspx?Site=FCBA&WebCode=LoginRequired> to log into your account.
- If you do not know your password you must click on the “**Forgot your Password?**” link and follow the instructions to generate a new password. The system will then email you a link which you must activate to change the password. **Note that the link that is emailed to you is only good for two hours from the time you request it and that it can be only used once.** If more than two hours have passed or you already activated it you will have to go back and click on “**Forgot your Password?**” again.

TO RENEW ONLINE BY CREDIT CARD:

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click on the **Pay Open Orders** button at the top right of the **My Transactions** page.

Recently, some equipment vendors and wireless carriers have proposed using unlicensed bands to deploy Long Term Evolution (LTE)-related technologies traditionally used for mobile broadband

wide area networks. Some users of Wi-Fi have objected to these LTE-related technologies asserting that they could cause harmful interference to consumers who have come to rely on Wi-Fi. This panel will explore the technical details of these LTE technologies and how they may impact the policy and legal issues in this debate.

Topic: The February Open Internet Order launched a new process where companies can request an advisory opinion if they are unsure about whether specific conduct is allowed under the order, and the Enforcement Bureau will respond with advice about what factors the Commission will look at to evaluate compliance. As a nascent industry that continues to evolve, certain providers in the mobile payments ecosystem may want to understand whether certain practices are prohibited under the new rules. The advisory opinions are not legally binding but are intended to give companies clear guidance in making their business plans. But some have questioned the value of nonbinding advisory opinions and other guidance, which could give the Bureau a blueprint for enforcement action. Commissioner John Tuma was appointed to the commission effective February 2, 2015. He is a member of the National Association of Regulatory Utility Commissioners (NARUC) and serves on the NARUC Committee on Critical Infrastructure. On July 28, 2015, the Minnesota commission release an Order Finding Jurisdiction and Requiring Compliance Filing in response to a complaint filed by the Minnesota Department of Commerce finding that two companies holding certificates of authority for intrastate telephone service transferred all their residential customers to two other companies without Commission authorization or notice to the customers. In the order, the PUC found that the FCC has not preempted state regulation of the fixed, interconnected VoIP service provided. Commissioner Tuma will discuss the events leading to the order, the arguments presented, explain why the PUC ruled as it did, and then take a few questions.

Matt DelNero, Chief, FCC Wireline Competition Bureau

If you do not already know Matt DelNero, you may soon. He is the new chief of the FCC's Wireline Competition Bureau. Prior to joining the FCC as Deputy Bureau Chief in early 2014, Matt had worked his way up from being a first year associate to a partner in the Communications & Media and the Privacy & Data Security practices at Covington and Burling LLP. Along the way he also worked with the Public Broadcasting Service (PBS), both in-house and as one of the organization's lead outside counsel. At the FCC, Matt has had leading roles in the historic Open Internet rulemaking, the FCC's efforts around technology transitions, and consumer privacy. I was thrilled he had a little time on a Friday afternoon to speak with me about his current position and perspectives on life, a career in law and policy, and the FCBA.



Q: So, what attracted you to the field of communications?

A: Well, as a kid I was always interested in technology. When I was eight or nine, I took apart a telephone to see how it worked, but putting it back together didn't go so well. And like a good number of other Gen X'rs, I got my first real taste of life online when my father got us a 28K modem and a CompuServe account. I was fascinated by it and all the possibilities to interact with people around the world. But when I tried to become a real techie it just wouldn't stick the way it did for some of my (equally geeky but more skilled) friends. You can probably see a theme here: lots of interest in technology but not the makings of an engineer or computer scientist. Fortunately, I later found my way to law school and summer associate positions that introduced me to the field of communications law (first at Mintz Levin and then at Covington, both in DC). I learned a lot those summers from talented lawyers with a passion for technology and policy, and I knew I had found the right career for me at that point.

Q: Tell our readers whether you were deliberate in your career progression and how things unfolded.

A: While my decision to join Covington after graduating from law school and focus on communications was deliberate, looking back I didn't really have a set

plan as to how my career would progress from there. I was blessed with many mentors along the way (and still am) who told me, and showed by example, the importance of being open to unexpected opportunities.

Q: What's the most challenging part of your work and why?

A: I have been on the job as WCB Chief for about two months, so that is two months of having a wider-angle view on Bureau operations than I had previously. By far the biggest challenge is figuring out how to deploy the Bureau's limited resources – its dedicated civil servants – most effectively. There are so many issues before the Bureau and the FCC, and the Bureau's current complement of full-time employees is down from 180 people to about 160 just over the past three years. That's to be expected in a tight budget environment. But it's a relatively small group to manage and implement reforms in all of the FCC's universal service programs (approx. \$8.5 billion per year), gather and report on critical data about the state of broadband deployment, oversee major rulemaking proceedings like special access, technology transitions and consumer privacy, review transactions of all sizes – to name just a few things we're handling. This can be challenging, to cover everything that deserves our attention and to retain great people and provide as fulfilling a work

environment as possible. But I enjoy the position immensely – every day is different. And I was fortunate to succeed someone as talented and dedicated as Julie Veach, who always led by example with a spirit of collegiality, professionalism, and quiet strength. I try to live up to the high standards that she set in some three years as Chief and 14 years as a civil servant.

Q: What do you enjoy reading in your free time?

A: It changes depending on the day. I've always been interested in history, and on that front I really enjoy good used bookstores – there's something about out-of-print books and magazines that can tell a unique story about our past and about how perceptions of events change over time. For example, recently I picked up a paperback from 1943 that provided first-person accounts of how people were experiencing the war. It was a very different perspective than more recent books I've read about World War II.

Q: What surprised or impressed you most about the people you've worked with and why?

A: Well, as a young lawyer I did not realize that more senior lawyers (including so many in the FCBA) were so willing to mentor younger lawyers in both informal and formal ways; I had to find that out over time. That willingness is something that I think makes the FCBA a standout among bar associations. You never stop depending on mentors, and as I've progressed in my career I've found serving as a mentor to younger FCBA members to be incredibly rewarding too.

I also would say while I saw this before I joined the FCC, since I have been with the Bureau, I have been extremely impressed by the dedication, the deep institutional memory, and the commitment of colleagues at the FCC. I could name a number of them, but would not want to leave anyone out. Their generosity of spirit and good stewardship is what keeps the agency functioning. While

the “hot” issues change over time, people who dedicate their careers to the core mission of the institution can make an immense impact.

Q: Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: I think one mistake is to try to over-plan your career and find the one “right” way to succeed. It’s better in my view to be open to new ideas and challenges. Like many lawyers, I’m naturally risk averse so I’ve had to push outside of my comfort zone at times. For example, I was very happy in private practice at Covington – I worked with fabulous, supportive colleagues at the firm and loved the diversity of issues that we handled, like privacy and data security, telecom policy, and media transactions. So when the chance to join the FCC and focus (as Deputy Bureau Chief) on broadband policy came up, I didn’t immediately make up my mind. But as I thought about it and talked to people I

admire and trust, I realized that this was a unique opportunity to make a difference on issues that I care about and learn and grow in new ways. About 18 months in, the experience has far exceeded my expectations.

Q: What’s something interesting about you that people are not generally aware of you that are willing to share?

A: Well, I may be a first for this column in stating that I am married to a choral conductor. Our careers are pretty different, and his has involved more interesting travel. He recently went to Cuba in his role as assistant conductor of the Gay Men’s Chorus of Washington – the first chorus of its kind ever invited to the island. Internet access is very limited in Cuba so we weren’t able to keep in touch that week. That was probably the first time in 14 years we had gone so long without speaking. But then mid-week I saw his picture in the Washington Post, singing at a venue in Havana. It was pretty neat.

Q: How long have you been an FCBA member and what is the value of FCBA membership?

A: I have been a member of the FCBA since my second year as an associate at Covington. The more senior associates were involved in the association and they encouraged me to join. The FCBA has given me the opportunity to know a lot of different people outside of my law firm and the Commission both socially and professionally. Even as a Bureau Chief I find tremendous value in participation. For example, it was a real treat to co-host the Young Lawyers Committee annual bar trivial night earlier this summer with Natalie Roisman. I also have always really enjoyed the annual seminar. But there is something for everyone. I’m also grateful that there’s a government rate for annual dues!
