As you may know, May is Mental Health Awareness Month, a time to raise awareness of mental health issues and to help reduce the stigma of talking about them.

Mental health can be a particular challenge within the legal profession, and for many FCBA members and our loved ones, the challenge has been exacerbated in the past year by a global pandemic, continued systemic racism and racial violence, and the physical threats to federal institutions that are our workplaces, such as the U.S. Capitol. If this has been a hard year for you, you are not alone. The challenges of “re-entry” and a “new normal” post-vaccination are also weighing heavily on many of us.

The FCBA will hold a panel discussion about mental health on **Monday, May 17 from 12:00 – 1:00 p.m. ET** with counselors from the D.C. Bar Lawyer Assistance Program and several

## PRESIDENT'S Message

### TO THE FCBA COMMUNITY:

To some extent I've been dreading the month of May, because I really am not looking forward to the return of the Brood X cicadas in the Washington, D.C. area and throughout large swaths of the East Coast. (I'm sure some of you are delighted at the chance to experience these sights and sounds, but I have a bug phobia, and I could do without them.)



However, their impending arrival has caused me to think about the last time this brood appeared. In May 2004, I was just leaving my first stint in private practice to join the FCC, where Michael Powell was Chairman and Bryan Tramont, who would go on to be Managing Partner of my current firm and an FCBA President, was Chief of Staff. 17 years was a long time ago, especially in this era of rapidly evolving tech, business models, and regulatory policy! Where were you?

Fortunately, there are also many good things happening this month to outweigh the cicadas, and they take place with a frequency greater than every 17 years. As just one example, I'm looking forward to our very first virtual Annual Seminar, Thursday-Saturday, May 13-15, with partial-day sessions each day. As I shared on the *FCBA Unplugged* podcast, in the early months of the pandemic I experienced anxiety for the first time, and I am very thankful for my ability to access professional help. I hope together we can work to raise awareness

of mental health issues and reduce the stigma in experiencing and talking about them. Whether you have struggled or are struggling yourself, or you would like to learn how to better support family, friends, or colleagues who face mental health challenges, I encourage you to attend this webinar. The event will be followed later in the month by opportunities for voluntary small group discussions to address the issues raised by the panel and related topics.

Also in May, along with a number of compelling committee and chapter events, the FCBA will partner through the Young Lawyers and Diversity Committees with the Women's Bar Association of D.C. Career Development and Mentoring Committee on an event addressing how to make the most out of mentoring relationships. This will be a terrific event for young lawyers and law students, as well as more senior lawyers who often serve as mentors. Please encourage your colleagues to attend, including any students working as interns or summer associates in your organization this year. Mentors and mentees will learn how to set expectations and objectives for their relationship, track progress, and assist one another in career growth. The panel will discuss how to maintain a mentoring relationship while meeting remotely and how mentors can best support attorneys of color. Co-sponsoring this program with the WBA connects back to the FCBA's years of hosting a joint Mentoring Supper with that organization, and it is

I hope you will invite interested colleagues who may not be familiar with the FCBA, as this is a great opportunity for them to experience our robust content offerings. Thank you to Jonathan Cohen, Josh Turner, Dan Waggoner, and Stephanie Weiner for their thoughtful work in bringing this series to fruition.

The first is members of the FCBA in academia. ## Constitution and Bylaws Committee Proposed Changes

This winter the Constitution and Bylaws Committee (Yaron Dori, Diane Holland, Megan Anne Stull, and Josh Turner) reviewed the FCBA's Constitution and Bylaws to ensure that they accurately describe the FCBA's current practices and provide a solid foundation for the future.

On April 28, 2021, the Committee proposed to the Executive Committee several areas for clarification and improvement of these documents.

- The Executive Committee unanimously approved the proposed changes to the Bylaws, which are now in effect and posted to the FCBA's website.
- The Executive Committee also voted to recommend that the FCBA membership vote to accept the changes to the Constitution at its Annual Meeting in June 2021. The proposed changes to the Constitution would: (i) provide

the FCBA with greater flexibility in how it describes itself in marketing materials; (ii) clarify the FCBA's evolving focus on technology law and policy; (iii) update the description of the membership application process to more accurately reflect the role of the Executive Director in that process; (iv) update the description of the Assistant Secretary role to more accurately reflect current practices; (v) update the description of the Young Lawyers Committee representative to the Executive Committee to more accurately reflect current practices; and (vi) make other ministerial and conforming changes.

The proposed changes to the Constitution are available on the FCBA's website. FCBA members are invited to review the document and to raise any concerns about the proposed changes to FCBA President-Elect Megan Anne Stull at [stull@google.com](mailto:stull@google.com).
