

FCBA to Launch Summer 2022 Diversity Pipeline Program; Information Session Wednesday, September 22, 5:30 p.m. ET

Following a successful pilot in 2021, the FCBA is preparing to launch a second year of the Diversity Pipeline Program (DPP) for Summer 2022. We appreciate the feedback from our inaugural student and employer participants in 2021 that will help shape an even stronger program for the future! We welcome all FCBA members to get involved in supporting and promoting this important program.

As the premier association for attorneys and professionals involved in the development and practice of technology, media, and telecommunications (TMT) law and policy, the FCBA is uniquely suited to attract and develop law students from historically underrepresented groups for long, successful careers in this space. The FCBA believes it is imperative that the legal profession in general, and the tech bar in particular, reflect the full spectrum of talents, perspectives, and experiences represented in the broader population. And while FCBA members may have divergent views on many aspects of tech policy, we have universal agreement about our industry's significant influence and responsibility to promote meaningful diversity, inclusion, and equity.

The DPP is an internship and skills development initiative that leverages the scale of our association and the scope of our membership to engage 1L law students and support them with curriculum and mentoring as they develop their legal and policy careers. It is a competitive, rigorous program designed to introduce a greater number of diverse law students to the practice of TMT law, help them secure and succeed in internships that will lead to careers in the field, and increase diversity within the FCBA membership and, ultimately, leadership. First-year law students from any ABA-accredited law school may apply.

In the first year of the program, the DPP received 100 student applications from 28 law schools across the country, facilitated 19 paid internships with law firms, companies, trade associations, and non-profit organizations in the Washington, D.C. area, and held over 30 hours of substantive instructional sessions, taught by instructors who are FCBA member practitioners, for students pursuing the TMT Law & Policy Certificate.

This year we are ready to raise the bar. Will you join us?

LAST CHANCE TO RENEW YOUR MEMBERSHIP!

This is your last chance to renew your FCBA membership before you will be dropped on September 30! Once that happens, you will no longer receive discounts on events or notices about FCBA activities. Your current membership expired on June 30, 2020 and by renewing, your membership will be good through June 30, 2021.

Please note that all membership notifications and receipts are emailed to FCBA members only – we cannot send them to a member's assistant or secretary.

IF YOU NEED TO CHANGE YOUR MEMBER INFORMATION

For changes in membership type or contact information, contact Elizabeth Hagerty at elizabeth@fcba.org to go over the member type options <u>BEFORE</u> paying your invoice. You cannot change your membership type or your contact information online.

HOW TO RENEW

1. LOG IN

Every member must log in to renew. To log in to your account, **click here** or go to **www.fcba.org** and click the Log In button.

The FCBA staff is still working remotely. For this reason, we strongly encourage you to pay online by credit card. We are still accepting payment by check, but the processing of check payments may be delayed.

IF YOU FORGET YOUR PASSWORD

If you don't know your password, please click on the "Forgot your Password?" link and follow the instructions to generate a new password. The system will then email you a link which you must activate to change the password.

Note that the link emailed to you is only good for one hour from the time you request it and that it can be only used once.

2. MAKE YOUR PAYMENT

To renew online by CREDIT CARD

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click on the Pay Open Orders button on the right side of the screen.
- Check off the box next to the order/invoice you wish to pay, click Next and follow the instructions to process your payment.

To renew by CHECK

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click the View More link under the Invoice Details column on the right side, then when the page opens click on Print This Page on the upper right side to print out the order.
- You must include the printed order with your check and mail both to the address on the order.

To pay for a group of renewals at one time

Some firms and companies prefer to pay for a group of membership renewals at one time with one check. There are two methods to do this:

1. Each individual member must log in and print out his/ her own order and submit it for payment through their internal channels. The firm or company must then send us all of the invoices at one time, along with the check. OR

2. The firm or company must send us a list of renewing members, each person's membership category and the associated fee, along with the check.

If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

Get to Know an **FCBA MEMBER**

Jared Sher

August into September can be a tricky time to nab someone to take the time to do a column. I was fortunate that Jared Sher graciously agreed to be interviewed. Jared is Chief Counsel, Program Network Policy, and Deputy General Counsel at NCTA, but prior to that Jared spent time both at a law firm and in-house, which has provided him with a broader perspective than many of us about the many roles



and responsibilities one can have in the practice of communications law and the development of policy. At NCTA, Jared manages the association's relationships with its programmer members and he helps develop and advocate for policy positions that promote innovation for America's leading content companies. And during Jared's career he has seen the content business grow and evolve from a broadcast-centric model to a multiplatform, streaming ecosystem. That certainly keeps things fresh.

Q: What attracted you to the field of communications?

I studied journalism in college, and went to law school initially thinking I'd be a libel lawyer for newspapers. And then I realized that I didn't want to be a litigator, so I broadened my horizons and began to look at additional opportunities in the media field. That led me to a law firm opportunity representing broadcast and cable companies, as well as other companies regulated by the Federal government. It was a great way to meld my background and interest in journalism with a chance to practice law in the media industry.

Q: Have things unfolded in your career more or less the way you planned?

I'm not sure I ever really had a defined plan. I've always tried to just take things one step at a time and leave myself open to new opportunities. I started at a law firm (Skadden Arps) and learned a great deal from several amazing mentors, including Toni Bush and John Quale. And then I was lucky enough to get hired in-house by a company (then called News Corp; later 21st Century Fox) that had been one of my primary law firm clients. After helping 21st Century Fox close its transaction with Disney, I was fortunate enough to slide over to NCTA at the time that Jill Luckett retired. So my career has been more about adapting

to the path in front of me, rather than the result of any highly-specified plan.

What's the most interesting or challenging thing that you've done in your current position?

If I can be permitted to slightly change the question to "career" from "position" – I'd say the most interesting (and important!) thing I've done in my career has been to help a refugee obtain asylum in the United States (after he was tortured while advocating for democracy in an authoritarian country). I later was able to help him obtain a green card and, ultimately, U.S. citizenship as well. Helping this person escape a truly perilous situation and build a new life has been immensely rewarding, and it reinforced to me the extreme importance of pro bono work – even when outside the field of communications.

Is there something interesting or someone who surprised or impressed you during your career and why?

As noted above, I've been the beneficiary of some great mentors in my career. From John and Toni at Skadden to Ellen Agress at News Corp/ Fox to now Michael Powell at NCTA, I've been so lucky to learn from some of the lions of the communications bar. To say I've been impressed by these individuals, and others with whom I've had the pleasure to work, would be an understatement.

Q: What do you enjoy reading?

I read a lot of non-fiction. I'm currently enjoying An Ugly Truth: Inside Facebook's Battle for Domination. That said, I read a wonderful piece of fiction earlier this year: Beautiful Ruins by Jess Walter. A great story and a superblywritten book.

Can you share perspective on the pitfalls to avoid or other career advice for those who are just getting started in the communications field?

To keep with my theme from above, I guess I'd encourage people to remain flexible and open-minded. Especially for people just getting started, I think it's important not to be overly-rigid in thinking about what the "right" move is for your career. Be willing to listen to new ideas and opportunities; there's far more than one single path forward.

Based on the fact that I've worked at a law firm, in-house and now at an association, I would say looking back that the training and mentoring that someone gets starting out at a law firm is invaluable. As I progressed in my career though, I have really enjoyed the more direct and consistent contact I have with folks that operate and run media businesses. While that's not career advice per se, it's important to figure out over time what aspects of your work you most enjoy and that should help to inform your career next steps.

What is something interesting about you that people are not generally aware of that you're willing to share?

Well some people are well aware of it by now, but I'm a long-suffering New York Jets fan. Success has been fleeting for the Jets, and they've provided plenty of pain and anguish over the years. But hope springs eternal!

The General Counsel will advocate for and represent both the Society of Broadcast Engineers and the Ennes Educational Foundation Trust, both being District of Columbia non-profit entities.

In **MEMORIAM**

Alan Campbell (1940-2021)

Alan Charles Campbell, former President of the FCBA and Chairman of the FCBA Foundation, died August 16. He was 81.

Alan was born and raised in Washington, D.C. He attended

Gonzaga College High School, and then attended the University of Pennsylvania on an academic scholarship. He graduated from the Wharton School in 1962, and obtained his law degree from Georgetown University Law Center (attending night sessions while clerking for Federal Judges Spotswood William Robinson III and Judge George L Hart, Jr.).

In 1964, he began his law career as an associate and later as a partner at Dow, Lohnes and Albertson, PLLC. After 26 years, he left Dow Lohnes and helped form Irwin, Campbell and Tannenwald, PC where he remained until he joined Fletcher, Heald & Hildreth, PLLC in 2009. Alan retired in 2014 at the age of 74 and was honored by the Virginia State Bar Association for his 50 years as a practicing Virginia attorney.

Alan married his college sweetheart Elizabeth Powell Coulon in September 1962. They settled in Northern Virginia, and in 2004 he and Liz purchased their retirement home on the Northern Neck waterfront in Virginia. They moved there full time in July 2005. Alan remained there until September 2019 when he moved to Dayton, Ohio to be closer to family.

Alan was a life-long athlete. He played football and baseball at Gonzaga and Penn. He was an avid runner and completed the Marine Corps Marathon. Exercise remained a priority for Alan throughout his life. For many years he drove his car from Virginia to D.C., parked several miles from his office, and walked to and from the office for the exercise.

In retirement he joined the Westmoreland Players, a local community theater in



the Northern Neck. He acted in 20 plays, starring in the Odd Couple and other performances, while also contributing in many other ways. He also studied for and passed the Master Gardener program, hosted its annual seminars and volunteered for garden maintenance work at George Washington's boyhood home. And he and his golden

retriever friend, Callie, together walked miles each day.

Alan coached his children and others in soccer and basketball, and was active in his church.

Bob Beizer and Dick Zaragoza, former FCBA Presidents themselves, remembered Alan

fondly. Bob commented that Alan was as a very gifted lawyer, who "as Bar president

... was instrumental in transforming the Association and Foundation into the thriving organizations they are today. He will be remembered for his sound judgment, warmth and extraordinary capacity for friendship." Dick observed that Alan was an "outstanding communications attorney and a person of high integrity," adding that as President of the FCBA Alan was "a strong supporter of the FCBA Foundation and its important work." And Peter Tannenwald, who was Alan's law partner for 12 years, remembered him as "a great partner and friend."

Alan is survived by his wife, Elizabeth (Coulon), daughters Ellen (Dave) Kaminski, Laura Szczybor, and son Ken Campbell, as well as seven grandchildren.
