33rd Annual FCBA Charity Auction to be held on November 3

The FCBA Young Lawyers Committee and the FCBA Foundation will hold their 33rd Annual Charity Auction on **Thursday, November 3, 2022**, at the **National Press Club, 529 14th Street, NW, Washington, DC**, from approximately **6:30 – 10:00 p.m. ET**. Each program is helping to create an environment that promotes school readiness for underserved children

Renew your FCBA membership today to avoid interruption to your benefits

Now more than ever, it's crucial to stay connected. Your membership in FCBA brings you the content you need, the connections that matter, and the opportunity to pay it forward. Please renew today!

Current FCBA memberships expired on June 30, 2022 and by renewing now, your membership will be good through June 30, 2023. **The deadline for renewal was July 31, 2022.** You will no longer receive the benefits of membership, including reduced pricing for events.

Please note that all membership notifications and receipts are emailed to FCBA members only – we cannot send them to a member's assistant or secretary.

IF YOU NEED TO CHANGE YOUR MEMBER INFORMATION

For changes in membership type or contact information, contact Elizabeth Hagerty at elizabeth@fcba.org to go over the member type options **BEFORE** paying your invoice. You cannot change your membership type or your contact information online.

HOW TO RENEW

1. LOG IN

Every member must log in to renew. To log in to your account, [click here](#) or go to www.fcba.org and click the Log In button.

The FCBA staff is still working remotely. For this reason, **we strongly encourage you to pay online by credit card.** We are still accepting payment by check, but the processing of check payments may be delayed.

IF YOU FORGET YOUR PASSWORD

If you don't know your password, please click on the "Forgot your Password?" link and follow the instructions to generate a new password. The system will then email you a link which you must activate to change the password.

Note that the link emailed to you is only good for one hour from the time you request it and that it can be only used once.

2. MAKE YOUR PAYMENT

To renew online by CREDIT CARD

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click on the **Pay Open Orders** button on the right side of the screen.
- Check off the box next to the order/invoice you wish to pay, click Next and follow the instructions to process your payment.

To renew by CHECK

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click the **View More** link under the **Invoice Details** column on the right side, then when the page opens click on **Print This Page** on the upper right side to print out the order.
- You must include the printed order with your check and mail both to the address on the order.

To pay for a group of renewals at one time

Some firms and companies prefer to pay for a group of membership renewals at one time with one check. There are two methods to do this:

1. Each individual member must log in and print out his/her own order and submit it for payment through their internal channels. The firm or company must then send us all of the invoices at one time, along with the check.

OR

2. The firm or company must send us a list of renewing members, each person's membership category and the associated fee, along with the check.

If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

in our nation's capital. Get to Know an FCBA MEMBER

Jennifer Oberhausen recently started working for Microsoft as Senior Corporate Counsel on the telecom team. In that role she advises Microsoft product teams as they develop new products and navigate telecom policy and legal issues globally. I've known Jen since she was a first-year associate and she has consistently demonstrated her legal and policy acumen at law firms, at a major wireless trade association and now at Microsoft. It was wonderful to catch up and get a sense of what Jen has been up to lately.



Q: What attracted you to the field of communications?

A: Really, I was drawn to the people in the communications group in my first law firm, and then it turned out that the subject matter was a great fit, too. I've found that with technology developing so quickly, the presence of new legal and policy issues that need to be addressed is constant. That means that the work is never monotonous and it's possible to become an "expert" within your organization on new areas of law much earlier in your career than if you were practicing in a more static area. I also like that we constantly need to be learning – not just about what regulators and policymakers are doing, but also how new technologies work and how the business landscape is changing.

Q: Have things unfolded in your career more or less the way you planned?

A: Yes and no. First off, I have to say when I was younger, I wanted to be a veterinarian, but my animal allergies made that infeasible. If you are talking about my career as an attorney, if I'm being honest, I never had a concrete plan, but have tried to focus on developing a career that continues to be engaging and challenging, while also fitting together with my life outside of work, too.

After interning for my Mayor in college and the FTC and FCC during law school, I did always think I'd work in government early in my career, but that didn't materialize. So in that regard things have not worked out the way I planned.

But I have managed to develop a career path that I find interesting and engaging on a daily basis, and I'm very grateful for that.

Q: What's the most interesting or challenging thing that you've done in your current position or during your career thus far?

A: I just started working with the team at Microsoft, so everything is still new and challenging! On the substantive side, I'm working to build on everything I know from the past decade plus of experience mostly with domestic telecom law and policy and expanding that to a global scale.

If we talk about my experiences in other positions, I would say that it was fascinating and illuminating to be part of international delegations at the World Radio Conference and CITEL as critical spectrum issues were being debated. There's nothing else like it I've experienced.

Q: Is there something interesting or someone who surprised or impressed you during your career and why?

A: The thing that most caught me by surprise was how quickly you can grow your network within the FCBA and this field in general, without even realizing it. I still remember walking into FCBA events as a brand-new associate and not knowing a single person in the room. It didn't take long before I had made a few

good friends, and then suddenly I would walk into an event and know almost everyone in the room. Now, those same friends I made as a very junior attorney have gone on to serve FCC Chairs and Commissioners, make partner in their law firms, and have risen in the ranks of their in-house counsel roles – seemingly all in the blink of an eye.

Q: What do you enjoy reading?

A: I'm a news junkie. It's a bad habit, but most days I peruse the New York Times, Washington Post, and LA Times before I even get out of bed. I also have an ever-growing pile of novels that I'm planning to read, but I never seem to make much progress on those now that I have an endless supply of news at my fingertips at all times.

Q: Can you share perspective on the pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: For a lot of people, I think the best advice is not to be too hard on yourself. No one will expect you to know everything or know how to do everything perfectly, so just do your best with what you do know how to do and be honest when you're stuck or have questions. If that happens, reach out and ask for guidance. That will save you a lot of stress and time, and you'll pick things up before you know it.

Q: What's something interesting about you people are not generally aware of that you're willing to share?

A: For the past three years or so, I've been a little bit less involved with the FCBA as I've been working with my alma mater, the University of Notre Dame, to launch the Alumni Association's first affinity group for LGBTQ+ alums – ARC ND. As you might imagine, it's a lot of work to build something from the ground up, so that's been taking up a lot of my free time.

Q: How has your life changed as a result of COVID-19?

A: Before COVID, I lived in the city in DC, I rode my bike or took the bus to work every day, and I hadn't owned a car in more than ten years. Well, none of that really worked anymore during a pandemic. I bought a car in May 2020 – mostly over the phone and via email – and ended up gradually moving out of DC. First, I was just visiting family in Indiana for a couple of weeks, then I

decided to stay a little longer, because like everyone else, working remotely became the new norm. After realizing that, I left DC for good in October of 2020. Now I live in California and will be traveling up to Redmond every couple of months. So, pretty much everything has changed!

2021-2022 FCBA Foundation Annual Report

This Annual Report summarizes the activities of the Federal Communications Bar Association (FCBA) Foundation during the recently completed 2021-2022 fiscal year.

OVERVIEW

The FCBA Foundation, celebrating 31 years, is a charitable organization working in furtherance of the goals set out in its Mission Statement:

1. To support worthwhile communications-related and educational projects, as well as other community service projects, particularly those directed towards children and students, through financial contributions and through volunteer services provided by Foundation members and others.
2. To foster greater public awareness and understanding of the development of communications technology, resources, and law.

This year, the Foundation continued its longstanding support of the following programs:

- Granting four-year college scholarships to Washington, DC high school students expressing an interest in communications-related fields of education, including engineering, technology, law, economics, and journalism;
- Granting one-year scholarships to current law school students who demonstrate an interest in communications law, technology, and public service;
- Granting summer work stipends to law school students serving as interns in communications-related public service jobs.

The Foundation's success is a direct result of the generous financial support of individual FCBA members and their employers, the Foundation Board of Trustees' time and dedication, the FCBA staff's commitment and contributions, as well as the time, talents, and energy that FCBA members bring to the Foundation's activities.

GOVERNANCE

The Foundation is governed by a Board of Trustees, comprised of individuals elected by the FCBA membership to three-year terms.

This year's Trustees were: **Anisa Latif Green (Co-Chair)**, **Erin Griffith (Co-Chair)**, **Michael Saperstein (Treasurer)**, **Rachel Wolkowitz (Deputy Treasurer)**, **Rizwan Chowdhry (Secretary)**, **Meagan (Sunn) Bolton (Deputy Secretary)**, **Avonne Bell**, **Delara Derakhshani**, **Maureen Ohlhausen**, **Roger Sherman**, **Edward "Smitty" Smith**, and **Brenda Villanueva**. **Natalie Roisman** served as the FCBA Executive Committee's liaison to the Foundation Board of Trustees.

As of June 30, 2022, four Trustees completed their three-year terms on the Foundation Board: **Delara Derakhshani**, **Maureen Ohlhausen**, **Roger Sherman**, and **Edward "Smitty" Smith**. Four new members have been elected to serve three-year terms as Trustees, effective July 1, 2022: **Angela Y. Ball**, **David Grossman**, **Karen R. Sprung**, and **Dr. Nicol Turner Lee**.

Many of the Foundation's activities, including the scholarship and internships programs, community service activities, and critical fundraising events, were jointly led by Trustees and member volunteers. The Board of Trustees is grateful for the broad participation of FCBA members in Foundation programs, and especially for the leadership roles assumed by members beyond the elected board. That extra measure of time and dedication was essential to the success of our programs.

The FCBA's Executive Director **Kerry Loughney**, Senior Manager of Programs **Janeen Wynn**, Bookkeeper **Wendy Parish**, and Member Services Administrator **Elizabeth Hagerty** also provided invaluable support to the Foundation.

COLLEGE SCHOLARSHIP PROGRAM

Under the leadership of the Foundation's college scholarship committee, **Rizwan Chowdhry**, **Delara Derakhshani**, **Erin Griffith**, and **Roger Sherman**, the Foundation reviewed applications from high school students of diverse backgrounds with an interest in communications-related fields, including media, journalism, technology, engineering, or law. Thirty-six high school student applicants were interviewed and 28 of these were chosen to receive FCBA Foundation scholarship assistance funded over four years. Our scholarship recipients this year came from 14 local public high schools: Bell Multicultural, Benjamin Banneker, Capital City, Cardozo Education Campus, District of Columbia International, Duke Ellington, Dunbar, Eastern, E.L. Haynes, Jackson-Reed, McKinley Technology, School Without Walls, Thurgood Marshall Academy, and Washington Latin. All 36 of the applicants who attended interviews will be provided new laptop computers.

INTERNSHIP STIPEND PROGRAM

Under the leadership of the Foundation's internship committee, **Avonne Bell, Edward "Smitty" Smith, Meagan Sunn, and Brenda Villanueva**, the Foundation reviewed applications from students at law schools across the country. The Foundation awarded stipends ranging from \$200 to \$7,000 to 21 students who have accepted public service positions for the summer.

LAW SCHOOL SCHOLARSHIP PROGRAM

The Foundation's law school scholarship committee, **Avonne Bell, Anisa Latif Green, and Maureen Ohlhausen** led the efforts to review applications from current students at law schools across the country who demonstrated merit and need, as well as an interest in communications law and technology and public service. We received applications from students at schools across the country and awarded five \$5,000 scholarships.

2021 FCBA FOUNDATION CHARITY AUCTION

The FCBA Foundation Charity Auction is the largest single event under the auspices of the Foundation, and the most administratively intense. The sheer number of volunteers committed annually to the charity auction is a testament to the volunteer spirit of the FCBA. Moreover, it is a reflection of the generosity of our members, who attend year after year to help support the Charity Auction's beneficiaries. This year's auction was held virtually on November 10, 2021. Co-sponsored by the Foundation and the **FCBA Charity Auction Committee**, the auction raised over \$100,000 for the beneficiaries – **Rosie Riveters** and the **FCBA Foundation**.

Rosie Riveters works to engage and inspire preschool to middle-school girls in STEM and equip them with an enduring growth mindset. Their hands-on and interactive programs provide girls from diverse backgrounds with a fun space to imagine, learn, and play. While programs focus on the joy of STEM, they also emphasize productive struggle to build participants' critical thinking and overall confidence in themselves. Since its founding in 2015, Rosie Riveters has become one of the leading providers of early-education STEM services for young women in the DC-metro area, serving more than 3,000 young women to date. Funds raised through the FCBA Charity Auction will support Rosie Riveters' newest program,

Rosie Innovators, which extends its reach through high school. The program will enable Rosie Riveters to continue to build upon the trust and long-term relationships it has established with young women and their families, creating the organization's very own, highly effective STEM pipeline that runs from preschool to college.

The FCBA Foundation will use proceeds from the Charity Auction to support its annual college scholarship program. The FCBA Foundation applied \$20,000 of this year's Charity Auction funds to a college scholarship named for The Young Lawyers Committee and Charity Auction.
