The ubiquity of internet-enabled communications has profoundly altered the world's economic, social, and information ecosystems and changed the way we live our daily lives. It's one of the great transformations in human history. A central, persistent societal question is what form of governance will best serve the interests of an ever-evolving society dependent on innovations in digital technology.

This program will begin with a Fireside Chat between FCBA President **Megan Anne Stull** and **Vinton Cerf**, Vice President and Chief Internet Evangelist for Google and a 2005 recipient of the Presidential Medal of Freedom, the highest civilian honor bestowed in the U.S. Vint is an American Internet pioneer who is recognized (along with co-developer Bob Kahn) as one of "the Fathers of the Internet." He has also received numerous honorary degrees and awards, including the National Medal of Technology, the Turing Award, the Marconi Prize, and membership in the National Academy of Engineering.

After hearing from Vint, expert panels will discuss how the digital world has transformed the information ecosystem and examine whether and how policy approaches and regulatory models should adapt or evolve to meet new and novel challenges. Panelists will include former FCC Chairman **Tom Wheeler** (Brookings Institution Visiting Fellow and author of *From Gutenberg to Google: The History of Our Future*), Florida State University Law Professor **Lauren Scholz**, NTIA Director of Communications Policy Initiatives **Russ Hanser**, Professor **Mark Jamison** (Director of the University of Florida's Public Utility Research Center and Digital Markets Initiative), and Commissioner **Karen Charles Peterson** of the Massachusetts Department of Telecommunications and Cable (and Chair of NARUC's Committee on Telecommunications). ## Get to Know an FCBA MEMBER

### Davina Sashkin

Davina Sashkin is coming to you live from Austin, Texas. Davina practiced communications law in DC for some time prior to becoming Counsel at Baker Hostetler LLP, where her practice focuses on broadcast regulation, compliance and transactions, with forays into wireline and cable matters from time to time. While she is based out of Baker's DC office, she lives and works in Texas. She likes to say she made the leap to 100% remote work before it was cool. In 2019, her husband had the opportunity to become general counsel of a Texas company. The family moved out west and they have not looked back, although Davina admits she misses seeing snow. It was probably a draw for Davina that she grew up in Austin, although she says much has changed as the area has grown with so many new businesses over the last 20 years. What has not changed is an outdoorsy, laid back vibe to life in general in Texas' state capital. I caught up with Davina as we were comparing notes over our respective Thanksgiving plans.



**Q: What attracted you to the field of communications?**

**A:** When I was studying for my master's degree in Communication, Culture & Technology at Georgetown University in the early aughts, it quickly became clear that I was drawn to the policy and legal aspects of communications and technology, rather than following the business path I originally intended. Kathleen Wallman, a former FCC Bureau Chief and White House adviser, was one of my professors and a mentor, and she pointed me to the communications law program at Catholic University. So that was that.

**Q: Have things unfolded in your career more or less the way you planned?**

**A:** Not at all! I never expected to be working at a big law firm, nor did I expect to focus on broadcast media as the bulk of my practice. After a stint at a small law firm right out of law school, I thought I would end up the FCC or at a trade association at this point in my career. However, the market and the vagaries of life have a way of paving your path in different ways than you expect. I look back and consider whether I should have taken some of the opportunities that came my way that seemed at the moment they

were presented to be bad timing; on the other hand I am happy with where I am and what I am doing now.

**Q: What's the most interesting or challenging thing that you've done in your current position?**

**A:** I suppose changing law firms in the middle of a pandemic, without having met anyone there in person and being 100% remote, would qualify as challenging. I joined Baker in March of this year, having only interviewed and communicated with the managing partner and colleagues by Zoom and email. In fact, I didn't meet anyone from Baker in person until September! It could have been a rocky road, but I think Baker has adapted to the COVID environment extremely well. It has been a smoother transition than I expected.

**Q: What do you enjoy reading?**

**A:** Does Twitter count? Seriously, I don't have a ton of time to dedicate to books, as can be seen by the pile on my end table that has barely budged this year! I do enjoy good, in-depth journalism, so much of my reading is of magazines like Texas Monthly and The Atlantic, The Texas Tribune. I still get the paper New York Times delivered to me every Sunday.

**Q: Can you share perspective on the pitfalls to avoid or other career advice for those who are just getting started in the communications field?**

**A:** When I look back at my career, I can think of a couple of times where I turned down a job or other opportunities for good and valid reasons at the time that might have put me on a different path. While you shouldn't reach for a role that might be absolutely crazy or that will bring you financial ruin, I would say don't be afraid to take a chance, try something new if it speaks to you even if there is a bit of risk involved. But always maintain a good relationship with the people and places you leave behind. You just never know when you might need a reference or even be working with those same people, law firms or companies at another point in the future.

**Q: How has your life changed as a result of COVID-19?**

**A:** Compared with many others, my life has not changed all that much in the COVID era – except for the period when my son was doing remote schooling! Since I transitioned to 100% remote work a year before everyone else when I moved to Austin, I was already adjusted to working from home when the pandemic hit. It definitely helped that I bought my current house with the need to work from home in mind, which was something many others just had thrust upon them. In some ways, the pandemic has actually been a good thing in that it has paved the way for working remotely like I do – now it seems less anomalous and more routine to clients as well as to colleagues.

**Q: How long have you been an FCBA member and what to you is the value of FCBA membership?**

**A:** I have been a member of the FCBA since my first year of law school, so nearly 20 years now! The FCBA has been incredibly valuable to me. I've made so many friends through it and established

an entire network of contacts to whom I can go if I have a question about some area of the law outside of my normal practice.

It's also been a source of referral work, and I likewise have been able to refer clients to other members of the bar.
