31st Annual FCBA Charity Auction: Spotlight on This Year's Beneficiaries

The FCBA Young Lawyers Committee and the FCBA Foundation will hold their 31st Annual Charity Auction on **Tuesday**, **November 10**, **2020**. The virtual gala starts at 5:30PM (ET) with a pre-show starting at 5PM. This year, the online auction will be open for bidding **November 6-12**, **2020**. Proceeds from this year's Charity Auction will benefit two great, local charities – the **FCBA Foundation** and **Reach Incorporated**.

The FCBA Foundation supports the Foundation College Scholarship Program, Law School Summer Stipend Program, and Law School Scholarship Program. The Foundation will use proceeds from the Charity Auction to support its annual College Scholarship Program which provides financial assistance and laptop computers to DC public high school students to assist them in attending college. In 2020, the Foundation committed \$280,000 to 26 high school students via scholarships ranging between \$8,000 and \$20,000. The graduating seniors were selected based on their academic achievements and service to



school and community. Also, the Foundation awarded stipends ranging from \$1,000 to \$7,000 to 26 students who had accepted public service positions for the summer. In addition, the Foundation received applications from students at schools across the country and awarded six scholarships to law students ranging from \$6,000 to \$8,600.

Reach recruits and trains DC high school students to become reading tutors and role models for elementary school students, resulting in improved literacy outcomes for both groups.

Suling Miller, Deputy Director for Development of Reach, explains that 80 percent of DC

During the twenty-teens, numerous jurisdictions expanded the obligations faced by companies that collect personal information, particularly in their duty to provide consumers, or data subjects, greater control. The executive branch, lawmakers. and regulators have recently placed a renewed focus on the responsibility that platform providers have for both their own privacy practices and also for the activities of their users. In late 2019, the Federal Trade Commission conducted a workshop to explore whether an update to the Children's Online Privacy Protection Act (COPPA) Rule was needed in light of the increased use of IoT, social media, ed tech, and general audience platforms hosting third-party directed content. This summer the Trump Administration issued a pair of executive orders concerning the popular TikTok app, citing national security concerns and the massive amounts of user data collected by the Chinese-owned app. Meanwhile, an amended version of the Earn It bill is moving through the Senate which, if enacted, would empower states to prosecute platforms and authorize private lawsuits against platforms who fail to comply with state requirements, which could weaken the ability of platforms to provide users with privacy-protecting end-toend encryption. Panel II will discuss and debate the current and future states of platform providers' evolving responsibilities and risks.

public school students reach 9th grade reading below their grade level. Reach removes the stigma of learning by turning struggling teen readers into tutors and role models. Reach teens practice fundamental literacy skills by reading children's books to elementary school students.

Teenagers with Reach typically improve two grade levels for every year that they participate. The younger participants typically improve one-and-a-half grades per year, meaning that they may not need intervention by the time they reach 9th grade.

Ms. Miller explains that the fundamental principle that guides Reach is: "we don't give up on teens."

Reach started 11 years ago with one site and 40 participants and has grown to serve over 500 participants per year. In addition to its After-School Tutoring Program, Reach has a College Mentorship Program and a Summer Leadership Academy and supports a Teen-Authored Books program, which, Ms. Miller explains, publishes children's books authored by teens that feature diverse narratives. The funds raised from this year's Charity Auction will help Reach support these programs and fuel

Get to Know an FCBA MEMBER

Renee Gregory

I've known Renee Gregory for a number of years as she has navigated the path between public and private sector roles in communications law and policy. She's always been a delight to encounter. Renee recently started a new job as Senior Regulatory Affairs Advisor within Google's Government Affairs and Public Policy group, and while socially distant, we were able to spend a little time together comparing notes



about what we were doing to stay sane in COVID times. It was great as well as to find out a bit about her new role at Google and her perspective on moving through a career.

What attracted you to the field of communications?

I love the combination of law, policy, and technology. You can't ignore any one of those aspects at the expense of the others. I particularly enjoy working with engineers. I sometimes joke that I love engineers so much that I married one! I also really enjoy the fact that communications law and policy touches nearly everyone nearly every day. It's not an abstract concept, and it really matters to people. That also means that the hard challenges like closing the digital divide are worth spending the time and effort to try to solve them.

As to what attracted me to communications in the first place, it's admittedly not what I dreamed of growing up! But as a young adult and early in my career, pursuing the characteristics I just described led me to focus on communications.

I got the DC policy bug in college when I interned on Capitol Hill one summer longer ago than I'd like to admit. After graduation, I set my sights on DC, even though I wasn't able to land a policy-related job at first. Instead, I spent about a year at a consulting firm, getting a crash course in business. I then took an entry level policy job with a small trade association representing federal contractors, and got a fantastic introduction to regulatory and Congressional advocacy. That job served as a springboard for my work at a couple of law firms, where I worked closely with a senior Partner representing federal contractors on the Hill and with federal agencies, particularly the Department of Defense. My clients included a tactical handheld radio company, which introduced me to the wonderful world of wireless communications!

During that time I also attended law school at night. After graduation, I was determined to practice "real law," and was able to work with clients from a range of regulated industries, including aviation, medical devices, subjects of environmental regulations, and of course communications. When it became clear that I wouldn't be able to specialize in what I enjoyed the most - communications - I went looking for a firm where I could do just that. I was incredibly fortunate to find and join Wiltshire & Grannis, as it was known at the time. There, I learned from the best: people like John Nakahata, Chris Wright, Paul Margie, Tricia Paoletta, Kent Bressie, Brita Strandberg, and others. I loved my time there, but also made no secret of my desire to serve in the government someday. To their great credit, my colleagues fully supported that, and helped me land a job at the FCC, working as Chairman Genachowski's Wireless Legal Advisor.

I spent a wonderful three and a half years at the FCC, working for Chairman Genachowski, as Chief of Staff to Julie Knapp in OET, and then for Chairman Wheeler. From there I transitioned to the White House Office of Science and Technology Policy for the final year or so of the Obama Administration, still focused on spectrum and the digital divide, but also becoming more involved in hot issues in tech policy. Every day of my five years of government service, I felt an immense

privilege to be walking through my office doors, and to be doing important work for the American people.

From there I spent a few more years practicing communications law at a firm, but I couldn't pass up the opportunity to try something very new at Google, which I joined earlier this year.

Have things unfolded in your career more or less the way you planned?

Definitely not! Looking back, my career path seems very logical and intentional, but I don't think you can plan every detail of a career; in fact, doing so could actually be counterproductive to your professional and personal life. Careers, and life in general, naturally evolve through time, often in unpredictable ways. Throughout my professional journey, I've tried to be open to opportunities that are aligned with my interests, skills, and long-term, high-level goals, and that has led me to some fantastic roles.

What is one of the most interesting and challenging things you've done in your current position?

For the first time in more than a decade I'm not focusing the majority of my time on communications law and policy. (Am I allowed to say that in an FCBA publication?) At Google, I'm getting the opportunity to learn a lot more about policy issues like AI, content regulation, data governance, competition, etc., while also navigating a strategy role at a huge company in my very first inhouse position. That's all been incredibly interesting and challenging at the same time.

Is there someone who surprised or impressed you during your career and why?

There are too many impressive people to list! At the risk of leaving out names, getting to know and work closely with legends of the FCC like Tom

Wheeler, Phil Verveer, Ruth Milkman, Roger Sherman, Gary Epstein, Howard Symons, and Julie Knapp has been a highlight of my career. Every single one of them is not only incredibly accomplished professionally, but also a wonderful human being. That tends to be true of the Communications Bar in general, which may be surprising to outsiders who don't necessarily have a positive view of attorneys.

O: What do you enjoy reading?

First, always do quality work, regardless of your role. Second, always be kind and respectful to everyone you encounter. Third, consistently try to form long-term professional relationships with people at all stages of their career, not just those who are further along than you, and nurture those relationships over time. Finally, find mentors and sponsors, and be open and honest with them about how you want your career to develop (but see answer 2 too!) All of those pieces of advice have served me well over the years.

What is something interesting about you that people are not generally aware of that you are willing to share?

Even before COVID, I was a bread-baker and yogurt-maker. Cooking and baking has always been a creative outlet for me, and I've been experimenting with Indian food lately, in addition to perfecting my bread, pie crust, corn bread, and biscuit recipes. With the cooler weather on the way, I'm looking forward to making lots of soups and stews.

Any other new COVID habits to report?

I've been exercising more: a silver lining that I really appreciate! I used to be a 5-mornings-a-week gym rat before I had children, and it's been great to have time again to become a bit more physically active.

How long have you been an FCBA member and what to you is the value of FCBA membership?

I can't recall exactly when I joined the FCBA, but I've probably been a member for about a dozen years. I really appreciate FCBA's wide variety of opportunities for involvement, and it's a great way to meet and get to know others who are active in the field. I was particularly impressed by the inaugural FCBA Women's Summit that was held this January, which seems like a lifetime ago at this point. That event illustrates how the FCBA is able to adapt and stay fresh to maintain currency, while always providing great educational and other opportunities for its members. And we're seeing FCBA's flexibility again now, as we all adjust to our new COVID reality.

CLASS IS IN SESSION

Q&A with Howard University School of Law Adjunct Professor Vickie Robinson

The FCBA is fortunate to have numerous members in teaching positions at law schools around the country, many of whom helped organize, teach, and mentor as part of the FCBA's 2020 Summer Series for Students and are involved in other FCBA leadership positions and initiatives. There is no better way to engage the next generation of law

students and young lawyers in this field than being in the (real or virtual) classroom! This is the first in a series of interviews with FCBA members working full or part-time in academia.

When Vickie Robinson sees a problem, she wants to help solve it. Whether she's leading the Microsoft Airband Initiative to address America's rural broadband gap, working to end police brutality through her efforts with the Blue & Black Partnership, or promoting diversity in the legal workforce by founding Howard University School of Law's Annual Microsoft Tech Law Summit, Vickie works to generate positive reforms where and when they are needed.

Vickie has strong ties to Howard. Originally from Milwaukee, Vickie first attended Howard as an undergraduate, majoring in political science, before going on to Howard Law (where she met her husband Paul) and graduating Magna Cum Laude. Vickie remains actively engaged with Howard's alumni association. So, when she realized her alma mater lacked a course in tech law, she took action. In the summer of 2019, Vickie and her colleague Daphne Forbes approached Howard University School of Law about teaching a seminar, with the ultimate goal of strengthening diversity and inclusion of lawyers in the tech sector. After receiving enthusiastic approval from the school, Vickie and Daphne developed a comprehensive program to provide Howard Law students with a real-world understanding of how technology and the law intersect.

The result, Technology and the Law, is a weekly, three-credit, evening course aimed at 2L and 3L students. To shape the course, Vickie, a widely regarded subject matter expert, relied on her previous leadership positions at the FCC and the Universal Service Administrative Company, as well as her current role heading the Microsoft Airband Initiative, to cultivate a robust tech law curriculum. Howard offered Technology and the Law for the first time during the Spring 2020 term. Limited to 20 students to enhance the experience and encourage engagement, the course used a newly released text, *Tools and Weapons: The Promise and the Peril of the Digital Age*, written by two senior Microsoft executives. Students were graded on a paper, in-depth

presentation, and class participation. Of course, the pandemic made face-to-face instruction impossible, and on March 11, 2020, Howard transitioned to University-wide remote classes. According to Vickie, pivoting her teaching plans to accommodate the new online learning environment proved to be the most difficult part of the semester. Vickie rose to the challenge and, even with the last-minute reconfigurations, Technology and the Law's inaugural semester was a resounding success. The class will be offered again in Spring 2021.

By establishing Technology and the Law at Howard University School of Law, Vickie and Daphne hope to help increase diversity and foster inclusion in the tech sector. With Technology and the Law, Vickie can address the challenges of strengthening diversity and inclusion head-on while teaching a subject about which she is passionate. Vickie hopes others will also look at what they can do to become involved in diversifying the field. And she notes that teaching is not a one-way street, as she has learned quite a bit from her students.
