The U.S. Senate passed the nearly \$1 trillion Infrastructure Investment and Jobs Act (H.R. 3684) August 10, 2021. If passed by the House of Representatives, the legislation would invest hundreds of billions of dollars in transportation, water, energy, and an unprecedented \$65 billion for broadband infrastructure. Will the broadband spending help the U.S. finally overcome the barriers to equitable distribution of broadband services? What entities are eligible to receive funding? Who will distribute it and how? Does the legislation adequately address the inequities in affordability and access that disproportionately affect communities of color. lower-income

areas, and rural areas? Our panel will review how different congressional offices influenced the legislation, what compromises were made to come this far, and explain how the bill promises to shape the future of broadband deployment in the United States.

Without up-to-date broadband maps, newly allocated infrastructure funds may go to areas that do not need them. The FCC's \$20 billion Rural Digital Opportunity Fund, for example, sought to award subsidies to "unserved" locations, but the initial site locations turned out to include the MIT campus in Cambridge; Chicago's Inner Loop business district: and the Dallas Fort Worth International Airport. Why exactly has drawing reliable broadband maps proven so difficult for so many different government agencies? Is the challenge one of data collection or calculation or presentation? How does mapping resolution affect the likelihood of error? Our panel will explore how Congress, which has already allocated \$65 million to the FCC to create broadband maps, can get broadband mapping done "right."

The FCBA Privacy and Data Security Committee and the American Bar Association's Forum on Communications Law will hold the 16th Annual Privacy & Data Security Symposium on Tuesday, November 16 from 2:00 – 6:00 p.m. ET. This program will be held virtually via the Zoom platform.

A comprehensive, omnibus privacy law has long been on the table in Congress, but it never seems to make it to the House or Senate floor. While such legislation progresses in fits and starts, other government bodies have been flexing their authority to regulate the privacy practices of U.S. businesses. In the past few years, several states have passed omnibus privacy legislation or laws targeted to address specific privacy issues, and more are expected. At the federal level, the Federal Trade Commission (FTC) has given increasing signals that it will take a more aggressive stance against consumer privacy harms. Beyond the U.S.'s borders, other

countries have started to follow the lead of the European Union in adopting comprehensive privacy laws.

These actions sometimes overlap, but often diverge, leaving businesses and the legal professionals that serve them—reeling as they attempt to keep up. This event will take a deeper dive into this evolving landscape, examining the latest developments in the states, at the FTC, and abroad and exploring how U.S. companies can implement policies and procedures that meet the expanding expectations of the these varying regimes in the dynamic data ecosystem.

Without a comprehensive privacy law at the federal level, states have continued to consider and adopt laws to regulate privacy. In 2018, California

was the first state to adopt omnibus legislation: the California Consumer Privacy Act (CCPA). This was followed by the California Privacy Rights Act of 2020 (CPRA), approved by California voters that year. In 2021, Virginia and Colorado followed suit by enacting their own omnibus privacy laws, which will go into effect in 2023. In addition to these omnibus frameworks, targeted state privacy laws are affecting how companies do business, including laws that govern biometrics, online privacy, and ISP privacy. State Attorneys General have been active implementing and enforcing their privacy laws, as well as unfair and deceptive acts and practices that affect consumer privacy. As national companies contend with the growing patchwork of state privacy frameworks, this panel will discuss the various laws, rulemaking activity, enforcement trends, and legislative proposals that should inform an organization's compliance strategies and planning.

#### 3:40 – 4:45 p.m. SESSION II: HOW THE FTC IS FILLING THE FEDERAL PRIVACY LAW VOID

In the absence of an omnibus federal privacy law, the FTC remains the leading arbiter of how companies must protect the privacy of consumers across the U.S. With its new and incoming leadership, the agency seems poised to significantly expand its efforts, which could have substantial implications for businesses. In March, the agency launched a new team to handle rulemakings, and the commissioners voted to streamline the FTC's rulemaking procedures in July, which together are expected to smooth the way for comprehensive FTC privacy rules. Agency leadership has also signaled that it will use its existing authority to enforce against

unfair and deceptive acts and practices that harm consumer privacy before new rules are adopted. Additionally, the FTC is expected to continue its robust enforcement of the Children's Online Privacy Protection Act (COPPA) and its COPPA rules, which the agency may soon update. This panel will explore these developments and what they mean for businesses and consumers.

#### 4:50 - 6:00 p.m. SESSION III: GOING GLOBAL—INTERNATIONAL DATA PROTECTION IN A CONNECTED WORLD

International data privacy never rests. International developments have started shaping the daily operations of U.S. businesses. These data protection regimes leave companies mapping and assessing their data collection, use, and retention strategies. Organizations conduct deep-dives to determine whether they can engage in crossborder data transfers. Enforcement actions highlight each jurisdiction's strategy along with the breadth of potential extraterritorial application. Meanwhile, international laws and regulations are in a constant state of flux even as the U.S. carries on without comprehensive privacy legislation. In August 2020, China passed its first omnibus data protection law, the Personal Information Protection Law (PIPL). One month later, Quebec acted to modernize the protections of personal information with the digital age in mind. At the same time, organizations will have until December 2022 to migrate to the new European Union Standard Contractual Clauses. This panel will discuss the various laws and regulations impacting international data protection and how they impact decisions by American businesses, including cross-border data transfers, in the absence of U.S. federal privacy legislation or meaningful changes to how the U.S. government can access data.

### Florida Chapter Program on September 13

The Florida Chapter spearheaded a program on broadband initiatives in the new Infrastructure Act. Will Cox, Ron Brisé, and Cindy Miller, as Florida cochairs, developed the program and were pleased to see almost 50 people viewed it nationally. Ron Brisé of the Gunster firm moderated the program.

Kathryn Dewitt of the Pew Research Center provided an excellent description of the broadband provisions in the Act. She said the provisions offer \$42.5 billion administered by the states and the states will have a lot of flexibility. There will be \$1 billion for middle mile deployment and \$2.75 billion for digital equity grants. States will analyze where the monies are needed, such as in tribal areas. There will be \$4.2 billion for affordability. The scope of the digital divide has become much more vivid during Covid.

Dr. Sandra Oh of the Technical Policy Institute discussed the mapping project to identify unserved and underserved broadband areas. Their sophisticated approach overlays data from the FCC and poverty statistics and more onto their map. It is available to the public.

Dr. Mark Jamison of the University of Florida Public Utility Research Center described problems in the past on the universal service programs. He offered tips: (1) decide the targeted areas; (2) write good contracts for what we expect to be delivered and how to share risks; (3) accountability.

Jay Schwarz, Vice President for Public Policy at Comcast, described the difficulty in increasing the adoption rate of broadband for low-income households.

The Florida chapter is pleased to see that FCBA – The Tech Bar, offers new opportunities for the chapters to participate more strongly nationwide. We appreciated the collaboration with the University of Florida Public Utility Research Center and Digital Markets Initiative and look forward to future collaboration.

Program. Rosie Riveters is a Northern Virginia based nonprofit working to close the gender gap in STEM. Rosie Riveters' curriculum for local students in the preschool through middle school age range seeks to inspire future interest in STEM fields.

Brittany Greer, the Executive Director of Rosie Riveters, explains that the organization's goal has always been to close the gender gap in STEM. "In 2019, women made up only 27% of the science and engineering workforce in the U.S.," according to Ms. Greer, a statistic that Rosie Riveters seeks to change by building critical thinking and problem-solving skills while enhancing each participant's confidence in STEM. Since the organization was founded in 2015, the program has served over 4,000 participants through partnerships with over 10 community-serving organizations, with overwhelmingly positive results. Rosie Riveters' participant data shows that 96% of students enjoyed the STEM-focused curriculum, and 71% total were inspired to further explore STEM education.

Like other educators, Rosie Riveters has experienced challenges due to the Covid-19 pandemic, especially as it relates to in-person learning, but Rosie Riveters has been able to continue serving the community during this difficult time. In 2020, Rosie Riveters pivoted from inperson to virtual instruction centered around a STEM "kit" that was delivered to each participant. This shift allowed Rosie Riveters to provide hands-on STEM learning for more than 810 students in kindergarten through eighth grade via virtual lessons and check-ins. Ava, a recent participant in the Rosie Riveters program, described her experience in the best way possible: "If you're a girl interested in STEM, you should absolutely get involved with Rosie Riveters - it will take you places!"

Looking towards the future, Rosie Riveters is launching a new program called Rosie Innovators, with the help of funds raised from the FCBA Charity Auction, that will extend the organization's reach through high school. "Rosie Innovators will enable us to continue to build upon the trust and long-term relationships we have established with young women and their families, creating a highly effective STEM pipeline that runs from preschool to college," according to Ms. Greer.

Rosie Riveters and the FCBA Foundation are grateful for your support this year. While the auction gala will once again take place virtually, bidders can still expect new and exciting prizes.

This month I was fortunate to talk with Rachael Bender who is well known in the wireless portion of the FCBA. She is currently Vice President & Associate General Counsel, Federal Regulatory and Legal Affairs at Verizon. As part of the Verizon team, Rachael works primarily on domestic spectrum and broadband access issues. Prior to her time at Verizon were some exciting years at the FCC, mostly

spent working with FCC Chairman Pai on wireless, international and engineering issues. Before the FCC, Rachael was Policy Director and then Senior Policy Director at Mobile Future. I caught up with Rachael from our respective home offices, which I have to say is not quite as fun as meeting for a drink or lunch, but I know someday we will do that again!

### **Q:** What attracted you to the field of communications?

A: For as long as I can remember, I knew I wanted to be a lawyer. My grandfather was a former state senator and he told me he thought he'd have benefited from a law degree, so I think that influenced me greatly. Then I went to Catholic University for law school and took advantage of their communications law program. It's where I first met Bryan Tramont, who is a communications law adjunct professor. After taking Bryan's class (taught with the wonderful Rosemary Harold) and doing my first telecom internship there was no looking back in terms of my chosen area of specialization. I also benefited from and am now proud to be part of the large, supportive group of Catholic University alumni who work in tech and telecom.

### **Q:** Have things unfolded in your career more or less the way you planned?

Yes and no. For instance, I knew I wanted to serve in the public sector for part of my career. I never imagined when I joined the FCC in October 2016 that I'd be working for the Chairman just a few months later. It was a very active couple of years – everything you do is at a sprinter's pace in that office just given the sheer number of issues the Commission is considering at any given time. But I would say that each step of my career has given me the opportunity to grow, so I'm grateful even if each next step wasn't fully planned.

### **Q:** What's the most interesting or challenging thing that you've done?

I'm currently working on the C-band transition in support of Verizon's upcoming deployment of 5G using the band, which has a lot of moving parts and is a big priority for the company. It's an evolving and interesting project that keeps me busy!

In thinking about past interesting work, I have to say in the Chairman's office, supporting the work of the Chairman and FCC in international fora was quite fascinating. Engaging with global counterparts, even when we don't agree on everything, is such an important part of the Commission's work. Seeing firsthand that the United States is looked to by other nations for leadership on communications issues is something that has really stuck with me.

**Q:** Is there was something interesting or someone who surprised or impressed you during your career and why?

I have been really lucky to have great bosses, from internship supervisors all the way to my current position (pandering/shout out, Will Johnson!). My first long-term boss at Mobile Future, Allison Remsen, isn't a lawyer, but she taught me so much about advocacy in our space. She helped me look at policy decisions from multiple angles, not just legal. She is a boss who became a mentor and a friend.

Additionally, when I think of impressive, I think of my colleagues in the office of Chairman Pai. I had the pleasure of working with some of the smartest, most caring, hardworking people while I was there. It was the opportunity of a lifetime.



With two young children at home, I don't have a lot of time for reading for pleasure right now. And even then, I often have parenting books on my list! For instance, I recently read, *The Danish Way of Parenting*, which among other things talks about the benefits of free play for young kids. I also just finished Emily Oster's new book, *The Family Firm*. I'm a big fan of her data-driven approach on topics from pregnancy to parenting.

# **Can** you share perspective on the pitfalls to avoid or other career advice for those who are just getting started in the communications field?

Network with everyone. If you're a young lawyer or law student, don't just meet with lawyers you hope might hire you. Network with the engineers and try to learn from them. If you're an engineer, meet with the lawyers. Network with the lobbyists and the press team and gain insights into how each shop thinks about the same issues you're working on in your job. Get to know the business teams and understand how they see the issues too.

And network with your peers. Those relationships will be important as you move along in your career and provide you a different kind of support structure. In addition to networking, I really appreciated Jennifer Hindin's advice in the newsletter when she was interviewed a few months ago: be kind to everyone.

Lawrence Wiley (Larry) Secrest III passed away on September 10, 2021 after a long battle with Parkinson's Disease. Larry was

a long-time FCBA member and one of the founding partners of the Wiley Rein law firm. Larry inspired young lawyers to be critical thinkers, was impassioned by Civil War history, and was a die-hard Maryland Terrapins and Washington Nationals fan. He is remembered as a kind-hearted colleague with a laugh that could light up an entire room.

Larry was born in 1943 and grew up in Alexandria, Virginia. He graduated from American University in 1965 and received his law degree from The George Washington University in 1968. Following law school, he joined the US Marine Corps and served in Vietnam. Upon his return, he was recruited by Dick Wiley to join the Federal Communications Commission,



where he served from 1972 to 1977, including as Chief of Staff and, later, General Counsel.

Larry transitioned to private practice at Kirkland and Ellis before moving to Wiley Rein in 1983 to help Dick Wiley lead the firm's communications practice. He represented broadcasters,

cable television and satellite television operators, and other electronic media companies. His practice also included international telecommunications matters. During his time at Wiley Rein, Larry worked on some of the largest mergers and transactions in the communications field, including for National Amusements (now Viacom), Twentieth Century Fox, CBS and Comcast. Upon Larry's retirement, Dick Wiley remarked: "It is not any kind of exaggeration to say that I could not have achieved my own goals and aspirations – at the FCC and in private practice – without Larry Secrest."

At his memorial service, Larry was remembered as a tender man of nobility

and gentleness, and a human being "of great capacity." Wiley partner Kathleen Kirby said: "I will always remember Larry for his brilliance, grace, and good humor. He welcomed me warmly to the Wiley fold many years ago, and through his example taught me to be a better lawyer." FCC Enforcement Bureau Chief Rosemary Harold, who worked alongside Larry at Wiley for many years, observed that "he taught me that it can be great fun to be a great lawyer - fun in the sense of enjoying the chase through statutes and case precedent, reveling in an apt turn of phrase, and pursuing informal chats about scores of irrelevant topics, including but not limited to organized religion, mainstream media, and the Civil War. One of the few topics Larry didn't discuss often was helping women to advance in the legal profession. He just took steps to help it get done." Larry's former colleague Martha Heller, now with ViacomCBS, said: "I'm so grateful to have had Larry as a mentor. He was a true intellectual lawyer, he was a wonderful teacher, and he had a huge heart. And he had the best laugh, even on the stressful days."

Larry is survived by his wife Christinne, four children, and eight grandchildren. The family asks that any charitable donations be made to the Michael J. Fox Foundation for Parkinson's Research in honor of Larry Secrest.
