2013 and was confirmed unanimously by the United States Senate on October 29, 2013. He was sworn into office on November 4, 2013.

Prior to joining the agency Commissioner O'Rielly served as a Policy Advisor in the Office of the Senate Republican Whip, led by U.S. Senator John Cornyn, since January 2013. He worked in the Republican Whip's Office since 2010, as an Advisor from 2010 to 2012 and Deputy Chief of Staff and Policy Director from 2012 to 2013 for U.S. Senator Jon Kyl.

He previously worked for the Republican Policy Committee in the U.S. Senate as a

Policy Analyst for Banking, Technology, Transportation, Trade, and Commerce issues from 2009 to 2010. Prior to this, Commissioner O'Rielly worked in the Office of U.S. Senator John Sununu, as Legislative Director from 2007 to 2009, and Senior Legislative Assistant from 2003 to 2007. Before his tenure as a Senate staffer, he served as a Professional Staff Member on the Committee on Energy and Commerce in the United States House of Representatives from 1998 to 2003, and Telecommunications Policy Analyst from 1995 to 1998.

He began his career as a Legislative Assistant to U.S. Congressman Tom Bliley from 1994 to 1995.

Commissioner O'Rielly received his B.A. from the University of Rochester.

### Wednesday, February 19, 6:00 – 8:15 p.m. NSA Telephonic and Electronic Surveillance Reform – Are the Programs Legal and What is Going to Change?

The FCBA Privacy and Data Security Committee will hold a CLE on Wednesday, February 19 from 6:00 – 8:15 p.m. entitled “NSA Telephonic and Electronic Surveillance Reform – Are the Programs Legal and What is Going to Change?” This program will be held at Drinker Biddle & Reath LLP, 1500 K Street, NW, Conference Room 2B.

In the second CLE of the year addressing the scope of NSA and other law enforcement agency authority to conduct surveillance of “foreign communications” under the Foreign Intelligence Surveillance Act (FISA) and the USA Patriot Act, this CLE will examine the two conflicting federal district court decisions that have addressed the constitutionality of the NSA metadata collection program (one decision supporting Government authority to collect such data and the other ruling it unconstitutional), and possible outcomes of the appeal process. The CLE will also discuss the President Obama’s January 17, 2014 proposed partial reforms following the Presidential Review Board’s December 2013 recommendations, including changes in how the collected data will be stored and accessed by law enforcement authorities, as well as reforms to FISA court proceedings to introduce a new adversary process that would include an advocate for persons whose metadata is sought.

### Christopher Guttman-McCabe, Executive Vice President of CTIA-The Wireless Association

I recently had lunch on a cold January day with longtime FCBA member and Executive Vice President of CTIA-The Wireless Association, Christopher Guttman-McCabe. Chris has been with CTIA for 13 years, first in policy and now in the chief operational role. Prior to his time at CTIA, Chris was an associate at Wiley Rein. He had a prior career in strategic management consulting before going to law school at Catholic University of America in the communications law program.



**Q: What attracted you to the field of communications?**

**A:** I chose to go to law school just as my longtime girlfriend, now wife, was finishing with law school. We decided to first to find the city where she got her first job and then search there for law schools. My thought was to try to find a school that offered a unique program and the Catholic University of America communications program appealed to me and set my path towards communications law and policy. The legislative process that ended up ultimately being the 1996 Telecommunications Act was going on at the time, so there was a lot of activity. As a result of being in DC, I was able to intern in my second and third years of law school at the FCC, specifically working for Diane Cornell in the Telecom Division of the International Bureau. In my summers I had stints with Commissioners Ness and Quello which were fascinating and different.

**Q: Tell me about your career progression.**

**A:** As I was graduating law school, I interviewed with a number of firms and ended up deciding to work at Wiley Rein and I really enjoyed that experience. I had great mentors there in the form of Mike Senkowski and Nancy Victory. After a couple of years there however, Bryan Tramont gently prodded me to consider an opening at CTIA. It seemed like it might be a great place to keep learning and a bonus was that I was reunited there

with another great mentor, Diane Cornell, who was running CTIA policy at the time. I've been at CTIA ever since, but with different roles and responsibilities.

**Q: What is the most challenging part of your current position and why?**

**A:** About six months ago I became Executive Vice President of CTIA when Bobby Franklin left to join the Venture Capital Association. While I still dabble in policy and continue to testify on Capitol Hill (I believe this week was appearance number 25), I now have an operational role overseeing a range of matters, including membership, the planning for and success of our tradeshows, overseeing our financial matters, those sorts of things. While I was comfortable in the regulatory policy area, it's always nice to challenge yourself to learn new issues. It's also a bit of déjà vu in that some of the operational and strategic management aspects of my new role are not dissimilar to what I did when I first got out of grad school. I am continuing to interface with people I have known for a long time in the industry and in companies, and am spending more time with CEOs and the folks that work directly with them than previously, I'd say.

In my new role I have to be sure that the tradeshow and all things operational with the association run smoothly. Just like everyone else, I have to keep on top of new wireless products, services, and the general technology evolution. Even the last three or four years it has

been astounding to see the changes. The things that advancing technology enables is something that we will emphasize in the upcoming September trade show: smart homes, connected cars, mobile educational and mobile health applications just to mention a few. It's just an exploding and fascinating area.

**Q: What are you reading now?**

**A:** I read a mix of different things. Right now I'm reading "For All the Tea in China: How England Stole the World's Favorite Drink and Changed History" by Sarah Rose, which is about international trade and, believe it or not, industrial espionage back in the days of the East India Company. Also, as the only male in a household of my wife and a 13 and an 11-year-old daughter, I'm reading "The Female Brain" by Louann Brizendine. I grew up in a family of six, four boys and two girls, so it's helpful to get new insights why certain things may be driving some behaviors and reactions from three quarters of my immediate family.

**Q: What surprised or impressed you most about people you've worked with and why?**

**A:** I have to say the level of intelligence I see across the board in communications companies, the FCC, Capitol Hill and the administration. The intellect of people who work in the communications area has consistently amazed me. Based on the interns and young folks I see coming up today, I have to say that I think the future of our bar is in good hands.

**Q: Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?**

**A:** Well what I have to share on this is not particularly deep, but I believe extraordinarily important. I really think that being a good person, meaning having common decency and manners, and a

good set of personal ethics, goes really a long way to advancing in life and in a career. The most successful people that I meet have those characteristics and more often than not they are the type of people you want to speak with, to listen to, and probably hang out and have a beer with them. As my father would say, it's fairly elementary stuff, most of what you need to know in life you probably learned or should have, in second grade.

After that, the other perspective I would share would be to not obsess about having to get the perfect job. Just start out, just take a job, things will evolve from there. Don't let the perfect be the enemy of the good.

**Q:** What's something interesting about you that people are not generally aware of you are willing to share?

**A:** I love all types of athletic competition. I played a couple sports in college. It's probably no surprise then, that I coach both my daughters' soccer teams - one for six years and one for eight years, respectively. I have a deal with both daughters, if they keep playing, I will keep coaching. And you can imagine how interesting it is to deal with the highs and lows of seventeen 13-year-old girls on a team training and competing at the same

time! I also really enjoy traveling with my family and particularly international trips when we can fit them in.

**Q:** How long have you been an FCBA member and what is the value of FCBA membership?

**A:** I've been an FCBA member for about 20 years. I joined when I went to law school at Catholic University as part of the communications law program. I'm a huge fan of the FCBA and what it does. I think the FCBA is key catalyst to

creating an environment where lawyers and engineers from different companies, law firms and agencies can get together and share ideas and learn. It's just a great place for professionals. Also the FCBA does a lot to mentor younger professionals in our industry.

To the extent a recipient receives unanticipated funding for the unpaid internship, the FCBA Foundation’s general policy is to reduce its scholarship awards by any amount that a recipient’s total funding

(including all sources) for the internship would otherwise exceed \$7,000.
