Mignon L. Clyburn served as Acting Chairwoman of the Federal Communications Commission, following her appointment by President Barack Obama on May 20, 2013. As Commissioner, she is serving a second term as a Democrat on the Commission, for which she was sworn in on February 19, 2013 following her re-nomination by the President and confirmation by the United States Senate.

Clyburn began her service at the FCC in August, 2009, after spending 11 years as a member of the sixth district on the Public

The vast majority of 911 calls originate from wireless phones, including calls placed from indoors. This trend makes delivering accurate automatic location information about indoor 911 callers a pressing public safety issue. There have been significant advances in location technology, and various approaches to improving indoor automatic location accuracy have been proposed. In a Report and Order adopted at the January 2015 Open Meeting, the FCC established new rules and set deadlines for improving indoor location accuracy. In this program, government, industry and carrier representatives will provide an overview of the new FCC rules and related technical and policy issues.

Service Commission (PSC) of South Carolina. She served as its chair from July 2002 through June 2004.

Prior to her service on the PSC, Clyburn was the publisher and general manager of *The Coastal Times*, a Charleston-based weekly newspaper that focused primarily on issues affecting the African American community. She co-owned and operated the family-founded newspaper for 14 years.

A longtime champion of consumers and a defender of the public interest, Commissioner Clyburn considers every Commission proceeding with an eye toward how it will affect each and every American. She is a strong advocate for enhanced accessibility in communications for disabled citizens, and works closely with representative groups for the deaf and hard of hearing. She has fought to promote strong competition across all

communications platforms, believing that the more robust and competitive the marketplace, the less need there is for regulation. However, when the market is not adequately addressing consumer concerns, Clyburn is an outspoken champion for smart, targeted regulatory action. She has pushed for media ownership rules that reflect the demographics of America, affordable universal telephone and high-speed internet access, greater broadband deployment and adoption throughout the nation, and transparency in regulation. Commissioner Clyburn is a member of the Federal-State Joint Board on Universal Service, Federal-State Joint Board on Separations, and the Federal-State Joint Conference on Advanced Services, all of which she chaired for three years during her first term at the FCC.

Clyburn is a graduate of the University of South Carolina, and holds a Bachelor of Science degree in Banking, Finance and Economics.

challenges. As more generic Top Level Domain names (gTLDs) are being issued, there are more challenges ahead over the right to use certain names. For example, the Belgium city of Spa has objected to the creation of .spa as a gTLD and likewise governments along the Amazon River have opposed a push by Amazon.com to make .amazon a gTLD. There is expected to be a growth in litigation and disputes around copyright, IPRs, unfair competition issues, deceptive

trade practices, etc. These are some of the nuts and bolts issues that affect all stakeholders and the user community, and ICANN's regional HQ, set up in Singapore in 2013, is focused on addressing them for the region.

## Get to Know an FCBA MEMBER

### Jerald Fritz, Executive Vice President, Strategic and Legal Affairs, ONE Media, LLC

On one of the many cold and sleet/snow threatening late afternoons we seem to have had so many of this January, Jerry Fritz and I convened at a local bar. Recalling how long we’ve known each other is rather too much to contemplate without a drink in hand. But remembering how fascinating and vital our industry has been over the last few decades was fun. Jerry has an abiding love of television and entertainment that is infectious. He is particularly excited at his latest professional chapter, which is as chief strategic and legal officer of ONE Media, a technology company, co-owned by Sinclair Broadcast Group and Coherent Logix. ONE Media is creating the Next Generation broadcast transmission platform for the television industry. This is a converged media platform that supports a full range of services, infrastructure and wired/wireless broadcast models that Jerry and ONE Media hopes appeals to broadcasters of many stripes.

**Q:** What attracted you to the field of communications?

**A:** The bright lights of show business, of course! When I was 16, the NBC owned station in Chicago, WMAQ, commissioned an original television musical, “New Performers 1968!” From hundreds of auditions, they chose 26 of us to sing, dance and act in the Emmy-award winning program including notably the then-young, now-famous Broadway, film and TV star, Mandy Patinkin. So fast-forward 47 years, Mandy has his Grammys, Emmys and Tonys and I get to advance the ATSC 3.0 standard. So I put it to you: who’s more successful?!



**Q:** Tell me about your career progression and whether things have unfolded in the manner you envisioned.

**A:** I migrated from the stage and in front of the camera to college at Northwestern where I majored in television and barely avoided getting bounced by the Department Chair for advocating abolishing the Fairness Doctrine a year after *Red Lion* was decided. While an undergrad, I worked at WGN as a floor director for several shows including *Bozo’s Circus*, *Romper Room* and *Cubs Baseball*. (The Bozo gig was great training for working with clowns later in my career!) With a specific goal to get into the communications business, it was then off to law school at Notre Dame where I

ran the closed circuit TV system and did a year in London studying international communications law. (South Bend vs. London – I just look dumb!) While in law school, I had a captivating clerkship with FCC Commissioner Robert E. Lee and Chairman Dick Wiley, where I first experienced the fascinating “politics of policy.” Eye-opening! After my judicial clerkship, I returned to the Commission in the old Broadcast Bureau reviewing station transfers and trying cases in the Hearing Division. After a few years, I left the agency to work with former FCC Chairman Dean Burch at Pierson, Ball & Dowd, specializing in new technologies with Satellite Business Systems and HBO and the complex broadcast issues surrounding RKO. When Ronald Reagan was elected, I came back for a third stint at the Commission as Chairman Mark Fowler’s counsel, primarily advising on common carrier matters including adoption of the new cellular service and also advising on broadcast ownership rules. Fowler then asked me to help run the Tariff Division’s implementation of that “little project” -- the AT&T divestiture. Dazed and tired after that process, I returned to the 8th Floor as Fowler’s Chief of Staff where we did, in fact, finally abolish the Fairness Doctrine! Following that great run at the FCC, I was, for 27 years, general counsel and head of strategic planning for Allbritton Communications, including its 8 TV stations as well as several other businesses. Among the many fascinating things we did was to start the first local

cable news channel, NewsChannel 8, and launch the spectacularly successful website/newspaper, POLITICO. It was a phenomenal time where I was also privileged to sit on the Boards of the NAB, ABC Affiliates and Communications Forum for the ABA. This past summer, the Allbritton TV stations were sold to Sinclair, so that chapter of my career ended and I get to start afresh at ONE Media.

**Q:** What is the most challenging part of your current position and why?

**A:** Turning around the aircraft carrier that is the broadcast industry in a sea of huge technical, regulatory and business waves is a huge challenge. Unless we do so, though, I fear that the boat might sink. The anchor of inertia is a tough obstacle, but the promise of mobile video delivery and a host of other opportunities provides real upside to those of us broadcasters who want to remain after the auction. That's the challenge: getting broadcasters to think in those terms.

**Q:** What are you reading now?

**A:** I'm a big history buff and am reading Lynne Cheney's wonderful book, "James Madison - A Life Reconsidered" and the biography of the 19th Century theatrical family that gave us Junius, Edwin and John Wilkes Booth, "My

Thoughts be Bloody." Maybe the best book, though, relates to one of my great passions, "Drawn & Quartered: the History of American Political Cartoons."

**Q:** What surprised or impressed you most about people you've worked with and why?

**A:** I've had three stints at the FCC and I have to say the quality of the work done at the FCC is substantially undervalued. I find the folks in our bar and related industries for that matter to be both committed and passionate. At the same time, we all suffer from what appears to be endemic to all of Washington, the plague of cynicism. It's the safe course not to be labeled naïve, but our challenge daily is to get beyond that. Some days are more successful than others!

**Q:** Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

**A:** Over the years, I have given a short lecture to young associates about 10 best and worst ways to gain or lose a client from someone's who's been gotten and lost. Among the rules: have a human answer your phone (I have other options), spend some time off the clock with the client to understand the business (you're expensive), answer what's asked (ask questions!), KISS and tell quickly (simple/stupid) and look for ways to keep me out of trouble (you'll be rewarded with more business!).

**Q:** What's something interesting about you that people are not generally aware of you are willing to share?

**A:** Well, I've written the book for a Broadway musical called "Boo." It's a cross time/cross generational love story that takes place in a cemetery with floating avatars who sing and dance. Very exciting! The book is done, but I do need some help with the music. Any great composers in the communications bar?

**Q:** How long have you been an FCBA member and what is the value of FCBA membership?

**A:** I've been an FCBA member for nearly 40 years. I joined in 1976. I think the FCBA CLE programs are truly outstanding in terms of the expertise that is represented and the willingness of practitioners to donate their time. I had the opportunity for many years to help run the FCBA/ABA/NAB Las Vegas Program, "Representing Your Local Broadcaster" and always marveled at the energy that all the panelists brought to the seminar. Now if we could only get them to sing and dance....
