First, on February 15th and 16th, the FCBA and The Catholic University of America,

Columbus School of Law will co-sponsor the 2019 National Telecommunications and Technology Moot Court Competition. The FCBA's National Moot Court Committee has prepared a compelling (and topical) problem involving political advertising restrictions imposed online social media platforms (tell me if you've heard this before). The Committee has worked hard on the problem and we thank the many members that have volunteered to judge briefs and the oral arguments. This year's competition boasts at least 10 national teams, and one international team traveling all the way from France (oh là là)! Snap out of your post-NFL hangover and join us at CUA Law School and meet future telecom lawyers.

Next, the Engineering and Technical Committee has put together an excellent panel for its Spectrum 101 CLE on February 20th. FCBA Foundation 2019 College Scholarship Program: Application Now Available

Get to Know an FCBA MEMBER

Rebecca Murphy Thompson

I had the pleasure of catching up with Rebecca Thompson recently over very hot cups of coffee on a cold winter afternoon. Rebecca is now several months into a new position at Twilio, where she is Head of Communications Policy, Global Public Policy and Government Affairs. Twilio is a growing organization that combines communications and technology to deliver value to business users, and Rebecca



was enthusiastic about her time at Twilio thus far. Rebecca has years of experience both at law firms and with associations, and she had some great insights to share regarding development as an attorney, the value of the work of the FCBA Foundation, and the compelling reason to be who you authentically are.

What attracted you to the field of communications?

I caught the bug in college. I went to Drexel University where I concentrated in history and political science. While there, I had a communications professor who told me that if I was interested in furthering my studies of mass media that I really ought to look at Catholic University for law school because of its Communications Law Institute. At that point Harvey Zuckman was running the Institute, I visited, I applied and got in. And the rest is history. But looking back at that decision, I think CUA and the Communications Law Institute was what led me to a lot of internships and externships that further ignited my interest in communications law and policy. Lucky for me, the CUA alums are a networked and tight knit group.

Back in college and in law school I was particularly interested in First Amendment and broadcast journalism. I thought perhaps I would become a legal correspondent. While in school I was fortunate to have a CBS News fellowship. A CUA law school alum had been instrumental in that opportunity. However, the experience was not what I had thought would be; it was during the Clinton impeachment hearings and it was tough sledding. I found that I did not enjoy the newsroom environment quite as much as I thought. But the communications field is large and there

was a boom in wireless that ultimately took me in a different direction.

Have things unfolded in your career more or less the way you planned?

I cannot say that my legal career has unfolded in any planned fashion, and that is just fine with me. I began my post-law school career in the wireless area just as wireless was really taking off. Early on, I thought maybe I would become a partner in a law firm as I really responded to the collegiality and the teamwork. But another opportunity came up to rebuild and reimagine a wireless carrier association that was incredible, so I wouldn't have traded that experience for anything.

Starting out, I spent over seven years at a small, communications law firm doing all kinds of rural wireless work. I even developed some of my own clients as time went on. Then I had an opportunity to try my wings at doing more policy work at Patton Boggs, which was an appealing way to expand my horizons. Again, I worked on wireless broadband issues and I really enjoyed doing lobbying at the time of the stimulus package that included rural broadband funding. I was not looking to leave when I was introduced to the then-named Rural Cellular Association, a relatively small group of wireless carriers that was being reorganized by CEO Steve Berry as the Competitive Carriers Association (CCA). Steve was looking for a General Counsel

to help lead RCA and his plan was to be bipartisan and to have a diverse team. I loved that CCA in many ways was like a start-up; over about eight and a half years we grew the association from a negative budget to a more sustained one, had 15 permanent staff and about a hundred wireless carriers as members before I left. I learned so much and had a terrific time. Another great thing about CCA was that it let me take time to be part of important things that the FCBA does in terms of the Foundation, and the Young Lawyers Committee.

Which brings me to Twilio, my new gig. Twilio is a cloud-based communications company that allows software developers to transform a business's communications with its customers. I've only been there a couple of months and I am still learning the technology, but as an enterprise company primarily, we are very focused on assisting the communications missions of small and medium-size businesses. And while the company is growing by leaps and bounds, the CEO Jeff Lawson made time to contact me as soon as I joined to welcome me personally. I'm especially proud of the company's philanthropic activities. A fun fact to share about Twilio is that every Twilion (yes, that's the term for us) is encouraged to learn to code and create an app. So far, I've been able to code my phone number to act as a conference line, which I count as a great beginning.

What is something that has surprised or impressed you during your career and why?

There are many great folks in the communications bar and at the FCC as well who have done tremendous mentoring for others. Bryan Tramont, in particular, goes above and beyond to help others with his pay-it-forward motto. Bryan was my neighbor before he was a colleague. I got to know him better during our regular Friday night game nights. In fact, he identified the Rural Cellular Association opportunity and probably knew what a good match it would be for me before I even heard

about it. I know he mentors others and gives so much to so many people. I also have Bryan to thank for my membership on the board of trustees at William Woods University, a rural university that needs tech and telecom assistance. Other communications professionals that I would count as mentors include Roger Sherman and Maura Corbett. In addition to his weekly spin class, I'm constantly bugging Roger for his professional and personal assistance. He has his finger on the pulse of just about everything. And Maura is a proud Jersey girl, like me, and a champion for all women in tech. I'm always impressed with the willingness of my colleagues to help others, and these three certainly standout.

When you have time to read, what do you enjoy reading?

I love reading fiction. I'm currently reading the Alternative Side now by Anna Quindlen. It's a fascinating exploration of the dynamics in relationships in a cozy New York City neighborhood being broken apart by diverging views of a tragic incident. At the urging of my husband, I have Joe Biden's biography to read next.

Can you share perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

First and foremost, anyone getting started should join the FCBA, find something that speaks to them and get involved. There's no better way to become aware of the wide range of communications law and policy issues and the networking and other opportunities are unparalleled. The FCBA is for everyone, including nonattorneys. The earlier you get involved in an organization like the FCBA the better. Looking back, I wish and gotten more involved earlier in my career.

In terms of habits that can lead to success, I would say do good work, always do good work. As a younger professional, your big focus should be on ensuring that your product is first rate without fail. Also, consider everyone to be your client.

A less obvious point would be to tap into what I think was my own secret to success: just be yourself. People can tie themselves up in knots sometimes trying to be something they're not, and that is no way to be happy or feel successful. So bring your authentic self to work; it will serve you well in all aspects of your life.

What is something interesting about you the people are not generally aware of that you're willing to share?

Here's a fun fact; I was an internationally ranked tennis player in high school and went on to earn the best record ever at Drexel University, that I think remains to this day. Having the discipline required to excel at tennis kept me occupied and helped me to learn time management skills that are still with me today. Unfortunately, I'm no longer an active tennis player, but I still love the sport.

How long have you been an FCBA member and what is the value of the FCBA membership to you?

I've been a member since I got out of law school, so I have been a member at least since 2000. At certain points in my career I've been very involved in the Young Lawyers Committee, helping at the charity auction. Now I have the great privilege of serving on the FCBA Foundation board as one of the co-chairs with Johanna Thomas. I think that the FCBA is one of the best run organizations out there for professional development, and I am a strong supporter of the Foundation's work. I'm also grateful that Twilio supports my activity in the FCBA Foundation.
