Nominations for the 2020 FCBA Election

Many stewards of the Internet's most popular websites, online services, and platforms have historically funded their products and services by harnessing the value of consumer data, with varying degrees of transparency about what data they collect, how they use it, and what third parties do with it. Consumers, public interest groups, some tech companies, regulators, and governments across the world have increasingly criticized this state of affairs – and called for reform.

This event will present an in-depth discussion of key trends in these reform efforts, including the growing role of consumer data rights, increasing platform regulation, and ongoing debates over the efficacy of enforcement efforts. We will examine the varying approaches that recently implemented laws, such as the European Union's General Data Protection Regulation (GDPR) and the California Consumer Privacy Act (CCPA) have taken on these three topics – and what approach future laws and regulations may take in the new decade.

SESSION II: PLATFORM REGULATION

Toward the end of the decade, lawmakers, regulators, and the public placed a renewed focus on the responsibility that platform providers have for the content and conduct of companies that use the platform, including those providers' and their corporate clients' privacy practices. For example, Google settled allegations by the Federal Trade Commission and New York Attorney General that its subsidiary YouTube knowingly collected information from children in violation of the Children's Online Privacy Protection Act (COPPA) Rule. And Facebook has been subject to intense scrutiny in connection with its sharing of Facebook users' data with third parties. Panel II will discuss and debate the current and future states of platform providers' evolving obligations as "privacy gatekeepers" for third-party conduct.

In MEMORIAM

The Association lost two distinguished retired members this past year: Ed O'Neill, a past President of the Association, who died August 28 at the age of 87; and John Harwood, a retired partner of Wilmer Hale, who died on September 24 at age 74.

Edward S. O'Neill

Ed O'Neill was born October 16, 1931 in Hoboken, NJ. He graduated from high school in 1948 and entered Catholic University in Washington, D.C. to pursue his undergraduate degree. However, his studies were interrupted by a four-year stint in the Army, after which he returned to C.U. He graduated in 1956, and from the Catholic University Law School in 1959.

Ed O'Neill was with the well-known firm of Welsh Mott & Morgan in the 1960s, doing broadcast hearing work, before joining Wilner & Scheiner. He practiced with the Wilner firm for many years, leaving in 1982 to join Bryan Cave. Ed finished his career with Fletcher Heald & Hildreth, retiring in 2007.

After his tour of active duty, Ed remained in the Army Reserves. He retired in 1992 with the rank of Major.

Ed is remembered as a meticulous practitioner who developed close

relationships with his clients, and as a person of exceptional wit. He was FCBA president for the Association's 1983-84 fiscal year.

Ed's wife of 59 years, Carolyn, predeceased him. He is survived by five children, twenty grandchildren and 12 great-grandchildren.

John H. Harwood II

John Harwood was a partner in the firm of Wilmer Hale and its predecessor Wilmer, Cutler & Pickering. He was a member of the firm's communications group.

John graduated from Harvard College in 1967. He then enlisted in the Marines and saw combat as a First Lieutenant in Vietnam. After military service, John entered Columbia University's Law School, from which he graduated in 1973.

After a year at the Institute for Public Representation at Georgetown University, John joined Wilmer Cutler, becoming a partner in 1981. John handled matters before the FCC and federal courts of appeals, principally the D.C. Circuit. John was later in charge of the firm's Brussels office, where he and his family spent several years. In more recent years, before

his retirement in 2009, he served as chair of the firm's Communications Group.

He is remembered as being collegial, dedicated, and good-spirited, a partner who cared deeply about his colleagues and the firm.

John is survived by his wife, Corbin; their two children; a daughter-in-law; and a granddaughter.

Get to Know an FCBA MEMBER

Jeremy Berkowitz

Jeremy Berkowitz is currently at the Promontory Financial Group, a strategic consulting firm, and a subsidiary of IBM, where he is a Principal in their data protection and privacy practice, working with clients to assess their privacy compliance and operational needs. Not surprisingly, Jeremy is an expert on state, federal and international privacy law and policy frameworks. Jeremy is an alum of the Catholic University of America (CUA) communications law program and I was delighted to sit down and talk to Jeremy about his career and learn more about his focus and approach to these issues as a consultant. Jeremy and I, along with others, are co-chairs of this year's FCBA Privacy and Data Security Committee, where there is no shortage of CLE and other ripped from the headlines topics!



Q: What attracted you to the field of communications?

A: In college I was very interested in journalism issues and once I started considering law school I was attracted to CUA's communications law program. I attended an information session and was hooked, particularly learning about the specialized communications law classes and internship opportunities that the program offered. While journalism continued to excite me, I saw that First Amendment issues really are a small part of the overall field, and that communications offered a much broader sweep, with many more career options post-law school.

I was lucky while in law school to intern at several different places, and as a result I saw the breadth of the communications legal field in trade associations, law firms, consultancies and the federal government. I interned at the Wireless Telecommunications Bureau the summer after my 1L year and worked on 700 MHz issues, as well as merger reviews. I did a stint at a small telecommunications law firm in Arlington that did mostly broadcasting law. I also interned at PCIA (now WIA) as well as NTIA in the Department of Commerce. So, even before I graduated, I knew I wanted to be working in some area of communications law or policy.

Q: Have things unfolded in your career more or less the way you planned?

A: During my last year of law school, I spent about 30 hours a week as a broadband policy associate at e-Copernicus, a small lobbying firm that was then primarily supporting clients in their applications for broadband stimulus funds (BTOP) from the federal government. It was there I met Jennifer Holtz, who worked with me at e-Copernicus and then brought me over to Booz Allen Hamilton in 2010. I did not originally anticipate management consulting as a field post-law school, but the 2008 economic jolt was creating challenges with the job market, and Booz Allen at that time was actively seeking people with legal backgrounds for help with various clients. I found over time I really enjoyed the consulting world and spent 5.5 years with BAH working on cybersecurity and privacy issues, first with the Federal government, and then with private sector clients. From mid-2016 to 2018 I was a Privacy Counsel and Senior Consultant for Deloitte and there I focused on issues around NIST privacy controls and the European general data protection regulation (GDPR). More recently I've become a Principal in Promontory's data protection and privacy practice. My primary role is working with clients and leading engagements on privacy compliance and operational needs. These days, that includes a lot

of consulting on compliance matters with CCPA, GDPR, and whatever other jurisdiction may next pass a major privacy law. I also do a lot of working on structuring privacy organizational functions and standing up CPO offices. More recently, I've gotten involved in helping to develop a practice area around the digital ethics of AI and automated processing. Privacy has shifted in the past 10 years from a strictly-compliance exercise to a risk management exercise, and now there is another shift ongoing as companies are taking more pro-active measures to show they are trustworthy stewards of the data collected from their customers and employees.

I can't say this has necessarily been my master career plan, but one opportunity has led to another, and I'm content with how things have progressed.

Q: What is one of the most interesting and challenging thing you've done in your current position?

A: For the clients I work with, the implementation of the California Consumer Privacy Act, known as the CCPA, is taking up quite a lot of bandwidth. Apart from that, I would say a continuing challenge, even when working with large, sophisticated clients that want to do the right thing the right way, is that you must be very mindful and take the time to understand the internal concerns of particular operations before you start making recommendations. For example, a significant part of what I do is working with clients on building out organizational privacy offices, which can be a new function that may well require new staffing, procedures, and assessments. This sort of change can be hard and people in any organization can perceive new offices or new functions as a diminishment of their own roles. This can manifest in some relatable but challenging behaviors. One aspect of my work is to get any reluctant participants engaged so the process and outcome is positive for the client. That's not always easy.

Q: Is there someone who surprised or impressed you during your career and why?

A: I joined the FCBA in my 1L year and have always been impressed by the large number of people who are willing to spend valuable time offering me advice on navigating law school and then my career. There are too many people for me to name, who have continuously provided counsel throughout the years, and have set good examples as well-respected professionals. However, I really must thank Mark Brennan, Julie Kearney, Davina Sashkin, and Jennifer Holtz who have been mentors and friends for more than 10 years now. They have offered me advice at different points of my career, given me opportunities to get more active in the bar, and provided the occasional sanity check to my thoughts.

Q: What do you enjoy reading?

A: A lot of different things, and all the holds I have in the DC Public Online Library all always seem to come through at once. One book that I've really enjoyed recently is Samantha Power's "The Education of an Idealist: A Memoir." I generally avoid political memoirs, as I find they more or less tend to be about score settling, but Power's book, probably due to her journalism background is an honest assessment of her time and experiences on the foreign policy frontlines of the Obama administration. I also am reading "Shadow of the Wind" a novel about the aftermath of the Spanish Civil War in and around Barcelona, and also just finished Ann Patchett's newly released "The Dutch House."

Q: Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: When you reach a certain point in your career, you are constantly getting training and learning lessons on managing individuals who report to you. Just as important, but not always emphasized is the importance of managing up, regarding the people you report to. You will have a variety of bosses with different work styles and needs and it's important to realize that anticipating their questions and knowing how to proactively take problems off their plate, is going to be very useful, particularly in flat organizations. I would also say to remember that your audience is your boss as well as your client. So, you should strive to make that boss (whoever it is for a particular project) look good.

Another suggestion is related to networking and focusing on the quality of relationships you build. It is beneficial to walk into a large networking event as a law student or early in your career and try to meet everyone, picking up a large stack of business cards along the way, for you to follow up with different individuals for coffee later on. However, it's just as important to focus on building solid relationships with individuals who are willing over a period of time to take you under their wing. That's not to say you shouldn't stop meeting new people, but I would focus just as much time on building relationships with individuals who you establish an immediate rapport with and can eventually become valuable mentors.

Q: What something interesting about you that people are not generally aware of the share?

A: I became a German citizen a few years ago. My grandfather was born in the Westphalia region of Germany in 1920 near the Belgian border, and with his family, fled overnight in November 1938, narrowly escaping arrest. He later spent time in concentration camps in France and Poland, miraculously survived, and immigrated to the United States in 1948. For individuals who were forced to flee Germany like that, as well as their

descendants, there's an opportunity to reclaim your German citizenship. Given some of my international work, having that dual citizenship can be beneficial, however, there were some personal reasons for doing it also. My grandfather's family had lived in that region of Germany since the 1700s, as part of a small but thriving Jewish community. He would have turned 100 this month and I don't think anyone could have foreseen then, the destruction of that community over the following 20 years, or that my grandfather would eventually survive his ordeal, start his life over, and become an American citizen. Holding dual citizenship has made me appreciate my German background as well as being born an American, even more.

Q: How long have you been an FCBA member and what to you is the value of FCBA membership?

A: I've been an FCBA member for 12 years joining during the beginning of my 1L year. I value the FCBA for professional and educational opportunities as well as the insights that other members are readily willing to provide about the field. I must salute the terrific job the organization does in encouraging building relationships and fostering mentoring opportunities. The FCBA allows you to explore new areas and helps you to navigate in the professional world.

I'm particularly happy to see that the FCBA has grown with industry trends during the past decade. This includes the addition of the IoT and Telehealth committees, ensuring the continuing growth of the bar with attention to new areas in the field.

FCBA Foundation 2020 College Scholarship Program

The FCBA Foundation College Scholarship Program provides financial assistance and laptop computers to DC public high school students to assist them in attending college. For over 24 years, the Foundation has helped over 270 local high school students attend college with scholarship awards ranging from several thousand dollars up to \$28,000, payable over four years.

The Foundation committed \$275,000 to its 2019 scholarship class via scholarships

of between \$8,000 and \$20,000 to graduating seniors who were selected because of their academic achievements and service to school and community.

The Foundation's web-based application lets interested high school seniors, who are matriculating to college next fall, apply for a scholarship online. The College Scholarship application is available at <https://webportalapp.com/sp/fcbacollegescholarship>.

The deadline for submission of applications is **Tuesday, February 25, 2019**. The Foundation plans to conduct interviews of promising applicants in early April 2020. We will notify successful applicants regarding their scholarship awards before May 2019.

FCBA Foundation 2020 Law School Summer Stipend Program

For the 27th consecutive year, the FCBA Foundation will award stipends to law students employed as unpaid summer interns through its Law School Summer

Stipend Program. The program provides stipends to students from around the country who want to dedicate their time and talent over the summer to government service in areas that relate to communications law, including broadcasting, cable, information technology, television, telephony, satellite, and wireless. It also can include work at agencies and Congressional committees addressing other communications-related areas, including internet law and policy, privacy, cybersecurity, copyright, emerging technologies, and related policy and legal issues.

In 2019, the Foundation awarded stipends ranging from \$1,000 to \$7,000 to 25 deserving law students who accepted public service positions for the summer. In addition, the Foundation selects one outstanding intern each year to receive an additional stipend for the summer: the Max Paglin Award.

Details on the Summer Stipend application dates and process will be released in the coming weeks.

FCBA Foundation 2020 Law School Scholarship Program

The FCBA Foundation Law School Scholarship Program provides financial assistance to rising second- or third-year students currently enrolled in accredited law schools in the United States who have a demonstrated interest in pursuing a career in communications law. In 2019, the Foundation awarded scholarships ranging from \$7,500 to \$10,000 to five outstanding law students. The scholarships are payable to the applicable law school in one lump sum to help the student with tuition or other education-related expenses.
