2014-2015 FCBA Membership Renewals

It is time to renew your FCBA membership. Your current membership expired on June 30, 2014 and by renewing, your membership will be good through June 30, 2015.

Please note that the deadline is JULY 31, 2014. You can avoid receiving future email reminders that your membership has expired by renewing today! Also note that all membership notifications and receipts are emailed to FCBA members only – we cannot send them to a member's assistant or secretary.

Please note that you cannot change your membership type or your contact information online. If you need to make a membership type or contact information change, contact Wendy Parish at wendy@fcba.org BEFORE paying the invoice.

Every member must login to renew.

Click the **Login** link at www.fcba.org or go to <https://netforum.avectra.com/eWeb/DynamicPage.aspx?Site=FCBA&WebCode=LoginRequired> to log into your account.

If you do not know your password you must click on the “**Forgot your Password?**” link and follow the instructions to generate a new password. The system will then email you a link which you must activate to change the password. **Note that link that is emailed to you is only good for two hours from the time you request it and that it can be only used once.** If more than two hours have passed or you already activated it you will have to go back and click on “**Forgot your Password?**” again.

TO RENEW ONLINE BY CREDIT CARD:

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click on the **Pay Open Orders** button at the top right of the **My Transactions** page.
- Check off the box next to the order/invoice you wish to pay, click **Next** and follow the instructions to process your payment.

TO RENEW BY CHECK:

- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click the **View More** link under the Invoice Details column on the right side, then when the page opens click on **Print This Page** on the upper right side to print out the order.
- **You must include the printed order with your check and mail to the address on the order.**

Len Kennedy, Senior Vice President and General Counsel, Neustar

I recently enjoyed a meal with Len Kennedy, who has had a number of significant roles in the communications industry over the course of a distinguished 34 year career, including as an FCC attorney, an eighth floor staffer to former FCC commissioners Ervin Dugan and Patricia Diaz Dennis, as partner at Dow, Lohnes & Albertson, as General Counsel at Nextel, then Sprint, as the first General Counsel for the Consumer Financial Protection Bureau (CFPB) and now as General Counsel of Neustar. Our conversation was wide ranging and eclectic.



Q: What attracted you to the field of communications?

A: In college, I was interested by my economics courses. But what really fascinated me was microeconomics, because of its way of crystallizing the animating forces behind important issues such as regulation, industrial organization, and economic policies. Through this route I came to antitrust and was struck there by how public policy sought to positively address challenging structural issues. At the time we were witnessing the beginnings of deregulation of certain industries, including both telecommunications and the financial services industry. The beginning of these deregulation trends was my own introduction to how economics and industrial organization can be managed or can help to translate these trends to optimize societal well-being.

Q: Tell me about your career progression and whether things have unfolded in the manner you envisioned.

A: If I look back, I see now how everything I've ended up doing was what I'd hoped to do. The only exception is I never got to be an antitrust lawyer simply because by the early 1980s there was a dearth of antitrust actions as a result of the boom in the "Law and Economics" school of thought and the deregulation of certain industries. But I've been part of or had a ringside seat at many communications and technology

revolutions; the Bell System breakup, the rise of wireless and all that that enables, the maturation of competition in telecommunications and the growth of regulated and unregulated services.

Q: What is the most challenging part of your current position and why?

A: A general point first and that is that Neustar is a small company, certainly small compared to Sprint or Nextel, so my surprise in becoming associated with Neustar is that being small in terms of size is not necessarily the same as being small in terms of importance. It is not surprising really when you think about it. Silicon Valley has all sorts of small companies that do incredibly significant things. Like these other technology companies, Neustar does some incredibly significant stuff, such as support advanced communications platforms and infrastructure. These capabilities enable anyone to compete both with traditional telephone companies and new entrants in the services they provide.

So there are two big challenges. The first is Neustar's engagement in seeking renewal of the Local Number Portability Administration contract. Nearly 50% of Neustar's revenues are attributable to that contract. This represents a daily set of challenges that have been going on for some time and will continue for a while. The second set of challenges is constantly honing the information and data analytic services that Neustar is already offering

and continues to develop. These offerings can provide new insights to entities wanting to know better ways to sell their services. Using these tools it is possible to know almost immediately which ad campaign for a Christmas product, for example, is effective and which can be shelved. There is lots of engineering and know-how behind this, and it allows companies to be much more effective in allocating their resources.

Q: What are you reading now?

A: I'm currently reading a lot on philosophy and religion. What prompted my recent interest in philosophy frankly was my longstanding interest in economics. In 2009 and 2010 I did a study on the global financial crisis, it was called "Find it, Face it, Fix it; How to Protect Your Company from the Boom and Bust Cycle." In doing my research, I looked to learn lessons from the 1929 crash and the Great Depression, and to other periods in history, even analogues in ancient history, as well as deregulation to help make sense of what happened. A couple of years after I wrote the paper, I reread it and was left with the feeling that something was missing. After thinking about it, I realized that a lot about how economic power, corporate governance, and public policy manifest in the world really springs from something deeper; that is how humans organize themselves and operate through collective actions and the problems caused by excess in the pursuit of things such as money and success above all else.

This led me increasingly to a broader view that just doing what feels right in terms of personal optimization of opportunities doesn't necessarily result in the best outcome for the individual or society. There is a philosophic aspect to all this. I think of a character in Colum McCann's book *Let the Great World Spin*, where a judge said "How did recklessness and freedom become a cocktail?" It's notable that this quote is from a judge, a person whose role is upholding the rule of law,

refereeing actions for the good. How did we all become somewhat inured to all kinds of “over the top” behavior? To me, reading philosophy has provided an added dimension to why things got so close to spinning out of control. Luc Ferry’s *A Brief history of Thought: A Philosophical Guide to Living*, brilliantly covers over 2000 years of thought in less than 300 pages.

Q: What surprised or impressed you most about things you’ve experienced and why?

A: I would compare my stint at the CFPB with my time in communications and the contrast to me is surprising. The CFPB was created in response to the financial crisis, which among many things showed us that the workings of economics is very important. In fact, it’s vitally important to modern society and to capitalism. Finance is all about measuring and allocating risk - creating paper whose value is derived from other things. The system can be stable, or unstable, as when it broke down in 2007, when there was enormous, widespread devastation. In contrast, communications as an industry generally has worked very well, even when the industry was moving from monopoly to competition with certain firms failing. Yes, eggs were broken, and parties had very different views about the right answers to major questions. But the upheavals in the communications industry over the last 30 years have generated great social and economic value for this country and support a global economy and networked society.

Through the major battles in communications, even when there were robust disagreements with players of all sorts, the FCC and its processes helped solutions to emerge. It is notable to me that even the small parties can participate and share their views and the governing statute, the Communications Act, in general has been elastic enough to expand as technology evolved. In our industry, lawyers engage in productive discussions

in the crucible and the tangible result tends to be positive.

In the world of finance, deregulation did little to make the social risk of complex instruments like derivatives transparent to everyone. It is undeniable that there’s a legitimate public interest concern in this area but private actors act often proceeded without the protection of ex partes and other forms of public participation. There was no historical, institutional bias in favor of robust public participation. There was no tradition at all of ex parte transparency. Large private players spoke directly to the government about significant issues without robust public disclosure. I think we learned the hard way that it is not necessarily a great system in terms of protecting non-industry participants. I would suggest that as a society we try to learn from these experiences. What’s emerged from all this, at least for me, is a basic point that public policy has to be tied to the character of the industry being regulated. Any policy that fails to relate to the character of the industry could well end up being at odds with the dynamics of the industry and it will produce a poor outcome.

Q: Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: The single most important thing I would say is to overcome your fear of failure, your fear of being wrong. We all have these fears, but they need to be faced. Challenge yourself to do your best and do not be shy to ask of others, as the late New York City Mayor Ed Koch used to say “how’m I doing” or, can I do it better? What you do is an expression of who you are and each project you work on should be the best it can be. It should stand the test of time. A friend shared with me a saying that I think is from the Jesuits that has stuck with me, and it is “work like everything depends on you and pray like everything depends on God.” So I say be fully engaged with what you are doing. If it does not feel right for you, then undertake an inquiry process

and make a change. But be interested, engaged and be willing to take a chance.

Q: What’s something interesting about you that people are not generally aware of that you are willing to share with the Newsletter readers?

A: I came to Washington 34 years ago to be a communications lawyer at the FCC. That gave me great opportunities to work in areas such as in economics, regulation and public policy. A big surprise along the way was that I discovered Tai Chi. Tai Chi is a form of exercise and meditation that has a spiritual dimension as well. It teaches you to always leave the door open. I can say without hesitation that Tai Chi has enriched me in my personal and professional life. I found joy in this totally unexpected interest that has helped me to see so many things from a new perspective. Through Tai Chi I met my wife, who is an artist. Tai Chi can help anyone harness the creative force inside that is most necessary to be expressed and shared in the most appropriate way. Artists offer their creations and we as lawyers often feel we don’t really have that luxury of being indifferent if the person viewing our work it does not “get it.” Our clients vote every day, our role can be more about fulfilling another’s need or vision. But when you think about it, every business, NGO, college or other organization is striving to express its own set of interests and ideas. That’s in its way a creative process. And our economic system unleashes and harnesses our creative energy as well if we let it.

Q: What, from your perspective as a long term member, is the value of FCBA membership?

A: The FCBA is a great organization because it encourages and provides many opportunities and venues for communications law practitioners to learn. We are a community and this is true despite the fact that I might be on one side of an issue and you are on the other. We are still a community. As a collection of people in many different phases of their

careers and with many perspectives, the FCBA helps us understand and make sense of what's happening through its many programs, committee events and meetings. It helps us see that we are not operating in a zero-sum world. We can think about and solve problems with a wider scope of vision. Importantly, the FCBA helps to develop the skill set of younger lawyers, who we will need to assume leadership roles. There is no

area I can think of that will see more change in the next 10 to 15 years than the communications field writ large. The FCBA has been around since 1936 and its distinguished members have been active for many decades in helping shape policy. It is a privilege to stand on the shoulder of giants and the FCBA is one heck of a giant.

In MEMORIAM

Michael J. Shortley III (1954 – 2014)

Michael J. Shortley III, an attorney with Level 3 Communications in Rochester, New York, died on May 7, 2014, following a battle with cancer. He was 59.

Michael was born and raised in Chevy Chase, Maryland and was a 1972 graduate of Georgetown Preparatory School. He graduated from the University of Virginia in 1976 with high honors and he received his J.D. from the University of Chicago in 1979.

He began his legal career at Hughes, Hubbard & Reed, in New York, in litigation and antitrust law. He then held in-house legal positions at Bell Atlantic, Rochester Telephone, Frontier and Global Crossing. At Global Crossing, Michael was Vice President and Regional General Counsel-North America, from 2002 until September 2011, when Global Crossing became part of Level 3 Communications. Most recently, at Level 3 Communications, Michael was Vice President in charge of state regulatory affairs, regulatory compliance and regulatory litigation.

Michael was known among his peers and colleagues for his work ethic, sense of humor and extensive knowledge and versatility as a communications lawyer. For many years he managed large regulatory compliance operations while at the same time handling significant and complex litigation himself. During his career, for example, Michael argued cases before the U.S. Court of Appeals for D.C. and Ninth Circuits and the New York State Court of Appeals and Appellate Division. He participated in two cases before the U.S. Supreme Court.

Michael became a marathon runner in his 50s. He was part of the Fleet Feet Rochester Running Team and ran in several marathons, half marathons and other races. He also was involved with raising funds for the local Humane Society animal shelter, and he enjoyed golf and tennis. He was an active member of the Church of the Assumption in Fairport, New York.

Michael is survived by his brother and sister-in-law, Brian and Kathleen Shortley, of Chevy Chase, a niece, and aunts, uncles and cousins.

FCBA Foundation 2014 Award Recipients

The FCBA Foundation is celebrating 23 years of giving back to the community. This year, we are pleased to select 20 students from eight Washington, DC public high schools for merit and need-based awards and college scholarships to be distributed over four years of matriculation. Also, as part of our law school scholarship program, we are pleased to award scholarships to five third-year law school students attending four different law schools and three Amy Zoslov scholarships to Case Western law students from the Amy Zoslov Memorial Fund transferred to our Foundation by CTIA's Wireless Foundation. Finally, we are pleased to award stipends to 18 law students from 13 law schools across the country who have accepted unpaid public service internships in communications-related agencies for the summer. 2014 COLLEGE SCHOLARSHIP PROGRAM

Under the leadership of the Foundation's college scholarship committee (**Micah Caldwell, Jennifer Holtz, and Krista Witanowski**), the Foundation reviewed applications from high school students of diverse backgrounds with an interest in communications-related fields, including media, journalism, technology, engineering, or law. Our applicants this year came from 10 local public high schools: Benjamin Banneker Academic, Cardozo Education Campus, Columbia Heights Education Campus, Duke Ellington School of the Arts, Dunbar, Friendship Collegiate Academy, Roosevelt, School Without Walls, Thurgood Marshall Academy, and Woodrow Wilson. Twenty-six of these high school student applicants were selected for interviews, and 20 emerged as FCBA Foundation scholars. Nineteen of these students will receive FCBA Foundation scholarship assistance funded over four years. One applicant has received substantial tuition assistance from other sources, and will be a Laptop Scholar. LAW SCHOOL SCHOLARSHIP PROGRAM

Sara Leibman and **Mark Schneider** coordinated the direction of the recent Foundation efforts to establish a graduate school scholarship program. In 2012, the Foundation initiated a scholarship pilot program for graduate students committed to communications law. Our first scholarship was awarded in 2012 to **Megan Coontz**, a law student at the University of Colorado at Boulder and our second scholarship was awarded to **Ashley Morse**, a law student at Catholic University. This year we ended the "pilot" nature of the program, and established two projects that resulted in scholarship awards to eight current law school students. DIRECTV Scholarship (\$16,000)

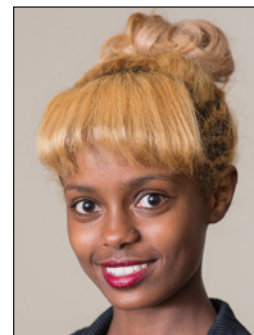
