#### **INVITING GOVERNMENT GUESTS**

Pursuant to the Office of Government Ethics regulation on widely-attended gatherings (5 C.F.R. 2635.204(g)(2)), the Chairman's Dinner appears to qualify as a widely attended gathering. The value of an individual ticket to the dinner is \$315.00. Most employees of the Federal Communications Commission may be directly invited to attend the dinner as guests of individuals and organizations purchasing tables or tickets. In most cases, individuals and organizations may issue invitations to the

Chairman's Dinner without the involvement of the FCBA. Some agencies, departments and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics. Individuals who have signed the Administration's Ethics pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. While this event has qualified as a widely-attended-

gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's Office of General Counsel. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State must be issued by the FCBA. Contact the FCBA for additional information.

Requests for invitations to be sent from the FCBA must be emailed to kerry@fcba.org by Monday, November 19. Those invitees will be placed at the discretion of the FCBA.

## ARBITRAGE-WHAT'S AT STAKE AND WHAT SHOULD THE FCC DO?

This past summer the FCC received comments in its rulemaking proceeding, WC Docket No. 18-155, that proposes to update the ICC regime by eliminating access arbitrage or financial incentives to engage in access stimulation. Access stimulation typically occurs when a local exchange carrier ("LEC") with relatively-high switched access rates enters into an arrangement to terminate calls—often in a remote area—for an entity with a high call volume operation, such as a chat line and "free" conference calls, collectively high call volume services. The competitive LECs that terminate the traffic assert that many of the tentative conclusions in the FCC's NPRM are not supported by record evidence that justifies eliminating the services and there are compelling reasons for the FCC not to take the actions it is proposing. This panel will examine the various forms of access stimulation in the marketplace, steps the FCC has taken, and explore whether the existing record supports the FCC's tentative conclusions that further ICC reforms are warranted.

## REFORMING ICC FOR 8YY CALLS AND THE IMPACTS OF DOING SO

The FCC also recently received comments in a companion rulemaking proceeding, WC Docket No. 18-156, on whether it should modify the ICC regime for telephone calls made to toll free ("8YY") numbers. The FCC sought comment on possible reforms to the ICC regime for 8YY traffic to address concerns that the current regime incentivizes (a) originating carriers and intermediate providers to artificially inflate access charges billed to the interexchange carriers that provide 8YY services, and (b) bad actors to flood 8YY numbers with robocalls. This panel will discuss how the FCC could address such issues and the impact of such ICC reforms on originating carriers and consumers.

#### New England Chapter "Regulation of Big Data" Program on September 27

The New England Chapter held its annual fall program in association with the Boston University College of Communication on September 27, 2018. Entitled "Regulation of Big Data," the program explored the legal and regulatory issues surrounding the collection, safeguarding, and use of Big Data by telecommunications companies, large edge providers (such as Amazon, Facebook, Google), and smaller providers.

The first panel featured Prof. Timothy Edgar of the Brown University Watson Institute for International and Public Affairs and Senior Attorney Ben Rossen of the Federal Trade Commission's Division of Privacy and Identity Protection, and was moderated by Co-Chair Greg Kennan. The panelists discussed the seemingly contradictory trends of deregulation in the telecommunications field and of increasing regulation and calls for more regulation of Big Data and those who collect and use it. The panel also discussed the likely fallout in the U.S. from the European General Data Protection Regulation (GDPR) resulting from multinational companies' need to implement uniform operations and

protocols over all their activities, wherever located; the FTC's activities, including a series of public hearings regarding data collection, privacy, and security; and the national security implications of mass surveillance, cybersecurity, and actual or potential access to collected data by governmental actors.

Commissioner Karen Charles Peterson of the Massachusetts Department of Telecommunications and Cable moderated the second panel with Jackie McCarthy, Assistant Vice President, CTIA (and Chapter Co-Chair); Alex Kingsbury,

Boston Globe Deputy Editor; Tim Wilkerson, General Counsel of the New England Cable and Telecommunications Association; and David Kovar, Founder and CTO of Unmanned Robotics Systems Analysis, Inc. as panelists. The wideranging discussion started with the questions what exactly is privacy, why consumers do not have a particularly good understanding of what constitutes privacy, and what are the roles of regulators and the private sector in educating them. Also discussed were the amount of effort industry was devoting to "net neutrality"

and privacy issues; how the speed and capacity of wireless broadband networks will fuel opportunities for cutting-edge industries to leverage big data, such as for self-driving cars and drones; and regulatory issues that arise as new technology is developed and utilized, including the need to distinguish for security purposes bona fide commercial drones from drones used as part of a terrorist attack.

The Chapter expresses its gratitude to retiring College of Communication Dean Tom Fiedler for his years of friendship and hospitality to the Chapter, and to reception sponsors Granite Telecommunications, Locke Lord LLP, and Verrill Dana LLP.

#### Texas Chapter CLE Program on October 24

The Texas Chapter of the FCBA hosted a one-hour program, "On the Road Again: Hot Topics in Rights-of-Way Use for Telecommunications Entities." Thirty people attended including FCBA members and members of the Texas PUC Staff.

Amy Leila (Saberian) Prueger, of the Austin law firm Enoch Kever PLLC,

served as moderator for a panel consisting of Alfred Herrera of Herrera Law & Associates PLLC; Katherine Mudge of Enoch Kever PLLC; and David Tate, Vice President and Associate General Counsel of AT&T.

Ms. Mudge and Mr. Herrera represented competing points of view concerning current litigation and Texas PUC proceedings which involve interpretation and implementation of the 2017 Texas statute governing compensation and permitting of small cell technology deployments in municipal rights-of-way, Texas Local Government Code Chapter 284. Katherine Mudge explained that this new chapter creates a separate statewide regime for "network providers" seeking to install nodes and related devices in public ROW. She pointed out that Chapter 284 specifically does not change Texas law concerning ROW use and compensation to be paid by "Certificated Telecommunications Providers (CTPs)." According to Ms. Mudge, if a company is a Texas CTP and not a network provider, then Texas Local Government Code Chapter 283 (and not Chapter 284) applies to ROW use and compensation. David Tate of AT&T noted that new Chapter 284 makes no mention of Chapter 283, and that was an intentional omission.

Alfred Herrera contended that the services and/or facilities provided by a company

should dictate whether Chapter 283 or Chapter 284 applies and that the inquiry does not end by simply concluding that an entity is a CTP. He observed that some Texas cities have developed questionnaires for applicants for ROW permitting in order to determine the applicable compensation scheme for the particular planned project. Mr. Herrera also pointed out that some certificated companies don't pay any compensation at all for ROW use by fiber optic cable not used to provision telephone access lines. Amy Prueger observed that Texas cities have different views about compensation due from companies that plan to install fiber optic cable.

After this lively debate, Ms. Mudge provided the status of the pending ExteNet case before the Texas PUC (Docket 45280). Mr. Tate provided an update on the pending litigation concerning Chapter 284 in State and Federal courts. In the brief time remaining, Katherine Mudge introduced two FCC proceedings concerning small cell technology deployment: the FCC's Third Report and Order in the Matter of Accelerating Wireless and Deployment (September 2018) and the activities of the Broadband Deployment Advisory Committee. The panel ended with discussion as to whether the Third Report and Order will preempt Chapter 284; Mr. Tate noted that Chapter 284 is state law until a court says it is preempted.
