#### **INVITING GOVERNMENT GUESTS**

Pursuant to the Office of Government Ethics regulation on widely-attended gatherings (5 C.F.R. 2635.204(g)(2)), the Chairman's Dinner appears to qualify as a widely attended gathering. The value of an individual ticket to the dinner is \$315.00. Most employees of the Federal Communications Commission may be directly invited to attend the dinner as guests of individuals and organizations purchasing tables or tickets. In most cases, individuals and organizations may issue invitations to the Chairman's Dinner without the involvement

of the FCBA. Some agencies, departments and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics. Individuals who have signed the Administration's Ethics pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. While this

event has qualified as a widelyattended-gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's Office of General Counsel. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State must be issued by the FCBA. Contact the FCBA for additional information.

Requests for invitations to be sent from the FCBA must be emailed to kerry@fcba.org by Monday, November 19. Those invitees will be placed at the discretion of the FCBA.

## Florida Chapter CLE Program on September 5

The Florida Chapter of the Federal Communications Bar Association collaborated for the first time with the Florida State University College of Law to host a program, "Telecommunications Technology and the Law – Planes, Trains and Automobiles – current Legal Developments with Drones, Internet of Things and Autonomous Vehicles."

Ron Brisé of the Gunster firm, formerly with the Florida Public Service Commission and the Florida Legislature, hosted the Internet of Things (IoT) panel. Jack Zinman, Vice President and Associate General Counsel of AT&T, described the early use of the phrase and said there is no widely accepted definition of IoT. Lauren Scholz, an Assistant Professor at FSU College of Law, described social implications, such as breaches of privacy and cybersecurity issues.

Cindy Miller moderated the autonomous vehicle panel. Representative Jason Fischer described the goals of eliminating human error and transforming mobility for Americans. He noted that currently 95% of car accidents are from human error. Chris Spencer of Gray Robinson said that the issues will be on product liability. Cybersecurity insurance will be big for autonomous vehicles. Chris Emmanuel, Director of Autonomous Florida for the Florida Chamber said that Florida already has one of the most pro-autonomous vehicle statutes on the books. Will Ourand of Newsome/ Melton said he is optimistic that "when it's ready, autonomous vehicles will save lives." He predicted questions will arise as to who is responsible when there is an accident because of the overlap between the computer and humans.

Will Cox of FPL moderated the panel on drones. Rachel Wolkowitz of Wilkinson Barker Knauer in DC said the problem in the regulatory arena is "apply old law to new technology." Nathan Trail of the



Consumer Technology Association said that since 2013, drones have saved on average one life per week. He urged that there not be a patchwork of regulations, and that hasty legislation be avoided. David Merrick of FSU Disaster Risk Policy showed a video of the use of drones after hurricanes and urged that drone operators be allowed to fly beyond the visual line of sight of the operator. Lieutenant Edwin Jacob of FSU Public Safety discussed drones on campus.

Debi Galler, General Counsel of Green Street Power Partners described the value of mindfulness. She said the definition is "paying attention in a particular way, on purpose, in the present moment and nonjudgmentally."

# Get to Know an FCBA FOUNDATION COLLEGE SCHOLARSHIP RECIPIENT

## **Lindsay Harper**

We are taking a break this month from our regularly scheduled "Get to Know an FCBA Member" column to feature a very busy young lady, Lindsay Harper. Lindsay is the 2017 FCBA Foundation Karen Kincaid \$24,000 scholarship winner sponsored by Wiley Rein and Karen's Friends. It's important that we know we have a positive impact on DC high school students through our scholarship program. And



in case you were not aware, every member of the FCBA is a member of the FCBA Foundation as well!

Every year, the Foundation reviews applications from high school students of diverse backgrounds with an interest in communications-related fields, including media, journalism, technology, engineering, or law. Last year, 39 high school student applicants were interviewed and 26 of these were chosen to receive FCBA Foundation scholarship assistance funded over four years. A total of \$300,000 was awarded thanks to our generous donors. All 39 of the applicants who attended interviews were provided new laptop computers and 26 were assigned FCBA mentors to help them advance academically and professionally.

I spoke with Lindsay during a short break in her studies to see how she is faring more than a year into her college career.

### Where are you currently enrolled and what are you studying? Do you have an internship?

A: I am currently a sophomore at Purdue University of Software Purdue University in Indiana where I am in the Purdue Polytechnic Institute. I am majoring in Cybersecurity with a minor in Organizational Leadership. In addition to my college coursework, I am an intern at Dell Technologies subsidiary called RSA's anti-fraud command center. I got this internship last January when I was a freshman and worked full time there over the summer. In that role, I detect and shut down malicious phishing websites, trojans, and other types of malware, as well as act on instances of brand abuse. Using the skills I've learned in my cybersecurity courses, I protect the data of major Dell clients. It's a very cool part time job!

## **Q:** Are you involved in other activities on campus?



I was a mentor for incoming minority freshmen entering Purdue University through a program called STEM ABC. It brings me great joy to act as a support system for these freshmen, as well as to be an academic mentor for them. I am also a member of the Women in Technology Association, a group on campus that is necessary because only 15% of the students in the Polytechnic Institute are women, and as I sit in the front row, I see other women gravitate towards the back of the classroom. This organization builds a sense of community and boosts individuals' confidence in class because they are aware of the strong support system that is available for them. Each of these organizations provides opportunities for women and minorities to support each other and take a role in helping each other build confidence and to step up.

I am also part of the Association for Information Technology Professional's club and the Minority Technology Association. When I am not in class (because school is my number one priority), active with these groups, or interning, I am most likely giving tours of Purdue University as I am a Purdue Polytechnic Institute Ambassador. I give tours of the Institute focusing on its various programs, and I also call admitted students and represent the Polytechnic Institute on "admitted and prospective students days." On the weekends, I have also volunteered with high school students that visit Purdue for academic camps to encourage them to consider Purdue as well as consider majoring in a STEM field.

## **Q:** What prompted you to apply for an FCBA Scholarship?

**A:** I was a high school senior at Woodrow Wilson High School in DC. My mother and I had a goal of trying to raise as much scholarship money as possible to be used for college as we have limited financial resources. As part of that effort, I spent many hours at the College and Career Center at Wilson researching colleges as well as scholarship opportunities. I was so pleased to find the FCBA and its Foundation and discover that it was a local organization that really wanted to get to know the scholarship applicants. I recall getting excited as I prepared to do my interview with the Foundation. The Foundation members made me feel welcome. Finding out that I got a \$24,000 scholarship from the FCBA Foundation to be paid out over four years was a huge boost to me. With tuition at Purdue topping out over \$44,000 a year, this scholarship has been a great help to me.

# **Q:** How has the FCBA Scholarship and your internship changed your outlook on education and career?

The FCBA scholarship made college less of a dream and more of a reality and I will always be grateful for that. As a senior in high school, I was concerned about what college I might be able to afford and whether it would be a good fit for my interests. In fact, I started my college search by researching the lowest out-of-state tuition at a decent school. Because of the Foundation's help, I was able to go to my dream school, Purdue, in a STEM program.

I have tried to make a positive difference at Purdue and in my internship with Dell/RSA. I started at RSA as a Junior Anti-Fraud Analyst and it was a learning experience and there was much I did not know. But I persisted and after studying for and taking a rigorous test this summer, I was promoted to Senior Anti-Fraud Analyst. During the school year, I work at RSA 12 hours a week. In the summer, I worked up to 39 hours per week.

As I have gotten more involved in cybersecurity, I realized that I want to be a bridge between the IT world and the administrative group in a company. In many cases, the two groups may not understand each other's goals. That made me think a bit more about how technology can be translated for company leadership and brought me to my minor in Organizational Leadership. There is an important crossover liaison role between the technology parts of the company and the business side that I think may be the perfect place for me.

#### What would you like the FCBA members to know about what the scholarship has meant to you?

I would really like to thank everyone who contributed to the FCBA Foundation for my gift of college. I think it's really important that the FCBA Foundation interviewers didn't just look at my transcripts and my GPA because I had a bit of a rocky freshman year in high school. I think it was really fantastic that they did a deeper dive beyond just my records to look at my passions and my potential. I will always be grateful for that.

## **Q:** What advice would you give future scholarship applicants and winners?

A: My advice would be to take the scholarship and use it to propel yourself to achieve your dreams. In other words, take every single opportunity you can to pursue your passions even if you



are not sure of the outcome. I would also say don't downplay your achievements or hide what makes you unique. It is really important that people see who you are and see what animates and excites you.

## **Q:** Is there anything else you would like to convey?

A: Mentors of all sorts have been critical to me and I am already mentoring those coming behind me. I have to say my faculty mentor at Purdue has been terrific and encouraged me to take as many opportunities I can. For example, I've been a student delegate, representing Purdue Polytechnic Institute, at several different events in Boston and Houston. During my freshman year, I also won a hackathon at the University of Maryland. My team and I placed first in Best Digital Industrial Hack and second in Best Virtual Reality Hack. I think another thing that's been really important in volunteering at high school events and STEM events is to be visible and to make sure that women and minorities understand that they will get support if they come to Purdue. I had kind of an amazing moment at a career fair on campus. Dell/RSA asked me to be one of the recruiters for Dell and I am only sophomore. Kind of amazing because last year it was me on the other side of these interviews!

Q: What's next for you?

I am now looking for a summer internship for 2019. Beyond that, while I am enjoying the Midwest, Purdue and the amazing community of people there, I have to say I miss being near the water. After college, I think I want to be located on one coast or the other. In the meantime, there's a few more years to go in college, and I am looking forward to them.
