"BUILDers" also receive extensive academic training, including classroom tutoring, free SAT and ACT prep courses, college application guidance, and financial aid support. BUILD's efforts have had a demonstrable impact on the lives of these students, with 100 percent of BUILD Metro DC seniors having graduated high school and enrolled in a college or university. The FCBA Foundation will use proceeds from the Charity Auction to support its annual scholarship program.

The Charity Auction is one of Washington, DC's premier "must-attend" events for the communications industry. The event features a live auction hosted by a professional auctioneer, silent auctions, online auction, and raffle drawings. LAST CHANCE TO RENEW YOUR MEMBERSHIP!

EVERY MEMBER MUST LOGIN TO RENEW.

- Click the Login link at www.fcba.org or go to https:// netforum.avectra.com/eWeb/DynamicPage.aspx?Site=F CBA&WebCode=LoginRequired to log into your account.
- If you do not know your password you must click on the "Forgot your Password?" link and follow the instructions to generate a new password. The system will then email you a link which you must activate to change the password. Note that the link that is emailed to you is only good for two hours from the time you request it and that it can be only used once. If more than two hours have passed or you already activated it you will have to go back and click on "Forgot your Password?" again.

The FCBA **Privacy and Data Security Committee** will hold a CLE on **Tuesday**, **September 23** from **6:00 – 8:15 p.m.** entitled Cybersecurity in Review: Public and Private Sector Perspectives on Securing our Communications Networks. This program will be held at Arnold & Porter LLP, 555 12th Street, NW.

In the wake of a number of high-profile cybersecurity events -- from the Heartbleed bug to the Target breach -- cybersecurity has become a red-hot issue in Washington, DC. On June 12, 2014, in an address delivered at the American Enterprise Institute, Federal Communications Commission ("FCC") Chairman Tom Wheeler announced a major cybersecurity initiative at the FCC to create a "new paradigm for cyber readiness" in the communications sector. The Chairman's announcement follows on the heels of a number of other important, ongoing cybersecurity initiatives within the federal government. In 2013, President Obama issued his cybersecurity Executive Order, which outlined a framework for a voluntary, incentive-based cybersecurity regime. Last year, the House passed the Cybersecurity Information Sharing and Protection Act ("CISPA"), and the Senate is currently considering a number of companion bills. On September 23, join the FCBA's Privacy and Data Security Committee to discuss these and other issues, including how the private sector addresses a rapidly evolving array of cybersecurity threats.

Results of Plenipotentiary-14, and Prospects for IANA Transition and UNGA-15." This program will be held at a location to be determined.

In December 2012, the International Telecommunication Union (ITU) held a treaty conference to revise its Telecommunication Regulations (WCIT). That conference exposed a rift between those Member States who wanted greater control over Internet Governance and those – such as the U.S. and Europe - committed to the Multistakeholder model. Subsequent surveillance-related issues underscored the importance of these issues at subsequent meetings at the ITU, at other U.N. bodies, and at various "multistakeholder" groups and meetings. In spring 2014, the Department of Commerce launched a process to transfer its remaining oversight of the "IANA" function. This kickstarted a process being coordinated by the Internet Corporation for Assigned Names and Numbers (ICANN), and initiated Congressional debate about the wisdom of this action. In addition. Internet Governance issues will be central to the quadrennial ITU Plenipotentiary Conference, held October 20 - November 7 in Korea. Finally, the U.N. General Assembly (UNGA) will address these issues in 2015.

This CLE will examine the legal and policy outcomes of the Plenipotentiary, and how any alterations to the treaty or resolutions (particularly regarding Internet Governance) could affect U.S. interests, including business. It also will review the IANA transition process to date and expected future timing. Finally, the CLE will examine how to maximize the private sector's role in UNGA's 2015 review of Internet Governance.

With its February 2012 launch in New York City, Aereo enabled its subscribers to stream broadcast TV to Internet-connected devices. The expected legal challenges followed quickly. While some succeeded, the Second Circuit ruled that the service was not a public performance, and was therefore lawful. The Supreme Court reversed on June 25, 2014, holding: "In terms of the Act's purposes, the differences [between Aereo's and cable systems' technology] do not distinguish Aereo's system from cable systems, which do perform 'publicly.' Viewed in terms of Congress' regula-tory objectives, why should any of these technological differences matter? Since the Court's decision, the lively legal and policy debates about Aereo have expanded after Aereo – taking the Court up on its view that Aereo was indistinguishable from a cable service - sought compulsory licenses from the broadcasters. Get to Know an **FCBA MEMBER**

Rick Chessen, Senior VP Law and Regulatory Policy, National Cable & Telecommunications Association (NCTA)

Rick Chessen is a happy man; he's done a

number of different things in his legal career, senior positions in government at the FCC, private practice, even Internet start-ups, each of which has led him to his current position as Senior VP, Law and Regulatory Policy at NCTA. As Rick describes it, NCTA is a happening place, and that was even before the Net Neutrality Notice hit the streets. Rick graciously made some time for a lunch with me before everyone left town for Labor Day and even while in the midst of the Net Neutrality rulemaking process. We had a wide ranging conversation about the FCC, what we are all doing in communications and just what a great and interesting group of people inhabit our space.

Q: What attracted you to the field of communications?

A: I've always been a media junkie. Since I was a kid, I've been a huge consumer of media and been fascinated by the technology that brought it to me. In the late '70s, I remember showing my friends the new Betamax my family got when they first came out. We watched Daryl Dawkins shatter the glass backboard during a dunk and then watched it again about a hundred times. It was like magic. I get that same feeling every time there's a new breakthrough - the Sony Walkman in the '70s, cable TV in the '80s, dial-up and then broadband Internet in the '90s. the introduction of the iPhone and the iPad in the 2000's. I could list dozens of others, but the point is the world of communications never stands still. The next thing that will surprise and delight us is right around the corner. I can't imagine working in another field.

Tell me about your career progression and whether things have unfolded in the manner you envisioned.

I joined the FCC when it was staffing up in the wake of the 1992 Act, starting the same week as folks like Tom Power and Steve Broeckaert. I had been working at a big Chicago law firm, and had gotten to work on some libel cases and other media issues, but jumped at the opportunity to be able to work on communications issues full-time. I spent the next 14 years at the FCC working in the Cable Services and Media Bureaus and serving as Senior Legal Advisor to Commissioners Copps and Tristani. Most recently, I joined NCTA in 2009 to lead its legal and regulatory department. In my wildest dreams, I never could have envisioned the direction my career has gone. I generally try to be open to opportunities as they arise and somehow I ended up in some pretty amazing places.

Q: What is the most challenging part of your current position and why?

Probably the breadth of the issues we cover. Cable used to just be about TV. But convergence has arrived and it's real. So now the business isn't just about video, it's about data and voice and wireless and on and on. There's almost no proceeding at the FCC in which we don't have an interest. Trying to stay on top of so many moving pieces is a challenge, but it's also what keeps things interesting and fun.

Q: What are you reading now?

A: Besides Net Neutrality comments? I tend to go non-fiction or light fiction

when I have some downtime. Right now I've got one of each going – "A Prayer for the City" about the plight of Philadelphia in the early 1990s and I'm re-reading "Leave It to Psmith" by PG Wodehouse, probably my favorite author of all time.

What surprised or impressed you most about the people you've worked with and why?

That's a tough one. I've worked with a lot of smart and talented people over the years. And that certainly goes for the permanent staff at the FCC. I think the most impressive thing about the FCC staff is how much they care about getting the right answer and doing things the right way. On the 8th floor, I was privileged to work for two Commissioners who believed in public service and lived it every day. And when Commissioner Copps was made Acting Chairman in early 2009, he somehow shifted into an even higher gear and brought the DTV transition home to a successful conclusion.

Here at NCTA, I'm lucky to have landed among another group of truly impressive colleagues. I get to work every day with a group of lawyers I'd put up against any law firm in the city. And what impresses me about the organization – and actually the broader cable industry – is how hard it works to be a constructive partner with regulators to find win-win solutions. Ultimately that's not always possible, but that's the goal.

Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

The most precious thing in the world is your reputation. FCC-land, in particular, is a very small world. You're going to see the same people again, often in different roles. Don't say anything you don't mean or you can't back up. If you say you'll do something, do it. People have long memories. Whatever shortterm benefits you think you'll get by cutting corners won't be worth it in the long run.

The other thing is to master the substance. There's always a shortage of people who really understand the details. You'll always be in demand.

What's something interesting about you that people are not generally aware of you are willing to share?

I'm a card-carrying foodie. I get seven cooking magazines. I'll drive 100 miles out of my way to taste a banana cream pie someone blogged about. We're sitting here at lunch and I'm already thinking about dinner. I come by it honestly – my mom is an amazing cook and both of my parents owned restaurants and delis. Probably not many DC types got to eat at "Delicachessen's" in downtown Minneapolis but that was my dad. **Q:** How long have you been an FCBA member and what is the value of FCBA membership?

I've been an FCBA member for over 15 years. It's a terrific organization that provides a real sense of community and connection for the communications bar. On top of that, the FCBA does so much good in the broader community. I'm honored to be serving my second stint on the Board of the FCBA Foundation, which does such a good job every year to provide assistance to students and others in need. It's something that all members of FCBA should feel very proud of.
