December 1st FCC Lab Tour Scheduled

The **Engineering and Technical Practice Committee** has arranged for a tour of the FCC Lab in Columbia, MD on Thursday, **December 1, 2005**. At the lab, participants will receive a brief overview of laboratory staffing and functions, and then see the equipment used for testing various devices that require certification, as well as used for research in support of Commission rule-making activity. This will include, of course, a

variety of devices, both intentional and unintentional radiators, subject to testing, and demonstrations of the harmful effects of noncompliant equipment. We will see a partial run and explanation of a cell phone SAR (RF safety) test and check out the FCC's new state-of-the-art (\$750,000) anechoic chamber, with an explanation of its construction and particular value/use and a typical test

SOME HIGHLIGHTS:

- The new Judicial Practice Committee, led by **Sam Feder**, **Robert Pettit**, and **John Rogovin**, launches its first CLE program this month focusing on
 - "Practical Tips for Appellate Litigation and FCC Advocacy" on November 10.
- The CLE Committee's November 29 event on "The Ongoing Debate Over the Sunshine Act" represents the bar's first in-depth look at this widely known but little understood statute, and will explore the concerns driving current reform efforts (as well as the potential obstacles to change).
- On November 30, the FCBA launches its first of several new educational lunch panel programs with "War of the Worlds," featuring four "think tank" and public interest group leaders representing diverse perspectives. Next year this series will feature luncheon panels of former FCC Chairmen, communications industry general counsels, State PUC Commissioners, and journalists who report on the industry. National Telecommunications Moot Court Competition - Call for Volunteers

The FCBA and The Catholic University Columbus School of Law will co-sponsor the 2006 National Telecommunications Moot Court Competition to be held February **3-4**. This year's competition centers on the (fictional) adoption of Federal Communications Commission rules that require cable and DBS systems to permit subscribers to purchase the service provider's family-friendly channels on a dedicated programming tier. Participating teams will analyze constitutional and administrative law issues attendant to FCC enactment of such a family-friendly programming scheme. This year's competition arises out of ongoing debates over whether cable and satellite providers should be required to offer "a la carte" channels as part of their video service packages, and out of the concerns some consumers have voiced over their perceived inability to sufficiently control the content of programming their families receive. The FCBA Moot Court Committee seeks volunteers to help prepare the problem and administer the competition. If you have expertise with these issues, or a general willingness to assist in the preparation of the problem, bench brief and related tasks, your contribution is needed. Atlanta Chapter

The Atlanta Chapter had an active and successful year in 2004-2005, beginning with a Holiday Happy Hour in December 2004, and continuing with two substantive events.

In June 2005, the Chapter held a reception hosted by Duane Morris LLP, featuring a presentation by Chris Jones, Regional Director of External Affairs, Verizon Wireless on the communications-related legislation considered in the 2005 Session of the Georgia General Assembly.

In September 2005, the Chapter sponsored a panel discussion of the business and regulatory impact of the US Supreme Court's Brand X decision. The program featured as panelists Dave Baker, Vice President, Law and Public Policy, EarthLink; Pete Martin, Vice President, Regulatory and External Affairs, BellSouth; and Chad Wachter, General Counsel, Knology. With last-minute help from BellSouth, we were able to move the venue of this program so that interested attendees could also attend the FCC's September 2005 Open Meeting which had been moved to Atlanta to assess the response of industry and government to Hurricane Katrina.

The Chapter plans to kick off the coming year with a January program to consider the findings and recommendations of Georgia's Joint House and Senate Emerging Communications Technologies Study Committee, which are expected to be published in December 2005.

The Chapter also strengthened its leadership this past year, adding two additional co-chairs, so our local lead-

ership team now includes Don Hackney, Arnall, Golden & Gregory LLP; Ron Jackson, Sapranov & Associates, P.C.; Richard Keck, Duane Morris LLP; and Michael Rosenthal, Director of Legal and External Affairs, SouthernLINC.

Cable Practice Committee

The Cable Practice Committee is cochaired by Ben Golant of the FCC's Media Bureau, Frank Buono of Willkie Farr & Gallagher LLP, and Quyen

Truong of Dow Lohnes & Albertson PLLC. Anita Wallgren of Sidley Austin Brown & Wood serves as the Executive Committee Liaison for the Committee.

We have relied upon the Committee's membership in developing our meeting agenda for this year. We started with a survey that was emailed to every Committee member asking them to rank on a scale of 1 to 10 their level of interest in a number of possible speakers and subjects for future brown bag lunches, meetings, and CLEs. We held our first organizational meeting on September 26th at Willkie Farr & Gallagher to discuss the results of the survey and other ideas. Thanks to significant input from those who returned the survey, as well as suggestions from attendees at that meeting. the Co-Chairs have a course of action for the next eight months.

Continuing a popular tradition, we plan to hold several brown bag lunches with government officials who have a significant influence on the cable and telecommunications industries, including guests from the Chairman's Office and other Commissioners' Offices, the Media Bureau, the Wireline Competition Bureau, other parts of the Commission, and Congressional staff. We also intend to host rigorous debates on policy issues such as program access and new video deployments, and to provide a forum for discussion of legislation pending before Congress that affects the media and telecommunications sectors. Finally, we are considering various possible topics for a CLE program, such as "The First Amendment and the Electronic Media" and "Top 25 Issues Every Cable Attorney Should Know About." We are open to joint sponsorship of these CLEs and meetings and will gladly participate in other Committees' educational efforts that intersect with the interests of the cable industry.

Young Lawyers Committee

The Young Lawyers Committee (YLC) is co-chaired by Jason Friedrich of Drinker Biddle & Reath LLP and Natalie Roisman of the FCC's Media Bureau. The YLC membership includes communications attorneys and other professionals under the age of 35 or with fewer than eight years of practice in communications. The YLC provides opportunities for networking, social interaction, and professional development that are tailored to those

new to the bar. Although YLC efforts generally are targeted to this population, all FCBA members are welcome at YLC events! Unlike other FCBA committees, YLC co-chairs are elected by the membership of the YLC. Elections are held in May and each co-chair serves a staggered two-year term. This ensures that the YLC has year-round continuity in its programming and outreach efforts.

Each month, the YLC hosts a brown bag luncheon focused on a substantive communications issue or career development and opportunities. The YLC draws on its membership to assist in planning and organizing these brown bag luncheons, thereby facilitating the participation of members other than the co-chairs and helping to identify future leaders of the YLC and the FCBA. Since the YLC elections in May, the YLC has hosted four brown bag lunches. The June lunch featured financial analysts explaining the impact telecommunications regulation on investors. In July, a panel of VoIP, cable, and wireless representatives joined a Hill staffer in discussing whether the information services/telecommunications services regulatory dichotomy can survive in an IP world. Like the rest of DC, the YLC took a break in August, but returned in September with a panel discussion of

cable and broadband rules governing IPTV, municipal competition, and local video regulation. In October, the YLC focused on career development, cosponsoring a luncheon with the Diversity Committee to welcome new lawyers and law students to the communications bar. Check the FCBA website and future issues of the newsletter for information on upcoming YLC brown bag luncheons.

The YLC also joins the Diversity Committee in organizing career development events for law students and young lawyers. In past years, the YLC and the Diversity Committee have co-sponsored a series of career panels at each of the area law schools, and the YLC will be involved in this effort again this year. The YLC also is working with the Diversity Committee to implement the FCBA's new mentoring initiative, which was introduced at the YLC/Diversity Committee October brown bag lunch.

This year, the YLC is working with the CLE Committee to plan Comm Law 101. This program, which will be held in early 2006, is intended to provide guidance for practitioners who are new to the communications bar. FCC Introduces New ECFS Search Refinement Tool

The FCC has responded to a concern raised by the FCBA Access to Records Committee regarding the inundation of docketed proceedings with numerous brief comment filings that make it difficult to effectively monitor FCC proceedings. The Commission has made available on the ECFS web page a tool that will enable the public to sort out many of these short text messages that have contributed significantly to the increased number of filings in docketed proceedings. The new search tool appears as a search option in ECFS at "Block 15" and is entitled "Eliminate Brief Text Comments." By checking this box, your search will exclude text messages, which will eliminate from a docket sheet any filings made through ECFS that use only the cover/comment sheet in ECFS and do not include a separate document. It is estimated, for example, that in an inundated docket containing 200,000 documents, a streamlined search using this new tool would screen out approximately 180.000 of those documents.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 pm.
