A Message from the Foundation Chair

DEAR FCBA FOUNDATION MEMBERS,

Thank you for providing substantive, and in some cases, even passionate, feedback in response to my email soliciting input about current and future Foundation student-funding programs. It is good to see the high level of interest so many of you have. This leads me to believe that we have a strong base for future leaders of, and resources for, the Foundation.

I'm pleased to announce that in response to the membership's interest in providing needs-based support across the full spectrum of students that seek our help, the Foundation Trustees decided upon three financial assistance programs. First, we are continuing to award college scholarships to senior high school students; second, we are introducing a "pilot" scholarship program for law school students; and third, we are almost doubling the number of law student internship stipends available. All of our programs seek to encourage the development of a new generation of communications and technology professionals, some of whom may even consider joining us as active members of the FCBA.

Permit me to share some details about each of the three needs-based assistance programs identified above, to which the Foundation Trustees have allocated up to \$255,000 of our total annual budget.

This year's college scholarship program yielded a record number of applications from across the greater DC metropolitan area, with more than 50 applications coming in from twelve different area high schools. In our budgeting, the

Foundation Trustees anticipated awarding \$125,000 in total scholarships. Many of you have already volunteered to either review the applications or to interview the students. The college scholarship program is administered by the Foundation's Scholarship Committee, led by **Mark Schneider** (Trustee) and **Lee Petro** (non-Trustee), and the process is well underway.

The Foundation Trustees, at our March meeting, adopted the law school scholarship program on a pilot basis. The Catholic University of America Institute of Communications Studies and the University of Colorado, School of Law (Boulder) each will have a named FCBA Foundation Scholarship of \$30,000 for one incoming first year law student. The application review process will be led by **Monica Desai** (non-Trustee) and me (Trustee), joined by other volunteers from the Bar. Much of the positive feedback you gave me about this scholarship program highlighted a number of other graduate-level institutions that might also serve as locations for such Foundation scholarships. As we gain experience and membership support for these scholarships, additional schools will be considered.

Finally, the internship stipend committee, led by **Kyle Dixon** (Trustee) and **Edgar Class** (non-Trustee) and comprised of mainly non-Trustees, has nearly finished its selection process. Following extensive outreach to FCBA members, law schools, professors, former interns and federal and state regulators, the Committee has reviewed numerous applications from law students who will serve as communications- and technology-related interns at multiple federal and state agencies. Applicants are from schools across the nation. Based on the Committee's recommendations, the Foundation expects to award up to 15 stipends of up to \$5000 each.

The Foundation anticipates a long-term FCBA engagement with all scholarship winners, and I look forward to your being able to meet (via video or in person) the FCBA Foundation financial award

recipients at the FCBA Annual Meeting.

In MEMORIAM

Peter Casciato (1952-2012)

Peter A. Casciato, one of the nation's leading telecommunications attorneys, died March 1 at the University of California San Francisco Medical Center, after a short illness. He was 59 years old. Peter was a key figure in the early telecommunications revolution of the late 1970s through the 1990s and a longstanding FCBA member. He joined the FCC after law school and emerged immediately as a rising star moving quickly from staff attorney to the general counsel's office. He was the FCC's principal attorney in the review and approval of the Gannet-Combined TV/newspaper merger resulting in the largest media merger in history at the time.

Peter was a member of the California State Bar, the Oregon State Bar, the New York State Bar and the District of Columbia Bar. He was also admitted to the U.S. Court of Appeals, Ninth Circuit, the U.S. District Court for the District of Columbia, the U.S. Court of Appeals for the District of Columbia and the United States Supreme

Court. He was named a California Super lawyer in 2011 and one of San Francisco's Best Lawyers in 2010 and 2011. Peter was also a philanthropist with a special interest in education and learning disabilities. He was one of the founding board members of the Bay School, an independent high school in San Francisco, California and an active participant with the Parents Education Network, a nonprofit organization supporting students with learning differences and ADHD. Peter also did a great deal of mentoring of young people on an individual level.



Outside of his work, Peter's interests revolved around his family, politics, history, travel and sports. He was a long-time runner who had run the Boston marathon, the Marine Corps marathon in Washington, D.C., the San Francisco marathon and the Hood to the Coast relay in Oregon. His true love, however, was baseball. He collected baseball memorabilia and was a regular

participant in the New York Yankees' Heroes in Pinstripes program for older players. He was a fierce competitor whether on the field where he played catcher or at the computer where he delighted in beating his friends and family year after year in his fantasy baseball and basketball leagues. Above all Peter cherished his family and his happiest times were spent with his wife, Regina, their children, Zachary, Sam and Victoria and the family dog, Madeleine. Peter Anthony Casciato was born October 4, 1952 in Portland, Oregon.

A memorial service was held March 25, 2012 in Portland and a second service is being planned by the family for the Bay Area this Spring. A joint reception is being hosted by the Northern California FCBA Chapter and the Conference of California Public Utility Counsel on April 19, 2012 (5:00 – 7:30 p.m.) at Chambers Eat and Drink, 601 Eddy Street (The Phoenix Hotel) in San Francisco. In lieu of flowers, the family asks that donations be made to the Sacred Heart Cathedral Prep High School in San Francisco (www.shcp.edu) or the Parents Education Network (www.parentseducationnetwork.org).
