Williamsburg is located 150 miles south of Washington, D.C. Educational and recreational activities abound, and include the following:

### **HISTORIC AREA**

(Historic reminder: from 1699 to 1780, Williamsburg was the capital of England's oldest, largest and most populous North American mainland colony, named in honor of England's King William III.) Encompassing 301 acres, Colonial Williamsburg's Historic Area portrays 18th-century Williamsburg on the eve of the American Revolution. Area sites include the Governor's Palace, the symbol of British authority in the colony; and the Capitol, the seat of colonial power and site of Virginia's vote for independence on May 15, 1776, and home to the General Assembly from 1776-79. Colonial Williamsburg also operates several museums. Williamsburg is a short trip to both Jamestown and Yorktown, the other two corners of Virginia's "historic triangle."

Seminar participants will be able to purchase a special ticket, good for the duration of the seminar, which includes access to Historic Area trade sites and museums at a special rate of \$15.00 per ticket. 

The Commission noted the opportunity for on-going dialogue and the possibility of a similar follow-up discussion on these topics in the future. The second portion of the Commission's discussion was conducted by Katie Bailey and Lynn Fabrizio who provided a status report on the pole attachment proceeding at the Commission; and sought further input from practitioners regarding the interpretation of the enabling statute. Katie noted that the record in the proceeding is robust with four rounds of comments; and that proposed draft rules are soon to be finalized. Several members of the NE FCBA Steering Committee were in attendance at the event. Special thanks to FCBA Steering Committee Members **Susan Geiger** and **Robert Munnelly**; as well as, Co-Chair **Greg Kennan**, Anne Ross, Chapter Chair of the Telecommunications, Energy and Utility Section of the New Hampshire Bar Association and the staff of the Bar Association on an informative and well orchestrated program.

The New England Chapter's collaboration with the New England Consortium of Public Utility Commissions (NECPUC) is also underway for the development of panel(s) at the Annual Symposium scheduled for the May 3-5 in Newport, Rhode Island. ### 2009 National Telecommunications Moot Court Competition

### Transactional **Practice Committee**

The FCBA's Transactional Practice Committee provides members with an active forum to analyze and discuss legal, regulatory and public policy issues that are essential for handling complex domestic and international transactional matters in the telecom industry. The Committee invites government enforcement officials, private practitioners, in-house corporate counsel, members of the financial community, and the public to share perspectives on these issues.

The Transactional Practice Committee is co-chaired by Mark W. Brennan of Hogan and Hartson LLP, Christine M. **Crowe** of Wilkinson Barker Knauer. LLP, Neil A. Dellar of the Transaction Team of the FCC, and Michael G. Jones

of Willkie Farr & Gallagher LLP. The Committee has organized a variety of events, with more ahead.

The Committee sponsored a brown bag lunch on October 8 regarding FCC merger review. Carolyn Brandon, Vice President, Policy; CTIA, Rebecca Arbogast, Principal, Stifel Nicolaus; and Coleman Bazelon, Principal, The Brattle Group, led a discussion of issues arising in the FCC's review of recent transactions, particularly transactions involving wireless telecommunications. Topics discussed included recent developments in the use of "spectrum screens" to identify local wireless markets requiring further analysis, implications of the results of recent consolidation and the 700 MHz auction upon the ability of small and rural carriers to acquire spectrum assets, the need for spectrum caps, and possible changes to the FCC's review of transactions in the new administration.

On November 12, the Committee held a brown bag lunch on post-closing issues. Todd Anderson of Constantine Cannon LLP and Lawrence Movshin of Wilkinson Barker Knauer, LLP discussed divestiture requirements, the role of management and divestiture trustees, the segregation of assets and business units, and post-closing considerations unrelated to divestitures including network and billing system integration, elimination of duplicate agreements, network assets, and employee issues.

On February 18, 2009, the Committee co-sponsored an evening CLE with the International Practice Committee regarding investing in overseas telecom markets. The CLE included two panels. On the first panel, Rebecca Arbogast; Sheba Chacko, Head of Global Operational Regulation and Americas Regulation, BT Global Services; Salomon Gruenberg, International Affairs, Verizon Business; Chris Peirce, Chief Regulatory Officer, MTS Allstream Inc.; and Ulises Pin, Partner, Bingham McCutchen LLP discussed market and regulatory factors in developing a

foreign investment strategy. On the second panel, Sean Heather, Executive Global Director, Regulatory Cooperation, U.S. Chamber of Commerce; Jim Allen, Managing Director and Head of Mergers & Acquisitions, Latin America, Morgan Stanley; Jonathan McHale, Deputy Assistant United States Trade Representative (USTR) for Telecommunications and E-Commerce Policy; and Laurie Sherman, Manager, Laura B. Sherman LLC discussed the dos and don'ts of investing in overseas telecoms markets.

The Committee held an additional evening CLE on March 12 entitled Tax 101 for Communications Attorneys. Cheryl Coe of Latham & Watkins LLP, Henry Cohn of Willkie Farr & Gallagher LLP, John Harper of Morrison & Foerster LLP and Scott McClure of Hogan & Hartson LLP discussed the tax implications of various types of transactions including stock and asset deals, S corporations, disregarded entities, tax-free reorganizations, spinoffs and splits, like-kind exchanges and the portions of transaction agreements of particular interest and import to tax counsel.

The Committee is planning a brown bag lunch for May 13 regarding representing communications companies in bankruptcy, and is planning to cosponsor a brown bag lunch in June with the Young Lawyers Committee entitled Transactions 101. Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.
