# Online Membership Renewals

## TO RENEW ONLINE BY CREDIT CARD AND MAKE A CONTRIBUTION TO THE FOUNDATION:

- Click the **Login** link at [www.fcba.org](http://www.fcba.org) or go to <https://www.netforumondemand.com/eWeb/DynamicPage.aspx?Site=FCBA&WebCode=LoginRequired> to log into your account. The primary email and password used to sign in MUST be the same as have been used for online registrations in the past, by the individual who is being renewed. If the password is not known or has never been activated, click on the **Forgot your Password?** link and follow the instructions to generate a new password.
- To view your renewal invoice, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.  
**\*\*Note:** For details on a particular order click on the small box to the left of the order #.
- Go to the **Online Store** link. Make sure **Top 100 Products** is selected in the upper, left-hand pull-down box and click the **Go** button.
- Select **FCBA Foundation Contribution – General Fund**, enter the amount, and click the **Add to Cart** button.
- Click **Check Out**. Select billing information and click **Next**.
- Check the box for the **Dues Renewal Order**. Click **Next** and follow the instructions to process your payment.

## TO RENEW BY CHECK:

If the password is not known or has never been activated, click on the **Forgot your Password?** link and follow the instructions to generate a new password.
- Once logged in, go to the **My Transactions** link. Here you can see a list of all your orders and invoices.
- Click on the small box to the left of the order/invoice # for your dues payment and print the page.
- You must include the printed invoice along with your check and mail to the address on the invoice.
- If you would like to make a tax-deductible donation to the FCBA Foundation, please send in a check with your renewal and note the contribution amount.

We have been reminded that some firms/companies prefer to pay for a **group of membership renewals** at one time with one check. In order to do this, each individual member will need to print out his/her own invoice and as with mailed dues invoices in the past, submit it for payment through their internal channels. If we receive one check for multiple renewals, a copy of each individual invoice must be included. If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

#### **PANEL I: ECPA'S WILD RIDE: 1986 TO 2010**

ECPA was enacted before the widespread adoption of the Internet and new technologies such as personal computers, email, text messaging, and mobile phones, which are now a

standard part of our lives. Since then, courts, government agencies, law enforcement and businesses have grappled with how to apply ECPA in the midst of rapid technological change. Balancing privacy rights with the needs of law enforcement in the digital world is a challenge. Our panel of experts will explore how ECPA has been implemented and interpreted over its first 15+ years and highlight coverage gaps, circuit-splits, and related issues raised by growing national security threats and the advent of new technologies and applications such as social networking, online advertising, geolocation and cloud computing – all of which suggest that the time to reform ECPA is now.

#### **PANEL II: ECPA REFORM: WHAT WE NEED MAY DEPEND ON WHERE YOU SIT**

While there is widespread consensus on the need for ECPA reform, not everyone agrees on how it should be done or on

whether it can get done. Our panel of experts will explore the proposals and prospects for legislative reform of ECPA.

## 2009-2010 FCBA Foundation Annual Report

The Federal Communications Bar Association Foundation, celebrating the 19th Anniversary of its founding, had a successful year providing charitable support for education and children's issues in furtherance of the goals set out in its Mission Statement to:

1) Support worthwhile communications-related and educational projects, as well as other community service projects, particularly those directed towards children and students, through financial contributions and through volunteer services provided by Foundation members and others.

2) Foster greater public awareness and understanding of the development of communications technology, resources and law.

The Foundation's accomplishments this year included raising about \$175,000 for the Internship and Scholarship Programs; including \$12,000 raised during the annual Charity Auction co-sponsored with the FCBA's **Young Lawyers Committee**, donating \$75,000 to **Bright Beginnings** raised during the annual Charity Auction, and numerous volunteer activities. These activities, and the Foundation's overall success, is a direct result of the generous support of individual FCBA members, as well as their firms and companies. This Annual Report summarizes the Foundation's activities during the recently completed 2009-2010 year.

### TRUSTEES

The Foundation is governed by a Board of Trustees, most of whom are elected by the FCBA membership, but which also may include persons appointed in accordance with the Foundation's By-Laws. This year's Trustees were **Kyle Dixon, Erin Dozier, Julie Kearney, Natalie Roisman, Megan Anne Stull,**

**Anita Wallgren, Jennifer Warren, and Rick Whitt.** The Foundation's officers, as elected by the Board of Trustees, were: **Stacy Fuller**, Chair; **Mike Altschul**, Treasurer; **Jamie Hedlund**, Assistant Treasurer; **Celia Nogales**, Co-Secretary; and **Henry Rivera**, Co-Secretary.

Three non-Board members worked extensively with the Board as co-chairs of the Volunteer Services Committee, **Joanna Georgatsos, Howard Weiss, and Tom Van Wazer.** The FCBA's Executive Director **Stan Zenor**, Director of Member Services **Kerry Loughney**, and **Wendy Parish** provided invaluable support to the Foundation.

### SCHOLARSHIP PROGRAM

The Foundation's scholarship program, the **Chairman Robert E. Lee Scholarship Fund**, is its most significant undertaking, both in terms of the funds awarded and in the amount of time required to administer the program. The scholarships and the laptops awarded to the scholarship recipients have the Foundation committing approximately \$140,000 to this year's scholarship program, helping these very deserving students.

Information and biographies of the scholarship recipients appear on page 14 of this issue of the FCBA News.

The scholarships are awarded based on a number of different criteria, including the student's predicted ability to succeed in college, past academic performance, participation in school activities, school attendance, service to the community, financial need, and other relevant factors that may apply to each individual applicant. The scholarship applicants are reviewed on the basis of a written application (including biographical information, academic performance and an essay) and a personal interview with members of the Foundation's Board of Trustees and other FCBA volunteers.

**Jamie Hedlund, Jennifer Warren, and Rick Whitt** served as the Foundation's Scholarship Committee Co-Chairs, overseeing the entire program. **Erin Dozier** also provided invaluable support to the program. The Foundation received applications from high school students of diverse backgrounds from Bell Multicultural, Cardozo, McKinley Tech, Theodore Roosevelt, and Thurgood Marshall High Schools in the District of Columbia. Twelve of these high school students were then selected for interviews, and 11 emerged as the strongest applicants. Nine of these students were awarded scholarships; two, as they received full scholarships from their colleges, are being assigned mentors in recognition of their qualifications. The scholarships (funded over four years) will assist these nine students as they move forward in their educational careers. In addition, all 11 of the winners will be awarded a laptop computer to assist with their studies and will be assigned mentors to help them advance academically and professionally.

The Foundation thanks **Lisa Fowlkes, Sarah Jameson, Erin Kim, Nancy Murphy, and Anisa Latif** for serving as the Scholarship Committee's liaisons to each of the participating D.C. public high schools in 2009-2010. The Foundation also continued its mentoring program of soliciting FCBA members interested in serving as a mentor to a scholarship recipient. **Jennifer Holtz** coordinated this program again this year. The mentors are available to help support the students in their transition to college. This is an important component of the scholarship program, as most of the scholarship recipients lack family members or other people to whom they can turn who have gone through the college experience to provide advice and assistance. At year-end, the Foundation's Board approved an event where the scholarship recipients, their mentors, and several Foundation Board members attended the June 29 Washington Mystics basketball game. Thanks to the **National Association of Broadcasters**, who donated tickets to their Executive Suite at the Verizon Center for the Foundation to host this event.

## INTERNSHIP PROGRAM

The Foundation's internship program awards stipends from the **Chairman Robert E. Lee Scholarship Fund** to law students serving in unpaid communications-related legal summer internships. The Foundation made awards to seven students, totaling \$35,600. The base amount of each stipend is \$5,000, which is intended to help defray the student's expenses during the internship. One student is

selected to receive an additional \$600 **Max Paglin Award**, in honor of the former FCBA member, FCC General Counsel and Executive Director, and founder of the Golden Jubilee Commission on Telecommunications. This year's recipients are:

**Joseph Ahlers**, of the University of Wisconsin, who will be working at the FCC in the Media Bureau, Industry Analysis Division; **Mitchell Calhoun**, of George Mason University School of Law, who will be working at the FCC in the Wireline Competition Bureau, Telecommunications Access Policy Division; **Henry Lawson Greenidge**, of the University of Baltimore School of Law, who will be working at the FCC in the Office of the Commissioner Meredith Attwell Baker; **Anne Halsey**, of Washington and Lee University School of Law, who will be working for Public Knowledge; **Yasemin Kasim**, of Georgetown University Law Center, who will be working at the FCC in the Enforcement Bureau, Hearing and Investigations Division; **Ari Moskowitz**, of the George Washington University Law School, who will be working at NTIA in the Office of Policy Analysis and Development; and **Fabiola Isabel Rivas**, of American University Washington College of Law, who will be working at the Broadcasting Board of Governors.

**Julie Kearney** and **Megan Anne Stull** chaired the internship program. This included coordinating the distribution of notices of the Foundation's Internship Program to law schools throughout the country (a copy of the application also is posted on the Foundation's website), and then coordinating the review of the 37 applications submitted. A group of Foundation Trustees reviewed the applications, evaluating the applicants' financial need, academic achievements, community service, and the relationship of their proposed internship to communications law.

## CHARITY AUCTION

Founded in 1991, Bright Beginnings (<http://www.brightbeginningsinc.org>) is a DC-based non-profit organization that provides free, full-day, year-round developmental care to infants, toddlers, and preschoolers whose families live in shelters and transitional housing. Bright Beginnings will use proceeds from the Charity Auction towards opening a second center east of the Anacostia River so it may serve more homeless children and families.

## FOUNDATION VOLUNTEER OF THE YEAR

At the FCBA's annual meeting and luncheon on June 30, the Foundation recognized **Jim Coltharp** as its Volunteer of the Year. Jim Coltharp and Comcast Corporation have donated their time and resources to us year after year in producing the video highlighting our scholarship and internship stipend award winners. Through this video, we are able to demonstrate the impact the Foundation has on the lives of those who are participating in our programs, a story we wouldn't be able to tell so vividly without their help.

## FUNDRAISING

The Foundation could not maintain or increase the level of services it provides without the funds needed to do so. The Board of Trustees remained committed to funding scholarships and internships using funds raised during the current year rather than drawing on the Foundation's reserves. At the same time, the Board hoped to further build the Foundation's reserves towards eventually reaching a level at which income from the reserves is sufficient to help fund the Foundation's on-going work. Fundraising is, therefore, a critical element to the Foundation's ability to fulfill its mission. **Erin Dozier** and **Natalie Roisman** co-chaired the Foundation's Fundraising Committee, taking the lead in what was a very successful year for donations, particularly for the **Robert E. Lee Scholarship Fund**. Special thanks go to the following

## McKenna's Wagon Seeking Volunteers for August 22

McKenna's Wagon is a mobile soup and sandwich wagon that goes "on location" to deliver food to the needy. For those who have volunteered, it has been a wonderful experience and a great way to help the needy in the D.C. community. This is an especially good experience for the teens and pre-

teens among us who do not have a full appreciation of the many privileges they enjoy. Community service credits are also available.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at 4:45 pm in comfortable clothes and shoes. Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available.

Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.

### FCBA Foundation Awards 9 College Scholarships and 7 Internship Stipends

The FCBA Foundation, celebrating its 19th Anniversary, is pleased to announce that it has awarded nine college scholarships to graduating seniors from five District of Columbia high schools and seven stipends to law students who accepted unpaid communications-related legal summer internships.

Thanks to the generosity of FCBA member companies and law firms, as well as FCBA members, the Foundation raised about \$175,000 for the Internship and Scholarship Programs. In addition to direct donations, funds for the Programs also are raised through the annual Chairman's Dinner, Golf Tournament, and Raffle at the Annual Seminar.

The Foundation received 37 applications from law schools across the country and seven students were selected to receive a stipend in the amount of \$5,000 to help defray his or her expenses during their summer internship. In addition, the Foundation selected one student to receive the Max Paglin Award, representing an additional stipend of \$600. The Foundation also received applications from high school students of diverse backgrounds from Bell Multicultural, Cardozo, McKinley Tech, Theodore Roosevelt, and Thurgood Marshall High Schools in the District of Columbia. Twelve of these high school students were then selected for interviews, and 11 emerged as the strongest applicants. Nine of these students were awarded scholarships; two, as they received full scholarships from their colleges, are being assigned mentors in recognition of their qualifications. The scholarships (funded over four years) will assist these nine students as they move forward in their educational careers. In addition, all 11 of the winners will be awarded a laptop computer to assist with their studies and will be assigned mentors to help them advance academically and professionally. 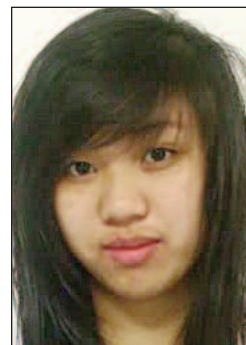

### Leonard S. Joyce (1931-2010)

Leonard S. Joyce, a communications law practitioner and resident of the Washington area, died on April 11, 2010 in Los Angeles from congestive heart failure. He was 78.

Described by his long-time partner as a “lawyer’s lawyer” who tried cases, worked on transactions, and did whatever the clients needed to be done, Joyce specialized in the representation of radio and television stations before the FCC. His career extended over five decades, from the 1960s until his retirement in 2002. During much of that time, Leonard was in partnership with George R. Borsari, Jr. Borsari recalls that it was a “true partnership,” with only a one-page partners’ agreement that basically provided for the partners to agree on all matters, which Borsari recalls they did. “Our clients didn’t belong to us individually,” Borsari remembers, “but rather to the partnership.”

Born in Scranton, Pennsylvania, Joyce grew up in Pottsville, Pennsylvania, where he was a high-school basketball stand-out. He graduated from Georgetown University in 1953 and received his law degree from Georgetown’s law school two years later. He served in the Army for three years after law school and then worked at the FCC for three years.

In 1962, Joyce joined the existing law practice of Harry Daly, and a few years later Borsari arrived to form the communications law firm of Daly, Joyce & Borsari. Joyce and Borsari continued to practice together until 1985. Joyce subsequently formed the law firm of Blair, Joyce & Silva with Forbes Blair and William D. Silva, with whom he practiced for a number of years. He concluded his legal career as a solo practitioner.

Among Joyce’s clients were a former president of the National Association of Broadcasters and a number of broadcast stations in Kentucky. Joyce owned a radio station in Kentucky and was

named a “Kentucky Colonel” by the state’s governor. A former colleague describes Joyce as “Irish to the core.” Another recalls him as big-hearted, passionate, fond of singing, hard-working, and somewhat technologically challenged (he clung to dictation when the legal world had moved to word processing).

An avid golfer and devoted family man, Joyce resided in Bethesda and attended Our Lady of Mercy Catholic Church in Potomac. He socialized with other communications lawyers, often lunching at “Mr. Day’s” in the vicinity of the FCC’s former headquarters at 19th and M Streets, N.W.

He is survived by his wife of 53 years, Mary Jo McQuail Joyce, four children – Stephanie Farrell of Bethesda, Tricia Joyce Burriss and L. Stephen Joyce, Jr., both of New York, and Mae Rhoten of Los Angeles – and ten grandchildren.
