Most employees of the Federal Communications Commission and the Commerce Department may be directly invited to attend the dinner as guests of individuals and organizations purchasing tables or tickets. In most cases, individuals and organizations may issue

invitations to the Chairman's Dinner without the involvement of the FCBA. Some agencies and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics.

Midwest Chapter

The Midwest FCBA Chapter held a meeting at Motorola's Chicago Offices, 233 North Michigan Avenue, 8th Floor, Chicago, IL 60601 at Noon on Friday, November 20. The speaker was Lawrence E. Strickling, Assistant Secretary for Communications and Information at the NTIA (National Telecommunications and Information Administration). Mr. Strickling is an appointee of President Obama and was confirmed on June 25, 2009 by the United States Senate as the Assistant Secretary for Communications and Information at the Department of Commerce. In this role, Mr. Strickling

serves the NTIA and is principally responsible for advising the President and the White House on communications and information policies, managing the Federal use of electromagnetic spectrum, performing cutting-edge telecommunications research and engineering, formulating and advocating for U.S. positions on international communications and information technology policy matters, and administering infrastructure and public telecommunications facilities grants.

This was a lunch meeting and was sponsored by Hank Kelly of the Kelley Drye & Warren Law Firm. CLE Credit was available for the meeting.

New England Chapter

On November 10th, the New England Chapter hosted a "Meet the New Regulators" program at the Hartford, Connecticut offices of the law firm, Robinson & Cole LLP. Commissioner Anthony Palermino of the Connecticut Department of Public Utility Control served as moderator for the panel, which included Chairman Kevin DelGobbo and Commissioner Amalia Bzdyra of Connecticut, and Commissioner Geoffrey Why of the Massachusetts Department of Telecommunications and Cable. The three commissioners engaged in a wide-ranging discussion about their initial impressions, goals, and challenges they foresee as they embark on their new roles.

Each of the Commissioners stated how impressed they have been with the commitment and quality of their respective staffs. Commissioner Why observed that there are special challenges as the single commissioner in Massachusetts, which means that he engages in a regular dialogue with staff and particularly relies on their varying perspectives. Commissioner DelGobbo noted the personnel changes that have

resulted from the Connecticut economy (e.g., early retirement incentive). Nevertheless, citing the quality of his staff, he believes they can do the job with the current staff level. He invited recommendations from those in attendance as to ways the agency can improve. In this regard, Commissioner Bzdrya offered that she has taken on the role of identifying ways to train staff on best practices (decision writing, interrogatories, etc.), and invited suggestions from those who practice before the agency.

The commissioners all agreed that enhanced competition for video and telephony services will play a critical role in the continued evolution of the communications landscape. Agility and regulatory openness are imperative. That said, they offered that the role of the states is evolving. They also agreed that the ability to converse with the various stakeholders will remain important. The commissioners cited favorably their discussions with company representatives from all sectors, as well as their counterparts

from other states through the New England Conference of Public Utility Commissioners and NARUC.

The New England Chapter is grateful to the commissioners for their participation and to Robinson and Cole for its hospitality.

Broadband Committee

The Ad Hoc Broadband Committee, chaired by **Barry Ohlson** of Wilkinson Barker Knauer, LLP, and **Nancy Victory** of Wiley Rein LLP, was formed this year to provide a special FCBA focus on broadband issues. Given this mandate, the Committee held a very successful CLE on Thursday, October 29, that was entitled *Broadband: How the Pieces Fit Together*. The event included keynotes by Blair Levin, Executive Director, Omnibus Broadband Initiative, FCC, and Tom Power, Chief of Staff, National Telecommunications and Information Administration. In three other panels a number of leading voices from government, industry, academia, and the non-profit community discussed the policy and legal issues raised by (1) the FCC's National Broadband Plan; (2) FCC and NTIA broadband mapping and data collection efforts; and (3) the role of government funding in achieving broadband goals, particularly the BTOP and BIP programs. The Broadband Committee hopes to hold a second event in 2010 and already has begun to work with other FCBA committees on promoting broadband-related programs.

The Governor's talk was followed by a panel of representatives from the state Public Utilities Commission, the Public Advocate's office, the Connect ME program, and FairPoint Communications. The panelists discussed their respective interests, needs and concerns in relation to stimulus funds and disbursement priorities in the state and region.

In addition, the Chapter held a "Meet the New Regulators" program in Hartford, Connecticut on November 10th. Connecticut Commissioner Anthony Palermino moderated a lively discussion among Chairman Kevin DelGobbo and Commissioner Amalia Bzdyra of Connecticut and Commissioner Geoffrey Why of Massachusetts. The Commissioners spoke of their expectations and aspirations as new Commissioners, the challenges they face, and how they will address those challenges.

In addition to being interesting and informative, these two programs have helped the Chapter in its continuing efforts to be truly New England-wide in scope.

The Chapter currently is planning for a January 26, 2010 event co-sponsored with the Boston University College of Communication, to be held at Boston University, concerning developments in broadband regulation and policy, and, more specifically, what regulation will look like after the National Broadband Plan. We have every reason to think that this program will surpass our co-sponsored November 2008 post-election program. Individuals who have signed the Administration's Ethics pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State

must be issued by the FCBA. Contact the FCBA for additional information. While this event has been cleared by the Office of the General Counsel in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain

individual ethics clearance through the Department's Office of General Counsel. **Requests for invitations to be sent from the FCBA must be emailed to Stan Zenor (stan@fcba.org) and received by Monday, December 7, 2009.** Contact the FCBA for additional information.

On December 10-11, at The Washington Hilton Hotel, the FCBA and the Practising Law Institute will co-sponsor their 27th Annual Institute on Telecommunications Policy and Regulation. 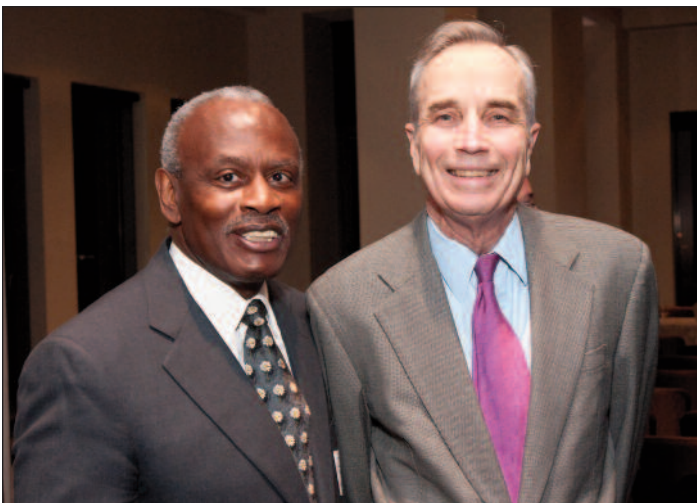

Katrina Renouf 1938-2009

Long-time communications lawyer Katrina Renouf died on September 4 at age 70 after a short illness. The founding partner of Renouf & Polivy, she specialized in broadcast litigation and regulatory affairs for over 40 years.

Katrina was proud to say she was born in New York City, despite the fact that at the age of one week the family moved to a 1,000 acre farm in Belchertown, MA. She was raised on a working dairy farm and attended a one-room school house. Leaving the farm for high school, she attended the Emma Willard School in Albany, NY, from which she graduated in 1956. She then attended Vassar College (B.A. 1960) followed by Harvard Law School (J.D. 1963).

At Harvard, Katrina became the first woman to reach the oral argument finals in the prestigious moot court competition. That competition also became Katrina's introduction to communications law and the Federal Communications Commission. The subject of the moot court competition was an FCC license renewal proceeding involving a South Carolina radio station, a case in which the FCC denied renewal of license because of the broadcast of off-color jokes by a station DJ. As in the real life case, Katrina's side lost (Hon. Byron White, presiding). Nevertheless, the experience led to an interest in broadcast regulation and a position at the FCC.

Katrina's career at the FCC started in 1964 at the Review Board, where she worked for four years before moving to the Litigation Division of the General Counsel's Office. There she represented the Commission in appellate litigation until 1971. During her tenure at the Litigation Division, Katrina started an index of all appellate decisions involving the FCC, a compilation she continued throughout her legal career and an invaluable tool to the lawyers of Renouf & Polivy.

Renouf & Polivy specialized in broadcast policy and licensing proceedings. Katrina was lead counsel on briefs representing, inter alia, the United Church of Christ, Office of Communications in the Jackson, Mississippi, proceeding, the National Association of Independent Television Producers and Distributors in the numerous Prime Time Access Rule proceedings and appeals, and Rainbow Broadcasting Company in the successful defense of the minority preference in comparative licensing proceedings in the United States Supreme Court (*Metro Broadcasting v. FCC*).

When she left the FCC in 1971, Katrina used her accumulated retirement money to buy a farm near Charlottesville, VA. It was there that she rekindled her love of animals and outdoor life. Despite suffering from rheumatoid arthritis for more than a decade, she remained a talented and avid gardener. Katrina is survived by her sister, Anne Renouf, and her long-time friend and law partner Margot Polivy.

Peter A. Rohrbach 1953-2009

Long-time communications attorney and FCBA member Peter Rohrbach died on October 25, 2009 in Baltimore, Maryland, at age 56 of complications from lymphoma.

Peter was born in Hartford, Connecticut, to a family descended from William Brewster, preacher on the Mayflower and the first religious leader of the Plymouth colony. He graduated from the Philips Exeter Academy and from Yale College, *magna cum laude*, in 1975. After a year working at the National Endowment for the Humanities, he attended Stanford Law School and was senior note editor of the *Law Review*.

Upon graduation from Stanford Law School in 1979, Peter began his long career in the Washington, D.C. office of Hogan & Hartson LLP. During his 30 years there, Peter was particularly

recognized for his work in telecommunications, with an emphasis in the wireline industry, satellite communications, and information services. He was also recognized for his experience handling broadcast and new media matters.

Peter's many accomplishments included handling major telecommunications mergers and related regulatory approvals at the federal and state levels, as well as achieving successful results in numerous complex regulatory and litigation matters. He taught law school seminars and frequently spoke on telecommunications policy matters at industry events, including FCBA seminars.

Peter also was an important member of Hogan & Hartson's management team. He had been Co-Director of the firm's Communications Practice Group since 1998. He also served two terms on Hogan's Executive Committee, and had been named firm-wide Managing Partner-Practice Management shortly before being diagnosed with cancer.

According to Peter's colleagues, he will be remembered as a kind and generous man whose thoughtful, unpretentious manner belied the depth of his convictions and passions. He was devoted to his family, had a deep appreciation for culture, and loved travel and the outdoors. His experience climbing Mount Kilimanjaro with his son in 2007 served as an inspiration throughout his battle with cancer. He also drew great satisfaction from his work as a volunteer teacher with the outreach program of Thurgood Marshall Academy, a successful D.C. public charter school.

Survivors include his wife, Linda Rohrbach, and their sons James and Andrew.
