A key component of the FCC's National Broadband Plan is to recapture spectrum that is presently allocated to other users, possibly through the use of incentive auctions. This event will focus on the controversy generated by the DCMA since its passage in 1998. Both the anti-circumvention provision – Section 1201 – and the ISP safe harbor provision – Section 512 – have been the subject of intense criticism and litigation. Critics of Section 1201 complain the law prevents users from legitimately using and copying content, while supporters believe it works to ameliorate unauthorized use of their copyrighted material. Also, the Circuits have conflicting views of the scope of 1201. Critics of Section 512 believe the recent *Viacom v. Google* decision has stripped content owners of protection against rampant unauthorized copying and distribution of their copyrighted content, while supporters believe it fosters innovation and growth of the Internet and that ISPs could not operate without Section 512's protection as interpreted by the court.

“privacy by design” in new applications and increased transparency regarding internet and other privacy policies so as to ensure customer choice.

The second half of the program was a panel discussion among Deborah Hurley, Chair of the Board of Directors of the Electronic Privacy Information Center (EPIC); Mike Spinney, Senior Analyst with the Ponemon Institute; Scott Schafer, Chief of the Public Protection Bureau of Massachusetts Attorney General's Office; and chaired by Rob Munnelly of Murtha Cullina. Among the topics discussed were: a framework for privacy policy analysis; the remarkable harmony in

privacy law in different nations; ensuring fair and appropriate use of collected personal information; and the analytical process that the Attorney General's Office employs in deciding whether to bring an enforcement action under Massachusetts' far-reaching data privacy regulation.

### Mass Media Committee

FCBA Mass Media Committee members are engaged and turnout has been strong for each Committee event. The first of the two planned CLEs for this year, *Watch this (White) Space: Regulatory Developments and Unlicensed Operations in the Television Broadcast Band*, came on the heels of the FCC's release of an order addressing operation of unlicensed devices in the television broadcast band. There was substantive discussion and lively debate over the legal, policy, technical/engineering and marketplace implications of the FCC's decision. On May 5, the Committee will return to the Newseum from 1:00 – 5:00 p.m. for the First Amendment CLE. The FCC's anticipated Future of Media Report and recent developments on the indecency front, among other things, promise to make our annual examination of media and the state of the First Amendment timely and interesting.

Our monthly brown bag lunches are always popular and this year has been no exception. In the heart of campaign ad buying season, September featured some candid advice from the FCC's political gurus, Bobby Baker and Hope Cooper. Later in the fall, we teamed with the Video Programming and Distribution Committee for two lunch sessions, the first with Media Bureau Chief Bill Lake and members of his staff, and the second with the 8th Floor Media Advisors. In December, the NAB's Dennis Wharton moderated a discussion featuring unique perspectives from media/technology reporters with *The Wall Street Journal*, *The Washington Post* and *Politico*.

We hit the ground running in 2011. Based on input from members of the bar, our first brown bag focused on the foreign ownership rules, how to structure broadcast deals involving foreign investors, and the practical and policy implications of current prohibitions, including on access to capital for minority participants and national security. Upcoming brown bags will feature members of the FCC's

### FCBA Foundation Now Accepting Applications for Funding of Unpaid Legal Internships

For the 18th consecutive year, the Federal Communications Bar Association (FCBA) Foundation will award stipends to law students from its Chairman Robert E. Lee Scholarship and Internship Fund. In 2011, the Foundation will award several stipends to law students employed as unpaid summer interns in positions with the FCC and other government agencies or entities with a connection to the communications industry. Applicants will be selected on the basis of: (1) a demonstrated interest in the communications field, (2) having secured or having pending, an unpaid summer position (internship) for at least eight weeks in communications with a government agency or entities with a connection to the communications industry, (3) dependence on financial assistance in order to accept the unpaid internship in a government agency or entity involved in communications; and, (4) community activities. To the extent a recipient receives unanticipated funding for the unpaid internship, the FCBA Foundation’s general policy is to reduce its scholarship awards by any amount that a recipient’s total funding (including all sources) for the internship would otherwise exceed \$7,000.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at **4:45 p.m.** in comfortable clothes and shoes. Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available.

Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.

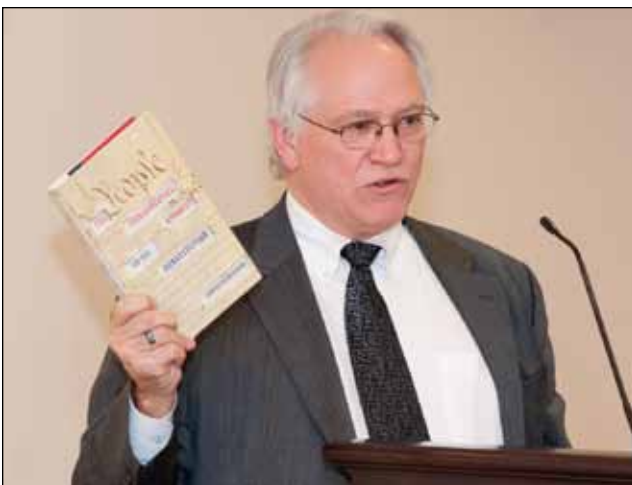

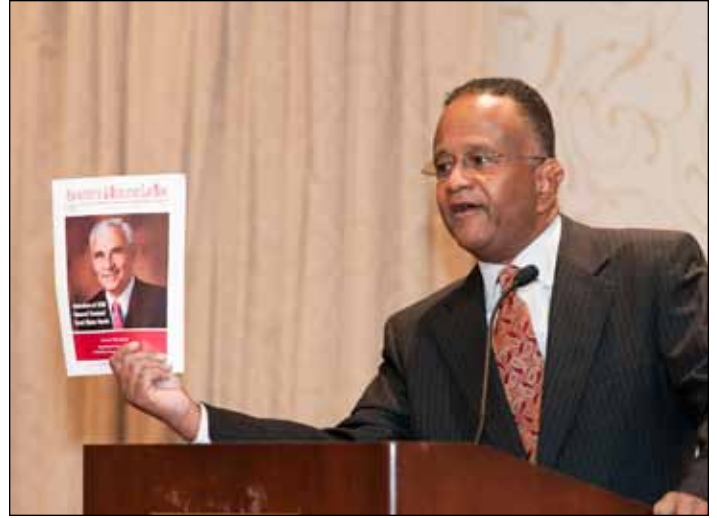
