PRESIDENT'S Message

DEAR MEMBERS:

The inaugural week has concluded, and with it, Washington is back to work (if it ever really stopped). In our part of DC, we have a new FCC Chairman, a revised Commission, and the anticipation of more change in the air. Already acting Chairman Copps has publicly announced his desire for new FCC initiatives in several areas, and Commissioner McDowell already publicly has responded with his own suggestions for cooperative change. Indeed, by the time you read this



message, Commissioner McDowell, with Chairman Copps in attendance, will have addressed these topics before the FCBA at our February 2 luncheon. And this is before we acknowledge the rumors of new nominations, staff changes or Congressional initiatives.

On occasion, I am reminded that one of the FCBA's central purposes (in Article II of its Constitution) is "to promote . . . fairness and efficiency in the development and application of communications law and policy at all levels of government" as well as "excellence and integrity in the profession." On those occasions, I am often asked how we accomplish these goals, or just as likely, to help achieve them in a particular way. I hope that the next five months will serve as a reminder that the FCBA can facilitate positive debate, change and improvement, even given certain limitations that our Association must recognize.

Of course, FCBA members know that active committee work is the best way to contribute in this area on a regular basis. Our committees have conducted, and will continue to schedule, regular meetings and CLE programs that educate our members and foster debate on controversial issues of communications law. In working on these regular monthly luncheons and CLE programs (of which we will have more than a dozen over the course of the next four to five months), I always have been proud that our bar members recognize that, with respect to perspective and policy orientation, in addition to a number of other areas, we are an incredibly diverse group; we will not, as an association, attempt to advocate the views of any one sector of our bar against the views of another. We strive to provide the forum for the best discussions of these issues, and rely on the debate to fulfill the goals we set for ourselves in our Constitution.

With that in mind, I hope many of you were able to attend our February 2 luncheon, and listen to Commissioner McDowell, or otherwise gain access to his remarks before the FCBA. I also call to your attention our all-day event on **Tuesday**, February 24, "The Communications Act and the FCC at 75: What Will the Future Bring?" The program will feature the highest level and quality of speakers focusing on key policies of FCC decision-making and anticipated crucial issues for Commission attention as we enter a new era. As I indicated last month, the program is designed to provide a sophisticated analysis of key legal issues and a stimulating discussion of the policy issues for the new Congress and FCC. And our Annual Seminar Committee already is at work planning a program for May 1-3 in Williamsburg that will follow up on the issues discussed at the February 24 event, as the FCC itself advances through the stages of these new days.

Several other FCBA programs are under way. After consultation of the Executive Committee, we have asked the co-chairs of our "Access to Records" Committee (Chris Bjornson, Michelle Cohen, Eric Einhorn and David LaFuria) to lead an FCBA effort to contribute positive recommendations to the new FCC regarding the public's interaction with the FCC, including its website and other methods of CONTINUED ON PAGE 7 ▶

FCBA Foundation Now Accepting Applications for Funding of Unpaid Legal Internships at Government Agencies

For the sixteenth consecutive year, the Federal Communications Bar Association (FCBA) Foundation will award stipends to law students from its Chairman Robert E. Lee Scholarship and Internship Fund. In 2009, the Foundation will award at least five \$5,000 stipends to law students employed as unpaid summer interns in positions with the FCC and other government agencies or entities with a connection to the communications industry (i.e., broadcasting, cable television, telephony, satellite, wireless, and information technology).

In addition, the Foundation will select one outstanding intern among those chosen to receive an additional stipend of \$600 for the summer—the "Max Paglin Award." Mr. Paglin was the former General Counsel and Executive Director of the FCC, and the founder of the Golden Jubilee Commission on Telecommunications, which compiled a definitive legislative history of the Communications Act.

Applicants will be selected on the basis of: (1) a demonstrated interest in the communications field, (2) having secured or having pending, an unpaid summer position (internship) for at least 8 weeks in communications with a government agency, (3) dependence on financial assistance in order to accept the unpaid internship in a government agency or entity involved in communications; and, (4) community activities. To the extent a recipient receives unanticipated funding for the unpaid internship, the FCBA Foundation's general policy is to reduce its scholarship awards by any amount

that a recipient's total funding (including all sources) for the internship would otherwise exceed \$7,000

Applications for a Lee Fund scholarship should be submitted to Kerry Loughney, FCBA Foundation, 1020 19th Street, N.W., Suite 325, Washington, D.C. 20036, by **Friday, March 6, 2009**. Applicants may be asked to interview with members of the Foundation Board; interviews may be conducted by telephone. Winners will be notified by Friday, April 17, 2009.

McKenna's Wagon is a mobile soup and sandwich wagon that goes "on location" to deliver food to the needy. For those who have volunteered, it has been a wonderful experience and a great way to help the needy in the D.C. community. This is an especially good experience for the teens and pre-teens among us who do not have a full appreciation of the many privileges they enjoy. Community service credits are also available.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at **4:45 p.m.** in comfortable clothes and shoes.

Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available.

Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food

distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. interacting with the public. As part of this effort, the committee, which really will be expanding its mandate to cover all interactions with the FCC beyond the simple access to records, will be contacting the other substantive committees of the FCBA to arrange for time at monthly meetings, or in other manners, to obtain input in this task. We also will include our FCC members in this effort as best we can.

The FCBA also has been contacted by the GAO with a request to provide input on the GAO's review of the FCC's data and information collection and dissemination. Rather than presume to present the views of the FCBA, we are attempting to arrange several ways in which we can facilitate the presentation of the views of our members to the GAO. Look for the announcement of our arrangements, hopefully in the near future.

Finally, as the FCC undergoes and implements change, we hope to respond not only with monthly committee luncheons and CLEs on the topics, but receptions and association-wide events

that permit active individual and group discussion of the issues. While I will do my best to initiate these events, I have no illusions and recognize that our events will only be as successful as our members' participation. But after more than 25 years of working with all of you, and specifically your Executive Committee members and Committee Co-chairs, I have great faith that our members' excellence and integrity will be demonstrated not only by the contributions I detailed in the last issue to our neighboring community

(through the Foundation and Young Lawyers), but to the development and application of communications law as well. While there has been some derisive attention to the influence of "Washington insiders" on policy made here in our Nation's capitol, I know that there is no group that is collectively more aware and responsible in the consideration of communications regulatory law as it is administered by the FCC than our FCBA members.

taken a number of steps suggesting that the law governing software patents is still very much in flux. In terms of the scope of patent law's reach (Bilski) to applicable remedies (Ebay), the courts have taken seriously concerns about the state of the patent system and its impact on innovation the software and information technology sectors. At the same time, Congress—spurred by a coalition of IT firms—has considered a number of reform measures geared to address concerns that the patent system is rewarding bad patents and encouraging inefficient litigation.

In this conference, we will evaluate both the premises underlying the call for a fundamental reform—and, indeed, the possible abolishment of—software patents as well as some specific suggestions for changing how patents are granted and how patent litigation operates. In particular, we will evaluate whether software patents should exist at all, whether patent litigation serves a constructive role in facilitating innovation and commercialization of new technologies, and whether patents play an important role in spurring the development of new technologies and enabling start-up firms to attract financing. It will conclude with a roundtable of three leading commentators on the role of patents and innovation.


