Byron Harrison

Byron Harrison, an administrative law judge with the FCC from 1972 until 1986, died at his home in Frederick, Maryland on February 6. The cause of death was pulmonary fibrosis. He was 88.

Judge Harrison was a native Washingtonian. He grew up in the Dupont Circle area and graduated from McKinley Technology High School in 1939. He was in the Army Air Corps during World War II, serving first in Ireland and England. His unit was moved to Normandy shortly after D-Day and later participated in the Battle of the Bulge.

After the war he entered George Washington University, and graduated from its law school in 1951. Byron went to work first for the U.S. Postal Service and later was in private practice before returning to the government, first with the Federal Power Commission and then with the FCC. He was appointed an administrative law judge and assigned to the FCC in 1972.

Judge Harrison presided over nearly 40 hearings during his career. Most were comparative hearings for new FM or TV construction permits, but he heard comparative renewal challenges as well. He also presided over some of the first round of cellular cases, which were decided then on the basis of comparative criteria. Among his more noteworthy cases were those involving renewal applications for the Gross Telecasting stations in Lansing, Michigan; the RKO General TV renewal for Memphis, Tennessee; and the hearing for the A-block Dallas-Ft. Worth cellular permit.

Judge Harrison chaired the education committee of the Federal Administrative Law Judges' Conference and was on the faculty of the Judicial College at the University of Nevada. Following his retirement from the FCC in 1986 he was in private practice for two years before he fully retired.

Survivors include a son, Stephen, and a daughter, Nancy Wood, as well as two grandchildren. His wife of 53 years, Mary, died in 2007. Another son, Paul, died at age seven in 1963.

Thomas Eric Lodge

Thomas ("Tom") Lodge, age 53, of Columbus, OH, a telecommunications attorney and FCBA member, passed away on Wednesday, April 28, 2010 after a three-year battle with colon cancer.

Tom received his B.A., cum laude, in Political Science from The Ohio State University in 1978 and his J.D., Order of the Coif, from Case Western Reserve University School of Law in 1981.

Tom had a distinguished thirty-year legal career at Thompson Hine, LLP, where he was a partner and leader of the firm's Telecommunications Practice Group. He was a member of the Ohio State and Columbus Bar Associations.

Tom was a leading lawyer in Ohio in telecommunications law, representing many telecommunications companies on a variety of issues before the Public Utilities Commission of Ohio. Tom also worked for clients in the wireless and fiber optics industries.

Throughout his tenure with Thompson Hine, Tom led many firm initiatives. In

addition to leading the Telecommunications Practice Group, Tom served for many years on the Lawyer Personnel Committee, including several years as chair of that committee, which oversees associate attorney development.

In the past few years, Tom fought a courageous battle with colon cancer. Even as he underwent treatments, including difficult chemotherapy regimens, he remained active in his practice and with the firm. Tom continued to make himself available to clients and colleagues throughout his illness, always with keen professionalism and good humor. Tom's diagnosis and treatment spurred him to spread the word of early detection both inside and outside Thompson Hine. He was also an active participant in and advocate for the Colon Cancer Alliance and of Pelotonia, an organization formed to raise money for cancer research at the James Cancer Hospital in Columbus. Tom served as a volunteer at the 2009 Pelotonia cycling race, managing the 50-mile stop and as a Virtual Rider and Captain for Thompson Hine's Peloton. Thompson Hine attorneys and staff will race in his memory this August.

Tom was the beloved husband of Joan for 30 years and the loving father of John and Sarah. In addition to his mother, two brothers, and other close relatives, he leaves behind his many colleagues and friends at Thompson Hine and in the Ohio legal community. Tom will be remembered as a brilliant attorney, a man of deep integrity, good humor and wit, and a kind and decent person who mentored many individuals throughout his career.
