Before I turn over the presidency, I cannot let this opportunity pass without making one more plug for the luncheon, which will take place at the **Capital Hilton beginning at noon**. **Chairman Julius Genachowski** will join us, and we'll be announcing the FCBA election results, presenting the Distinguished Service Awards, and showcasing the winners of the FCBA Foundation's scholarships and stipends. I hope to see all of you there!



We have had an amazing year, and we could not have done it without the help of the FCBA Executive Committee, all the committee co-chairs, the chapter co-chairs, and of course, the dedicated staff at FCBA headquarters. Your commitment to our bar association is truly remarkable, and I am proud to be your colleague in the FCBA.

I would like to take a moment to highlight this year's results of your incredible hard work and devotion to our bar association. Julius Genachowski was nominated by President Barack Obama as Chairman of the Federal Communications Commission on March 3, 2009, and sworn into office on June 29, 2009.

Chairman Genachowski has two decades of experience in public service and the private sector. Prior to his appointment, he spent more than 10 years working in the technology industry as an executive and entrepreneur. He co-founded LaunchBox Digital and Rock Creek Ventures, where he served as Managing Director, and he was a Special Advisor at General Atlantic. In these capacities, he worked to start, accelerate, and invest in early- and mid-stage technology and other companies. From 1997-2005, he was a senior executive at IAC/InterActiveCorp, a Fortune 500 company, where his positions included Chief of Business Operations and General Counsel.

Genachowski's public service spanned broadly across government. His confirmation as FCC Chairman returns him to the agency where, from 1994 until 1997, he served as Chief Counsel to FCC Chairman Reed Hundt, and, before that, as Special Counsel to then-FCC General Counsel (later Chairman) William Kennard. Previously, he was a law clerk at the U.S. Supreme Court for Justice David Souter and Justice William J. Brennan, Jr. (ret.), and at the U.S. Court of Appeals for the D.C. Circuit for Chief Judge Abner Mikva. Genachowski also worked in Congress for then-U.S. Representative (now Senator) Charles E. Schumer (D-N.Y.), and on the staff of the House select committee investigating the Iran-Contra Affair.

Genachowski has been active at the intersection of social responsibility and the marketplace. He was part of the founding group of New Resource Bank, which specializes in serving the needs of green entrepreneurs and sustainable businesses, and has served

on the Advisory Board of Environmental Entrepreneurs (E2). He also served as a board member of Common Sense Media, a leading non-partisan, non-profit organization seeking to improve the media lives of children and families.

Genachowski received a J.D. from Harvard Law School (magna cum laude), where he was co-Notes Editor of the Harvard Law Review. He received a B.A. from Columbia College (magna cum laude), where he was Editor of Columbia Spectator's Broadway Magazine, re-established Columbia's oldest newspaper (Acta Columbiana), and was a writer and researcher for Fred Friendly. He was also a certified Emergency Medical Technician who served on the Columbia Area Volunteer Ambulance, and taught cardiopulmonary resuscitation (CPR).

Genachowski, a son of immigrants, is married to Rachel Goslins and has three children.

New York Chapter

Continuing an active programming schedule, FCBA's New York Chapter hosted a panel discussion and networking reception on Thursday, April 28 at the Rochester, NY headquarters of PAETEC. The panel discussion titled "Effectively Advocating from 'Outside the Beltway' on Inter-carrier Compensation Reform and Other Policy Issues" included Rebekah Goodheart, Associate Bureau Chief, FCC Wireline Competition Bureau, who joined the discussion via video conference from Washington, Gregg C. Sayre, Associate General Counsel of Frontier Communications Corporation, Michael J. Shortley III, Vice President, Regional General Counsel of Global Crossing North America, Inc., and William A. Hass, Corporate VP Public Policy & Regulatory of PAETEC. John Messenger of PAETEC moderated the panel. Among other things, panelists shared their experiences in navigating and balancing the needs of clients and addressing the concerns of the Commission in effectuating policy and rulemaking.

Following the panel discussion, event participants enjoyed refreshments and networking. Overall, the program was an outstanding opportunity for communications attorneys from Washington and across the state of New York to share ideas and to forge new relationships. The Chapter thanks the chapter's steering committee and program co-sponsors Syracuse University College of Law, PAETEC, and Klein Law Group for their tremendous support.

In addition, the New York Chapter co-sponsored the NYSBA's 12th Annual Public Utility Law Institute on May 17th in Albany, NY. The all day continuing legal education program provided an array of unique speakers on telecommunications and energy legal/policy issues. CHAPTER in the Spotlight

Pacific Northwest Chapter

The Pacific Northwest Chapter was founded more than a decade ago in the heat of the telecom explosion of the 1990s. Since then, the Chapter has evolved to focus broadly on issues related to telecom, the Internet, and technology more broadly. Of course, the Northwest has been a hub of wireless activity since the 1980s; thus, the Chapter takes special interest in issues relating to wireless.

Recent programs sponsored by the Chapter reflect both the broader and wireless focus of our activities. Late last year, a panel at Microsoft with speakers from Microsoft and T-Mobile discussed the potential impacts of privacy regulation on the Internet. While the panelists discussed particularly the then recent FTC report on privacy, they also discussed best practices generally for online companies.

In late March, the Chapter held a program on the wireless ecosystem and related device issues at T-Mobile. Speakers from T-Mobile, HTC and Groundspeak covered issues of concern across that ecosystem. The perspectives of a carrier, a device maker and a content/edge provider were equally valuable and showed both the challenges and opportunities for all involved.

A Fond Farewell to McKenna's Wagon

After thoughtful consideration, the FCBA Foundation Board has decided to retire its work with McKenna's Wagon. McKenna's Wagon is a mobile soup kitchen operated by Martha's Table and it delivers meals to the homeless in D.C. The FCBA Foundation will continue its volunteer activities with Martha's Table.

Joanna Georgatsos, FCBA member and the Foundation's most recent Volunteer Coordinator for McKenna's Wagon, offered a thought-provoking reflection on her years as a volunteer with McKenna's.

I have many fond memories of volunteering with McKenna's Wagon. By far, the most meaningful experience was my first time volunteering, before I began serving as the Volunteer Coordinator. While I was dutifully handing out sandwiches from the van, a young man in line said to me, "I know you, what year did you graduate high school." In all honesty, I was somewhat startled, so I did not respond. He then said, "You went to Walter Johnson and graduated in 1997, right?" I did in fact, go to Walter Johnson High School, but I graduated in 1998. I told him that, and then he proceeded to list several people who I went to school with, and said he graduated in 1997. I started to respond, but he just smiled and wondered away, soup and sandwiches in hand.

That experience hit very close to home for me. It made me realize that homelessness can happen to just about anybody, regardless of background or situation. After that experience I quickly offered to be the Volunteer Coordinator with the hope that other FCBA members would be as deeply touched as I was.

Each time I volunteered with McKenna's Wagon, I was always surprised by the people we served. They were almost always polite, courteous, and grateful, and always thanked us for our time. They helped us set up the tables to distribute food, and through their assistance the entire operation almost always ran smoothly. Many of the people we met were eager to make conversation, often talking about the weather, current events, and during football season, the latest Redskins defeat. They seemed to come from all walks of life – there were old people and young, people of all races and ethnicities, and many who I would never imagine to be homeless. Almost all of the people we met were courteous of each other – the regular practice was to allow the "first timers" (people who had not been through the food distribution line yet that day) to cut the line so they could get their share of food. There were rarely fights or arguments, and on the rare occasion when there was a dispute, it generally fizzled out quickly before escalating into something serious.

By volunteering with McKenna's Wagon, I loved getting to know other FCBA members in a relaxed setting. Many members of all ages and professional backgrounds volunteered throughout the years. Members volunteered that were attorneys at the FCC, the FBI, and other federal government agencies, in private practice, with public interest groups, and in-house at large and small communications companies. Many law students interested in communications law volunteered, as well as children and friends of FCBA members. While each volunteer likely took with them their own personal experience, almost everybody seemed to enjoy volunteering and left feeling more connected to the community as a whole and the people we served.

Overall, while volunteering with McKenna's Wagon took very little time, for that brief period, it gave the FCBA volunteers a short glimpse into another world. While we were free to drive away from that world once all of the food was distributed and the van was packed up, the volunteering experience left all of us with a greater appreciation for our good fortune, and more compassion for the less fortunate around us.

FCBA ANNUAL SEMINAR 2011

On April 29-May 1, the FCBA again hosted a successful Annual Seminar at Nemacolin Woodlands Resort in Farmington, PA. The theme of this year's Seminar was "On the Occasion of the FCBA's 75th Anniversary Year: Celebrating the Past and Looking Forward" and an interesting and impressive group of panelists and speakers participated. After opening comments from FCBA President **Bryan Tramont**, the Seminar began with a panel featuring FCC Bureau and Office Chiefs Admiral **James Barnett**, Chief of the Public Safety and Homeland Security Bureau; **Paul de Sa**, Chief of the Office of Strategic Planning and Policy Analysis; **Sharon Gillett**, Chief of the Wireline Competition Bureau; **Joel Gurin**, Chief of the Consumer and Governmental Affairs Bureau; and **Austin Schlick**, FCC General Counsel. The panel, moderated by **Michele Farquhar**, Hogan Lovells, and **Mike Senkowski**, Wiley Rein, addressed "Lessons Learned From the Past and Their Plans for the Future." After a reception (sponsored by Comcast Corporation and NBC Universal) and family dinner at the Ski Lodge, attendees and their families socialized at the WildSide (sponsored by Warren Communications Daily) with many playing Bingo (sponsored by AT&T), bowling, or conversing and enjoying the arcade games.

The Saturday morning session opened with a panel featuring the leadership at NTIA -- **Larry Strickling**, **Anna Gomez**, and **Tom Power**. In a session moderated by FCBA President-Elect **Yaron Dori**, the panelists described the mission of NTIA, the way in which their office processes industry concerns, and the challenges involved in coordinating the Administration's position on communications policy. Attendees also were treated to several humorous anecdotes about the organization of the office and what it is like to work there. During the following session moderated by **Bryan Tramont**, FCC Commissioners **Mignon Clyburn** and **Michael Copps** offered their views on FCC policy and the Communications Act. The next panel, comprised of **John Branscome**, Majority Counsel, Senate Commerce Committee; **Shawn Chang**, Telecommunications Counsel, House Energy & Commerce



Committee; **David Quinalty**, Republican Professional Staff Member, Senate Commerce Committee; **David Redl**, Majority Counsel, House Energy & Commerce Committee; and moderated by **Tricia Paoletta**, Wiltshire & Grannis, was a bipartisan, bicameral panel of House and Senate communications counsel reviewing likely developments through the first Session of the 112th Congress. The discussion focused on legislation for funding the nationwide interoperable wireless broadband network for public safety. The network, ten years after the September 11th attacks, is a priority for both chambers, although leaders of the respective Commerce Committees have differing views on the disposition of the 700 MHz D Block. Members are also reviewing the possibility of incentive auctions for broadcasters - if truly voluntary - both to free up spectrum for mobile broadband growth and fund the public safety network. Counsel assumed these issues, as well as FCC process reform and merger conditions, would be front and center for the foreseeable future. Wrapping up the morning was a panel on Safety in an Online World moderated by **Mark Brennan**, Hogan Lovells and **Lisa Youngers**, XO Communications; and featuring **Stephen Balkam**, CEO, Family Online Safety Institute; **Will DeVries**, Policy Counsel, Google, Inc.; and **Rick Kaplan**, Chief Counsel and Senior Legal Advisor to FCC Chairman Genachowski.

After the educational sessions ended, attendees participated in various afternoon activities including a golf tournament (sponsored by Verizon) a tennis round robin (sponsored by AT&T), and a tour of Fallingwater.

The evening's reception (sponsored by the National Association of Broadcasters), banquet, and DJ music entertainment (sponsored by Google Inc.) also proved to be fun for all, and included dancing by all ages. During dinner, **Julie Kearney**, Chair of the FCBA Foundation, made remarks about the FCBA Foundation's 20 year history. A raffle was held to support Byte Back, an organization helping to improve economic opportunity for low-income residents of the Washington DC area by providing computer training and employment readiness skills. FCBA REQUESTS PROPOSALS FROM U.S. LAW SCHOOLS TO HOST THE FEDERAL COMMUNICATIONS LAW JOURNAL

For many years, the FCBA has contracted with various U.S. law schools to publish the Federal Communications Law Journal. The FCBA's Law Journal Committee, in close coordination with the FCBA's President and Executive Committee, is issuing the Request for Proposals set forth below seeking submissions from accredited U.S. law schools interested in serving as the host institution for the Journal beginning with academic year 2012-2013. Submissions from interested law schools are due September 15, 2011. We encourage FCBA members to help publicize the RFP process. If you think your alma mater or another law school might be interested in making a proposal to host the Journal, please make that school aware of the RFP.

FEDERAL COMMUNICATIONS BAR ASSOCIATION REQUEST FOR PROPOSALS HOST INSTITUTION OF THE FEDERAL COMMUNICATIONS LAW JOURNAL

The Federal Communications Bar Association ("FCBA"), the official bar association of the communications industry, is undertaking an assessment of potential Host Institutions for its academic journal, the Federal Communications Law Journal ("Journal"). The Journal explores important issues of telecommunications law and policy in analytically rigorous and topical ways and, consistent with past practice, is to be published three times during each academic year. The copyright of the Journal is held, and will continue to be held, by the FCBA.

To this end, the FCBA is issuing this Request for Proposals ("RFP") to solicit proposals from accredited U.S. law schools to host the Journal. Potential candidate law schools should be able to demonstrate the following criteria:

- The law school has a commitment to a telecommunications curriculum such that students working on the Journal will both have some familiarity of the

issues and be provided with active guidance from the law school's faculty.

- The law school will provide at least one faculty advisor who has a proven record of expertise and scholarship in the area of telecommunications law and policy. This expertise is essential to help the students evaluate the quality of potential submissions and to provide crucial editorial advice.
- The faculty advisor(s) should be familiar with and active in the telecommunications law and policy debate in Washington, D.C., such that the faculty advisor(s) can provide students with guidance as to which potential submissions are most timely, relevant, and useful to FCBA members and others.
- The faculty advisor(s) will be responsible for working with the FCBA Law Journal Committee and other FCBA members to discuss upcoming issues of the Journal, as well as working with the FCBA to hold conferences, symposia and the like that can result in the publication of the proceedings in the Journal.
- In the event a new host school is selected, the Selectee and its faculty advisor(s) should be able to demonstrate that school's willingness and ability to work cooperatively with the incumbent host school to ensure a smooth transition.
- Law schools submitting proposals are encouraged to state their vision for the Journal and provide any information they think would be pertinent for consideration by the FCBA.

Cost allocation between the FCBA and the host school is as follows:

- Host School: The host school will contribute in-kind services such as office space, library access, web design and hosting, and administrative costs. The students' time would be volunteered.
- FCBA: The FCBA will contribute to the production, printing, and mailing costs at a rate of \$2.50 per FCBA member to

ensure that each of its members will receive a personal hard copy of each published issue of the Journal.

- Host School and the FCBA will split the residual income from sales of non-FCBA member subscriptions (e.g., law libraries) and from electronic databases such as Westlaw & Lexis on an "as agreed to" basis. Potential candidate schools are encouraged in their submissions to propose a reasonable percentage division of residual income.

Time Frames for the RFP Process:

- Issuance of RFP: May 2011
- Submissions Due: September 15, 2011
- Site Visits (if any) and Consideration of Finalists: October 30, 2011 – February 1, 2012. Schools that are chosen as finalists may be asked to pay expenses for FCBA Journal Committee members to visit on-site.
- Selectee Announced: February 1, 2012 (thus allowing transition to occur during the remainder of the academic year while students are still on campus)
- In the event a new host school is selected, control of the Journal would pass to the Selectee at the end of the 2011-2012 academic year. Beginning with the 2012-2013 academic year, the Selectee will publish the Journal three times each academic year.
