The New England Chapter had a strong presence at the New England Conference of Public Utility Commissioners (NECPUC) annual symposium in Newport, Rhode Island, on May 5-7. In addition to the attendance at the conference of numerous New England Chapter members, the Chapter was instrumental in arranging two telecommunications-related panels at the symposium.

The first, "Optimal Communications Infrastructure to Unleash the Power of the Smart Grid," featured speakers from power companies, equipment vendors,

wireless telecommunications providers and applications developers. The panelists discussed such issues as the networks that could support smart grid applications; the role of broadband in supporting the smart grid and challenges facing the use of broadband, especially in rural areas; how to ensure that communications systems supporting the smart grid are future-proofed and scalable, and feature openness and interoperability; and how to ensure cyber-security and grid security.

The second panel was entitled “Will the Broadband Stimulus Funds Incentivize a National Broadband Policy and will States’ Priorities be a Part of the Equation?” Moderated by Commissioner Vandean Vafiades of the

Maine Public Service Commission, the panel consisted of representatives from wireless, cable, rural telephone, the U.S. Senate, and a state PUC. It discussed such issues as the components of a national broadband policy and states’ roles in its development and implementations; definitions of technology neutral, unserved, and underserved; the priority to be given innovative strategies for consumer access to technology; and cost to consumers.

The New England Chapter continued its successful partnership with the NECPUC symposium organizers through helping to arrange these seminars. We fully expect to continue our joint efforts next year. Special thanks to former Co-Chair Doug Denny

Brown and David Bogan, both of which are current members of the New England Chapter Steering Committee, for their efforts in positioning the Chapter in its collaboration with NECPUC.

The New England Chapter has several programs planned for later this year, including an upcoming event on July 14th in Portland, Maine – which will feature Governor John Baldacci and his efforts during his term to foster economic development in the state of Maine. Also, the Chapter is in the process of planning a second-annual co-sponsored event with Boston University on Broadband on Monday, October 5th.

Despite the loss of two Co-Chairs in the second half of this year, the ad hoc Privacy & Data Security Committee has been very busy. The Committee has hosted and/or moderated events that have covered a wide range of privacy and data security issues, including a Brown Bag Luncheon on the FTC's Red Flag Identity Theft Rules in October, featuring Pavneet Singh, Senior Attorney, Division of Privacy and Identity Protection, Federal Trade Commission (FTC), one of the co-authors of the FTC's Red Flag Rules Order. Because privacy and data security issues impact all communications industries, the Committee has partnered with the FCBA's International Telecommunications Committee to co-host a brown bag luncheon titled "*The Global Privacy Framework for Communications and Media Companies*" on May 5. Speakers included representatives from the U.S. Department of Commerce, the FTC's Office of International Affairs, and VeriSign. Rules committees. He served as Governor of Virginia from 2002-2006 after spending 20 years as a business leader in the high-tech industry.

Senator Warner was the first member of his family to graduate from college, earning a degree from The George Washington University, thanks to part-time jobs and student loans. He received a law degree from Harvard in 1980.

As a private citizen and philanthropist, Mark Warner helped create the Virginia Health Care Foundation, which has provided health care to more than 600,000 under-served Virginians, and SeniorNavigator.com, a referral network for older Virginians and their caregivers.

As Governor of Virginia, Mark Warner inherited budget shortfalls that ultimately grew to \$6 billion. He left office four years later with a budget surplus that allowed Virginia to make the largest single investment in K-12 education in state history, key reinvestments in one of the nation’s best public university systems, and record investments in the clean-up of the Chesapeake Bay.

In 2004, Warner chaired the National Governors Association, and TIME Magazine named him one of “America’s Five Best Governors” a year later. Governor Warner’s bipartisan, results-oriented focus resulted in Virginia being designated as the nation’s “best managed state” and its “best state for business.”

He lives with his wife, Lisa, and three daughters in Alexandria, Virginia.

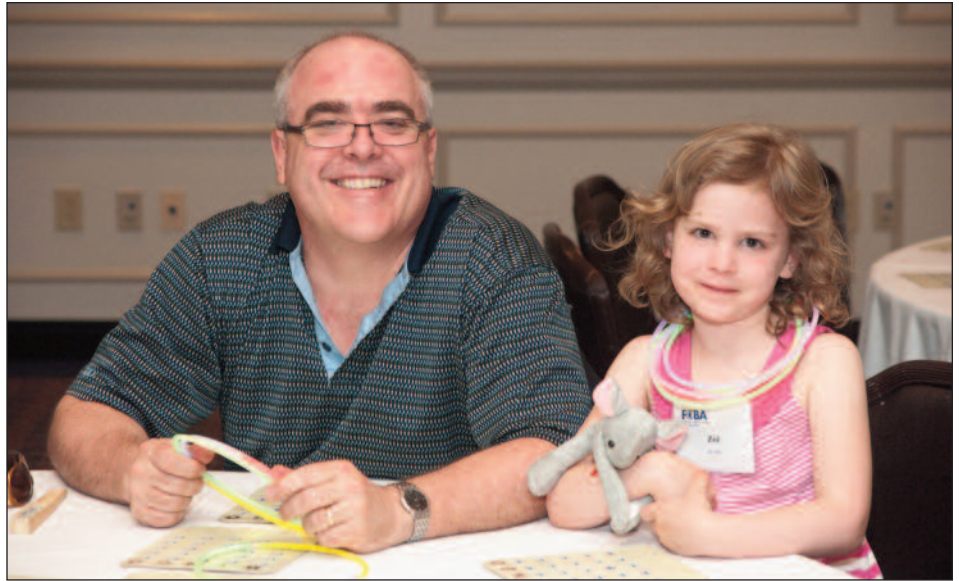

Rudolfo (Rudy) Lujan Baca

Former FCBA Executive Committee member Rudy Baca, 52, died unexpectedly of a heart attack on April 24, 2009, while in Philadelphia to visit friends and family and view the *Cezanne and Beyond* exhibit at the Philadelphia Museum of Art.

Rudy was born in Albuquerque, New Mexico. After earning a B.A. degree from the University of New Mexico and a J.D. from Georgetown University, where he was Editor-in-Chief of the *Immigration Law Journal*, Rudy embarked on a legal career spanning both the public and private sectors. He started as a judicial clerk to the Hon. Ricardo M. Urbina of the Superior Court of the District of Columbia, then worked in his home state as an Assistant Attorney General with the New Mexico Corporation Commission.

Returning to Washington, Rudy joined the Federal Communications Commission's International Bureau as a Senior Attorney. He later became Senior Legal Advisor and Chief of Staff to FCC Commissioner James H. Quello and served as Common Carrier Advisor during Quello's time as interim Chairman. After leaving the FCC, he was an investment analyst and industry strategist with Legg Mason and The Precursor Group, focusing on global telecommunications, wireless and media issues. Most recently, he practiced communications law as a partner with Rini Coran, PC and Fleischman and Harding, LLP.

Rudy contributed to his profession, the field of telecommunications and the community in many ways. His leadership as an FCBA Executive Committee member and co-chair of several standing committees and his energy as a volunteer and cheerful

presence running the cashier operation at many charity auctions helped make the FCBA a stronger organization. He also served on the Board of Directors of the National Hispanic Bar. As an adjunct professor at the Georgetown Law Center and through his involvement with the work of the United States Telecommunications Training Institute, Rudy helped enable many talented individuals – both from the U.S. and abroad – to become successful lawyers and telecommunications professionals.

Rudy is survived by his father and stepmother, two sisters, a brother, nieces, nephews, and his partner of 30 years, Edward M. Kelly. Friends and colleagues describe Rudy as “the soul of exuberance,” “always upbeat,” “effervescent,” “someone who loved the arts” and “a person of passion who found life to be exciting and took delight in many things that people overlooked.” Others have pointed out that in addition to his trademark energy and enthusiasm, there was also the Rudy who quietly and patiently rendered many acts of kindness to individuals in need and who was devoted to his family and friends.

A memorial service to celebrate Rudy's life is planned for Friday, July 17, 2009, at 11:00 a.m. at the Church of the Annunciation, 3810 Massachusetts Avenue, N.W.

Joel H. Levy

Joel H. Levy, a communications attorney for more than 45 years, died on April 3, 2009. He was 73. He had practiced communications law with the Cohn and Marks law firm since 1965.

Joel was born and raised in New York City. He graduated from Dartmouth College in 1957 and Harvard University's Law School in 1960.

Shortly after graduation from law school, Joel began working at the FCC, first in the Rules and Standards Division and later, starting in 1963, with the Office of General Counsel, Litigation Division. In 1965 Joel left the FCC to join Cohn and Marks. There he represented large and small broadcasters, as well as wireless and wireline carriers. He worked on many Court of Appeals cases over the years.

Joel found particular professional and personal satisfaction in the close relationships he developed with clients and in defending the First Amendment rights of broadcasters. Among his long-time clients was The Forward Association, for both their print and broadcast operations.

He was very active over many years with the American Jewish Congress. He served as a national officer and provided pro bono legal services.

His hobbies were photography, tennis, walking and golf. He was not only a serious photographer but also a collector of prints by notable photographers.

Joel is survived by his wife Felecia, two sons, one daughter and three grandchildren.

For those who have volunteered, it has been a wonderful experience and a great way to help the needy in the D.C. community. This is an especially good experience for the teens and pre-teens among us who do not have a full appreciation of the many privileges they enjoy. Community service credits are also available.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at **4:45 p.m.** in comfortable clothes and shoes. Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available.

Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.
