#### THREE SUBSTANTIVE SESSIONS:

**1. Is the Doctor in?: Health Privacy and Data Security Issues** - The Health Insurance Portability and Accountability Act of 1996 (HIPAA) was one of the country's first federal privacy laws and impacts more than just "covered entities" such as health care providers and health insurance companies. The Health Information Technology for Economic and Clinical Health Act (**HITECH Act**), which was enacted as part of the American Recovery and Reinvestment Act of 2009 to promote the adoption and meaningful use of health information technology, imposes privacy obligations on vendors and service providers to these "covered entities," including a wide range of communications companies engaged in new business ventures involving digital health care records and new health care products. This panel will discuss new developments and emerging issues related to covered entities and business associates as well as other entities who may soon be regulated for their work in the health care industry. We'll also explore issues for media companies that engage in news gathering and reporting about

an individual's physical or mental health status, and developing regulations for the burgeoning field of consumer personal health records. Panelists also will address new regulations in this area and some recent (and substantial) enforcement actions under HIPAA and the HITECH Act.

**2. The Nuts and Bolts of Online Behavioral Advertising and FTC's Do Not Track Proposal** - The Internet allows greater interactivity between consumers and online entities, which has provided many consumer benefits, such as free content and applications and more personalized services. The increasing ability of companies to collect and combine consumer information has also raised concerns about consumer privacy. In particular, the FTC has examined online behavioral advertising – tracking a person's online activities to deliver advertising tailored to that person's interests – and issued suggested self-regulatory principles in 2009. Industry responded by undertaking self-regulatory efforts, which the FTC recently criticized as insufficient. The FTC has instead endorsed the creation of a Do Not Track mechanism that would provide consumers

a more uniform and comprehensive choice about online behavioral advertising. This panel will discuss how behavioral advertising works, its benefits and risks, and the advisability and feasibility of a Do Not Track mechanism.

**3. Working 9-5: Privacy and Data Security Issues for Employers** - Much has been made about the protection of consumer privacy. However, any company that has employees is also subject to some of the same privacy laws that apply to consumers, in addition to various federal and state laws that regulate the collection of social security numbers and other sensitive or personally identifiable information from employees. Employers are also subject to increased legal liability for an employee's use of social networking services, texting, or emails on or off the job. ## FCBA to Sponsor Special Interact Training Program on March 29

As part of the mentoring component of the Pay it Forward initiative, the FCBA is teaming with Interact Performance Systems to offer a one-day training seminar on **Tuesday, March 29** from **8:30 a.m. – 6:00 p.m.** at Wiley Rein LLP, 1750 K Street, NW, 10th Floor Conference Room.

The seminar, called Interact Performance Problem Solving™, is a program for leaders, peers and teams to help improve inter-personal communications skills for use on the job - or for that matter just about anywhere people deal with people.

**Diane Cornell**, Coordinator of the Pay it Forward program, explained that she wanted to make this course available to the FCBA membership because, "of the many training courses I took in my career, I found this to be by far the most useful – it taught me skills that I have used every day in my job. And I believe that other FCC managers who took the course had the same experience."

Have you ever felt like yelling at a work colleague because they dropped the ball and left you in the lurch? Or they consistently turn in projects late? Many of us have needed to discuss an important issue or problem with someone else and found ourselves struggling with just how to go about it. Often we think we've approached such a situation as well as can be done only to discover later that we've alienated the other person and perhaps made the situation worse. Can we improve our handling of these kinds of situations? Yes we can!

The goal of this Performance Problem Solving™ seminar is to build skills to help people solve problems, improve commitment, and strengthen working relationships. This course is designed to help participants address problems in a work environment – whether the issue is with a peer, or with someone above or below them in the reporting chain.

Performance Problem Solving teaches participants how to ensure accountability and ownership from one another while building commitment and strong working relationships. This program builds concrete tools for solving the kinds of problems that undercut performance. Key to the success of this program is its use of systems thinking and a decision model rather than action steps. Participants learn to diagnose the causes of performance problems and to respond to what they have learned. This approach allows

participants to build on simple listening, communication, and feedback skills to deal with the tough business problems that make a difference to the bottom line.

In this program, skills are presented in four segments. Each segment is demonstrated by short video scenes, by reality based examples drawn from participant experiences and by participant rehearsals. Segments include (1) skills for communicating the situation and providing positive reinforcement, (2) skills for assessing and handling ability problems, (3) skills for assessing and handling motivation problems and finally (4) skills for dealing with emergent problems, or issues that arise while handling other problems. (A fifth segment incorporating and reviewing the entire skill set is available should a follow-up or refresher session be desired.)

#### Learn skills to:

- Confront performance problems without creating defensiveness.
- Diagnose whether problems are due to ability (internal skills or external obstacles) or motivation (person doesn't understand the consequences or doesn't care about them).
- Resolve motivation problems by explaining the reasons behind priorities and getting the other person to explain the reasons behind their different priorities.
- Resolve ability problems, seek input, establish criteria, and evaluate options.

The Privacy and Data Security Committee co-chairs this year are **Genie Barton**, Director of the Online Interest-Based Advertising Accountability Program at the Council of Better Business Bureaus, Inc.; **John Heitmann**, Partner at Kelley Drye & Warren LLP; **Karen Henein**, Associate at Willkie Farr & Gallagher LLP; and **S. Jenell Trigg**, Partner at Lerman Senter PLLC. Privacy has been a hot topic for the media, the Hill, international and domestic regulators, and consumer groups. New self-

regulatory initiatives have been launched, agency reports issued, international privacy frameworks negotiated, and domestic bills introduced. The Committee kicked off in September 2010 and has offered a series of brownbag lunches, CLEs, and two major Pay It Forward initiatives. Brownbag lunch topics have included online privacy, privacy issues in social media, and state power grid information tracking (smart grid). We've presented numerous CLEs on cutting edge issues such as ECPA reform, international data privacy laws, and mobile broadband privacy. Several of these events were conducted in partnership with various other FCBA committees. Also, on March 16, 2011, the Committee's Annual Privacy and Data Security Symposium is back by popular demand for its sixth year. The theme this year will be "New Directions, New Laws, and A New Privacy Paradigm." The Symposium will focus on developments in privacy and data security that will impact

### FCBA Foundation Now Accepting Applications for Funding of Unpaid Legal Internships

For the 18th consecutive year, the Federal Communications Bar Association (FCBA) Foundation will award stipends to law students from its Chairman Robert E. Lee Scholarship and Internship Fund. In 2011, the Foundation will award several stipends to law students employed as unpaid summer interns in positions with the FCC and other government agencies or entities with a connection to the communications industry. Applicants will be selected on the basis of: (1) a demonstrated interest in the communications field, (2) having secured or having pending, an unpaid summer position (internship) for at least eight weeks in communications with a government agency or entities with a connection to the communications industry, (3) dependence on financial assistance in order to accept the unpaid internship in a government agency or entity involved in communications; and, (4) community activities. To the extent a recipient receives unanticipated funding for the unpaid internship, the FCBA Foundation’s general policy is to reduce its scholarship awards by any amount that a recipient’s total funding (including all sources) for the internship would otherwise exceed \$7,000.

This is an especially good experience for the teens and pre-teens among us who do not have a full appreciation of the many privileges they enjoy. Community service credits are also available.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at **4:45 p.m.** in comfortable clothes and shoes. Martha's Table is located in a yellow building

at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available. Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution

is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.
