Presented by the Transactional Practice Committee

The Transactional Practice Committee is planning a CLE for **Thursday, March 12, 2009** from **6:00 – 8:15 p.m.** at Willkie Farr & Gallagher LLP, 1875 K Street, NW. Tax laws have a substantial impact on communications transactions. They can determine the structure of the entire deal, and are a factor in calculating the economic costs and benefits of a deal. Compliance with tax laws is relevant to reps and warranties, covenants and post-closing obligations of the parties. The obligations that the parties undertake can require the commitment of significant financial and human resources. Yet communications attorneys typically know very little about tax issues or how to use tax counsel effectively. This CLE is intended to introduce communications lawyers to basic tax concepts to assist them in spotting issues and knowing when expert tax counsel is a must. Topics will include:

- Portions of the deal agreement of interest to a tax lawyer
- Asset sales versus stock sales
 - by form or elective under Section 338 of the Code
 - the fundamental tax difference
 - tax treatment for sale of stock of a corporation and reverse subsidiary merger where consideration is cash

 - tax treatment to buyer and seller
- Use of LLCs in tax free reorganizations
- Tax-free reorganizations
- Two-step acquisition structures
- Mechanics of joining and leaving consolidated groups
- Like-kind exchanges
 - benefits
 - requirements of simultaneous exchanges
 - additional requirements of deferred like-kind exchanges

Williamsburg is located 150 miles south of Washington, D.C. Educational and recreational activities abound, and include the following:

HISTORIC AREA

(Historic reminder: from 1699 to 1780, Williamsburg was the capital of England's oldest, largest and most populous North American mainland colony, named in honor of England's King William III.) Encompassing 301 acres, Colonial Williamsburg's Historic Area portrays 18th-century Williamsburg on the eve of the American Revolution. Area sites include the Governor's Palace, the symbol of British authority in the colony; and the Capitol, the seat of colonial power and site of Virginia's vote for independence on May 15, 1776, and home to the General Assembly from 1776-79. Colonial Williamsburg also operates several museums. Williamsburg is a short trip to both Jamestown and Yorktown, the other two corners of Virginia's "historic triangle."

applicable remedies (Ebay), the courts have taken seriously concerns about the state of the patent system and its impact on innovation the software and information technology sectors. At the same time, Congress—spurred by a coalition of IT firms—has considered a number of reform measures geared to address concerns that the patent system is rewarding bad patents and encouraging inefficient litigation.

In this conference, we will evaluate both the premises underlying the call for a fundamental reform—and, indeed, the possible abolishment of—software patents as well as some specific suggestions for changing how patents are granted and how patent litigation operates. In particular, we will evaluate whether software patents should exist at all, whether patent litigation serves a constructive role in facilitating innovation and commercialization of new technologies, and whether patents play an important role in spurring the development of new technologies and enabling start-up firms to attract financing. It will conclude with a roundtable of three leading commentators on the role of patents and innovation.

John W. "Jack" Gray, Jr.

Former AT&T Corporate Vice President of Federal Governmental Relations **John W. "Jack" Gray**, 78, died after an illness on January 14 at Goodwin House retirement community's nursing center in Alexandria, Virginia. He was a long-time member of the FCBA until his retirement in the 1990's.

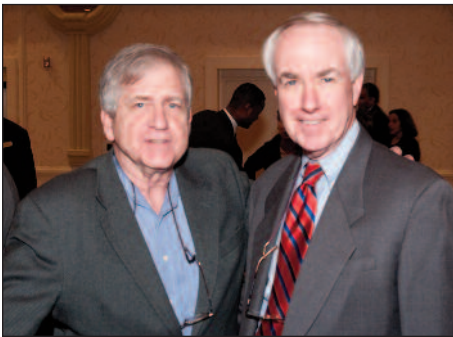

Law Journal Committee

New faces have been the predominant theme for the Law Journal Committee over the past year. The Committee, which works with students and faculty at the Indiana University law school to publish the Federal Communications Law Journal, welcomed **Chris Wright** of Harris, Wiltshire & Grannis, and **Deborah Salons** of Drinker Biddle as new co-chairs, joining **Jamison Prime** of the FCC. At Indiana, new Faculty Advisor Jody Madeira and this year's roster of student editors have been working to ensure that Volume 61 of the FCLJ's long running academic journal offers a robust mix of

communications-related articles, notes, and reviews.

As the primary point of contact between the FCLJ and Indiana Law, the Committee addresses matters relating to our publication contract. Through regular conference calls, an annual on-site visit, and a D.C. reception, Committee members worked with student editors to identify communications-related topics of interest to our membership and address general issues of editorial policy. Editor-in-Chief Christopher J. Harayda and his staff have put together a strong volume of the Journal, including articles adapted from the recent conference marking the 25th anniversary of the breakup of AT&T sponsored by the University of Pennsylvania's Center for Technology, Innovation, and Competition. The Committee continues to work to improve electronic access to the Journal. Members receive advance access to Journal content via an email with hyperlinks to the current issue that is sent out while the paper edition is being printed and mailed. The Online Forum

serves as an additional outlet for high-quality analysis and dialogue, hosting both responses to published articles and new and original communications law commentary. The Online Forum, published exclusively on the Journal's website in conjunction with the electronic versions of print articles, is available at <http://www.law.indiana.edu/fclj/index.shtml>.

We're grateful for the contributions of former Faculty Advisor Joshua Fairfield, who worked with the Committee to launch the Online Forum and to ensure a smooth hand-off to Jody Madeira before leaving to pursue academic opportunities at Washington and Lee. Similarly, the steady hand of former co-chair **Bill Richardson**, who served since 2004, was an invaluable asset to both the Journal and the Association.

Young Lawyers Committee

The Young Lawyers Committee (YLC) is co-chaired by **Tarah Grant** of Hogan & Hartson LLP and **Cathy Hilke** of Wiley Rein LLP. Its membership includes law students, attorneys, and other professionals who are either under the age of 36 or who have been admitted to the practice of law within the preceding seven years. The mission of the YLC is to provide opportunities for networking, social interaction, and professional development to those who are new to the bar. Unlike other FCBA committees where the co-chairs are appointed, the YLC co-chairs are elected by the YLC membership. Elections are

held in May and each co-chair serves a staggered two-year term, thereby ensuring the YLC has year-round continuity in its programming and outreach efforts.

Throughout the year, the YLC offers brown bag lunches on a monthly basis. YLC brown bag lunches are informal gatherings with one or more YLC-invited guests presenting on a topic of interest to the YLC membership. Topics range from substantive law issues and “introductions” to areas of communications law to career development advice. The YLC frequently draws on its membership to assist in planning and organizing these brown bag lunches and sometimes reaches out to other FCBA committees to assist with the promotion of the event and/or the selection of speakers.

Since the YLC election in May 2008, the YLC has hosted six brown bag lunches on varied topics, including “Welcome to the U.S. Copyright Office” in June, “The Role of Trade Association Policymakers and Counsel” in July; “Mentoring” (co-sponsored with the Diversity Committee) and “Everything You Have Always Wanted to Know About Experimental Authorizations and STAs But Were Afraid to Ask” (co-sponsored

with the Engineering and Technical Practice Committee) in October; “Work/Life Balance” (co-sponsored with the Diversity Committee) in January; and “Transitions: How to Successfully Navigate a Move into a New Position” in February. Upcoming brown bag lunches include “Diversity in the Workplace: Issues Affecting Lesbian, Gay, Bisexual, and Transgender Professionals” (co-sponsored with the Diversity Committee) and “Telecommunications Issues and Advocacy at Agencies Other Than the FCC” in March. Also, for the fourth year in a row, the YLC will be working with the Diversity Committee to co-sponsor a mentoring luncheon in April in connection with the FCBA’s Mentoring Initiative.

In addition to the monthly lunches, the YLC hosts monthly happy hours to provide YLC members with an opportunity to get to know their peers in the communications bar in a relaxed setting. These happy hours are held in a variety of locations throughout the city to maximize attendance and are well attended by FCBA members, law students, and other prospective members of the FCBA. Popular annual happy hour themes are the “Welcome New Associates” happy hour in the fall

and the “Welcome Summer Associates” happy hour in the summer. The YLC occasionally co-sponsors happy hour events with other FCBA committees to encourage interaction between YLC members and more senior members of the bar. Of course, attorneys of all levels are always welcome at YLC happy hours.

The YLC works with the Diversity Committee each year on the FCBA’s Law School Outreach Initiative. For this initiative the YLC and the Diversity Committee co-sponsor and co-organize a series of career-development panels at each of the area law schools. This year the committees plan to host events at American, Howard, George Mason, George Washington, UDC, Catholic, and Georgetown.

The YLC also promotes young lawyer involvement with the FCBA’s Annual Seminar. The YLC actively encourages its members to attend the Annual Seminar and, to facilitate such attendance, coordinates a room-sharing and ride-sharing program for YLC members. In the past, the YLC has worked with the Annual Seminar planning committee to coordinate a social event or other activity that enables YLC members to interact with more senior members of the communications bar at the Annual Seminar.

In addition, the YLC engages in year-round charitable fundraising and community outreach efforts. The YLC participates in the FCBA’s volunteer program with Martha’s Table and has continued its efforts to sell FCBA-logo polo shirts to benefit the FCBA Foundation. In addition, the YLC frequently helps the FCBA Foundation publicize opportunities for young lawyers to get involved with Foundation programs. While the foregoing activities all contribute to the YLC's fulfillment of its mission, the YLC activity of which its co-chairs and members are proudest is its annual Charity Auction. The annual Charity Auction is the YLC's flagship project and one of the FCBA's signature events. The senior YLC co-chair leads the *Ad Hoc* Charity Auction Committee, which is responsible for selecting the organization that will receive the auction proceeds and for coordinating all aspects of the annual event. The process begins in the spring by soliciting applications from local charitable organizations. FCBA Foundation Now Accepting Applications for Funding of Unpaid Legal Internships

For the sixteenth consecutive year, the Federal Communications Bar Association (FCBA) Foundation will award stipends to law students from its Chairman Robert E. Lee Scholarship and Internship Fund. In 2009, the Foundation will award at least five \$5,000 stipends to law students employed as unpaid summer interns in positions with the FCC and other government agencies or entities with a connection to the communications industry (i.e., broadcasting, cable television, telephony, satellite, wireless, and information technology).

In addition, the Foundation will select one outstanding intern among those chosen to receive an additional stipend of \$600 for the summer—the “Max Paglin Award.” Mr. Paglin was the former General Counsel and Executive Director of the FCC, and the founder of the Golden Jubilee Commission on Telecommunications, which compiled a definitive legislative history of the Communications Act.

Applicants will be selected on the basis of: (1) a demonstrated interest in the communications field, (2) having secured or having pending, an unpaid summer position (internship) for at least 8 weeks in communications with a government agency, (3) dependence on financial assistance in order to accept the unpaid internship in a government agency or entity involved in communications; and, (4) community activities. To the extent a recipient receives unanticipated funding for the unpaid internship, the FCBA Foundation's general policy is to reduce its scholarship awards by any amount that a recipient's total funding (including all sources) for the internship would otherwise exceed \$7,000.
