Mack Armstrong Wins Inaugural FCBA Excellence In Government Service Award

Daniel M. Armstrong - known as "Mack" to one and all - has been named the recipient of the FCBA's first Excellence in Government Service award. The award was created in late 2007 to recognize individuals with longterm careers in the federal government, in the field of communications, who are dedicated to the pursuit of excellence and public service. Mack will receive the award at

the FCBA spring reception, to be held on June 11, 2008, from 6:00 - 8:00 p.m. at the Washington Hilton Hotel, 1919 Connecticut Avenue, NW.

Mack's stellar record of government service makes him a fitting first recipient of this prestigious new award. Mack has served with great distinction as the head of the FCC's Litigation Division since 1975. Mack has had a long career (41 years) in public service, serving in the Civil Division of the Department of Iustice and the Federal Bureau of Investigation, as well as an Assistant United States Attorney in the Eastern District of New York, and in the U.S. Navy Judge Advocate General's Corps, before joining the FCC.

At the FCC, Mack has supervised the production of hundreds of briefs over the years and has argued dozens of the most challenging cases himself. Because much FCC litigation is in the D.C. Circuit, the judges of that court know Mack well and regularly advise incoming FCC General Counsels that they hold Mack in high esteem.

This Master Class will be taught by **Dale N. Hatfield**, engineer, consultant, adjunct professor at the University of Colorado and former Chief of the Office on Engineering and Technology at the FCC. Hatfield will then draw upon his four decades of experience in the field to trace how technological developments have supported the federal government's (i.e., the FCC and NTIA) efforts to reduce the rigidities in the rules and policies governing the management of the radio spectrum resource in the past and how subsequent developments in terms of software defined and "cognitive" radios are currently producing additional opportunities to introduce even more dynamic methods for managing that crucial resource.

Two of Mack's most important triumphs came in unusual Supreme Court cases where the Department of Justice took a position in opposition to the Commission. In FCC v. National Citizens Committee for Broadcasting (1978), Mack successfully defended both the newspaper-broadcast crossownership rule and the Commission's decision to grandfather some existing cross-ownership situations even though DOI (like the D.C. Circuit) contended that the Commission should not have permitted any grandfathering. In Metro Broadcasting (1990), Mack successfully defended the FCC's minority ownership programs for broadcasters from an equal protection attack even though the Justice Department opposed the FCC's position (in a brief signed by Acting Solicitor General John Roberts).

Mack's leadership has made the FCC's Litigation Division one of the Commission's finest components. Mack has regularly recruited excellent lawyers and turned them into better lawyers. Some, like Mack, stay in the Division for many years, providing a cadre of top appellate litigators for the Commission. Others learn to draft briefs and present oral arguments and then go on to other positions. The nomination for Mack noted that: "[a]ttorneys who have worked for him in the Litigation Division, even many years after they have moved into private practice or other

endeavors, speak of their experience with fondness, loyalty and respect."

The new FCBA Excellence in Government Service Award criteria consider an individual's long term federal government service, commitment to public service, and dedication to excellence, as well as his or her role in mentoring more junior government employees. A large number of excellent candidates were nominated for the award, including some who are not lawyers and some who do not work at the FCC. The annual award, which honors people with outstanding careers in federal service in the field of communications, is open to federal employees in all fields, and all agencies.

among us who do not have a full appreciation of the many privileges they enjoy. Community service credits are also available.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at 4:45 pm in comfortable clothes and shoes. Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available.

Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite

appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 pm.
