

Some agencies and branches of the Federal Government do, however, apply additional stipulations above the regulation issued by the Office of Government Ethics. Invitations to Members of Congress, Congressional staff, and employees of the Department of

State must be issued by the FCBA. **Requests** for invitations to be sent must be received by Friday, November 7, 2008. Contact the FCBA for additional information.

While this event has been cleared by the Office of General Counsel in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's Office of General Counsel.

### HLS/Emergency Communications

The HLS/Emergency Communications Committee is chaired this year by Lynn Charytan, Rosalind Allen, David Furth, and Scott Tollefsen. Support for public safety and emergency communications are a concern that crosses party lines, so we expect continued focus on these concerns both on the regulatory and legislative fronts over the coming year.

The Committee hopes to provide a forum this year that will support discussion by the full range of players with an interest in emergency communications: private industry, the public safety/emergency communications advocacy groups, Members of Congress, the FCC — and other agencies that have an interest in this area, including DHS and FEMA, DOJ, and others.

Our fall events included "From Katrina to Ike and Bevond: Hurricane of Responses Emergency Communications Providers," a lunchtime brown bag discussion on October 24, at WilmerHale's offices, that reviewed what carriers and the FCC have done to support communications services and networks over this most recent hurricane seasons. Panelists included Jennifer Manner, from the Satellite Industry Association, Robert Mayer, from USTelecom, Christopher Guttman-McCabe, from CTIA, and Victoria Velez, Deputy Chief of the Public Communications Outreach and Operations Division in the FCC's Public Safety and Homeland Security Bureau. Later this fall, we plan to have the PSHSB Bureau staff in to highlight the key issues on the Bureau's agenda for the coming year.

We welcome suggestions on additional topics and speakers. We are beginning to develop ideas for continuing legal education sessions, as well; please let any of us know if there are areas where review would be particularly helpful.

### Rocky Mountain Chapter

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at 4:45 pm in comfortable clothes and shoes. Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available.

Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.

# In **MEMORIAM**

### "Ernie" Jennes Helped Lead Bar Out of Comparative Hearing Era

**Ernest Woodrow Jennes**, who was in the first generation of communications law practitioners to focus on regulation rather than comparative licensing hearings, died October 4th at age 90. He was the founder of the communications practice at Covington & Burling, from which he retired in 1982.

Ernie was counsel to the Carnegie Commission on Educational Television, whose report laid the foundation for enactment of the Public Broadcasting Act of 1967. He later counseled the League of Women Voters on their sponsorship of the early Presidential debates.

He also was counsel to and the guiding spirit of the Association of Maximum Service Telecasters, during the period when "drop-ins" threatened loss of reception to interference in the fringe areas of existing high-powered television stations. To foster additional stations he led AMST in its support of "all-channel" legislation to require television receivers to tune stations on UHF channels 14-82 comparably with VHF channels 2-13.

Upon the advent of cable systems – then little more than cable antenna television systems (CATVs) — he quickly perceived that they would erode viewership and the economic base for free, local over-the-air television broadcasts, and Ernie waged an unrelenting battles before the Commission, the courts, and the Congress against cable's simulcasting of "distant signals," *i.e.*, non-local signals from out-of-area stations in bigger markets. When cable was a new concept, only vaguely perceived by members of Congress to be different from translator stations, part of his testimony before a House Judiciary s u b c o m m i t t e e contained an explanation of the difference.

When the Nixon administration attempted to retaliate

against Katherine Graham for the Washington Post's role in the Watergate exposé, by challenging the renewals of Post-Newsweek television stations in Jacksonville and Miami, Covington & Burling successfully defended their licenses.

During the era of "ascertainment" of local needs and interests, he encouraged his clients to engage with listeners and viewers where they lived. Thenchairman Burch is said to have charged up-and-down the hallways of the Commission's headquarters at 20th and M Streets, waving as an example of good ascertainment, the report, written by two co-owners, of their ascertainment in bars in remote Alaskan crossroads.



As the member of the firm's management committee with an extreme penchant for precision, Ernie was a formidable figure to associates and staff. Yet he heard out their arguments and often synthesized their positions with his. He took a personal interest in their advancement and offered generous emotional support in times of family illnesses.

Ernie exhibited the same exactitude in his personal activities as in his practice. When he took up sailing, he immediately enrolled in a night course in navigation. Upon his retirement from the firm in 1982, he and his late wife Elizabeth moved to Annapolis to devote themselves to sailing. He played an active role in the Chesapeake Bay Foundation.

He was a graduate of Yale College and the Yale Law School. Before joining Covington he served on a Department of Justice trial team in the successful capital prosecution of eight German saboteurs.
