PRESIDENT'S Message

DEAR MEMBERS:

Watching the extent of the devastation of Hurricane Sandy relatively unscathed has an undeniable effect. It may be different depending upon where you were and what other calamities you've lived through, how long your power was out and how many trees you have to have taken down. What I noticed being stranded at home with the family was how much we all craved continued communication with the world outside; how much it mattered when the broadband connection stopped working for a couple of hours, and how we had to adapt our expectations, even for a short time, to a lack of communication outside of the inhabitants of our immediate household. The folks in lower Manhattan and places hit hard by Sandy plainly have it much worse. The image of people crowding around the outside of a closed Starbucks in the hopes of picking up a still-functioning Wi-Fi signal speaks volumes about our need to be connected and to communicate, a need that seems exponentially greater in the immediate aftermath of a terrible storm.



The companies, firms and government agencies we work for and with have different missions, goals and measurements of success. But we are all united in recognizing the tremendous value of our interconnected ecosystem of communications networks, and the key role these organizations play in increasing the ability of Americans to communicate one to one, one to many and to broadcast emergency and other information. Technology made predicting the extent and severity of the hurricane possible, and all types of communications networks helped to spread the word that preparation was key to riding out the storm safely. Communications infrastructure providers prepared their networks and did what they could to keep communications flowing. And communication is critical to recovery and restoration. On the whole, we are fortunate indeed that the ability to communicate before, during and after Hurricane Sandy was harnessed for the common good and safety of all.

The FCBA had to cancel several events as a result of Hurricane Sandy, and information about rescheduling will be forthcoming. Many other interesting events, CLEs and brown bag lunches are on track and are highlighted in the newsletter. In the spirit of helping others, please consider how you can support the upcoming Charity Auction on November 8. These include rapid re-housing for recently homeless families as well as transitional housing for families that have been homeless or living in shelters. They couple this assistance with a variety of youth counseling and

enrichment services for the children (including homework support, tutoring, mentoring, and wellness education), and they provide employment, mental health, and substance abuse counseling for their parents. Over the past 22 years, THC has established a great track record of giving DC families the tools and support they need to break the cycle of poverty and establish economic independence in safe and stable housing environments.

The FCBA Foundation will use proceeds from the Charity Auction to support its annual college scholarship program.

In addition to focusing our efforts on raising the most money we can for the beneficiaries, this year, the Charity Auction Committee has focused on a spirit of volunteerism and finding ways to partner with the beneficiaries to further their missions. As part of this effort, we have held a number of community service events with THC. These include an event in September where FCBA members helped one formerly homeless family (a mother and her two little girls) move in to temporary housing, and we furnished a second apartment for another family that would soon move in to the building.

A few weeks later, the Auction Committee—in conjunction with the FCBA's Privacy and Data Security Committee—presented a family online safety training program for THC's beneficiaries. The one-hour training leveraged our bar's expertise with privacy, online safety, and data security to help further THC's mission of educating the children and parents in their program. The event was one of the most well-attended sessions that THC has hosted and received an enthusiastic welcome from the children and their parents.

The regulatory foxtrot - slow, slow, quick, quick, slow - means that participants in the spectrum policy dance need to keep an eye both their current and future partners. Multiple cycles line up this year: it's a century since the sinking of the Titanic and the 1912 Radio Act, ten years since the FCC Spectrum Policy Task Force Report (SPTFR), and the end of a four-year Administration that saw the FCC's National Broadband Plan, a Presidential Memorandum calling for 500 MHz of spectrum to be found for wireless broadband use, and a report of the President's Council of Advisors on Science and Technology (PCAST) about realizing the full potential of government-held spectrum.

It is a time when pressure on spectrum allocations keeps growing due to the drumbeat of new broadband wireless applications, a crowded dance floor with a growing diversity and density of conflicting radio operations, and a crescendo of technologies such as smarter radios and heterogeneous networks. This presents an opportunity to look back at lessons learned, and prepare for

challenges of the next four and ten, if not a hundred, years.

most cases, individuals and organizations may issue invitations to the Chairman's Dinner without the involvement of the FCBA. Some agencies, departments and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics. Individuals who have signed the Administration's Ethics

pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. While this event has qualified as a widely-attended-gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's

Office of General Counsel. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State must be issued by the FCBA. Contact the FCBA for additional information.

In MEMORIAM

Stephen L. Markendorff (1944-2012)

Steve Markendorff, a retired FCC engineer known to his colleagues as “Mr. Cell Tower,” died October 9, 2012 at Duke University Medical Center. During his 34 years at the agency, 1967-68 and 1972-2005, Steve became an expert in the licensing and regulation of cellular telephony and was known as a fierce advocate for an engineer-in-training program and the hiring of young engineers at the FCC.

He served as Chief of the Cellular Radio Branch of the former Mobile Services Division in what was then the Common Carrier Bureau. He later became Deputy Chief for Engineering of the Commercial Wireless Division in the Wireless Telecommunications Bureau. He interrupted his FCC service to serve with the U.S. Air Force from 1968 to 1972.

Steve graduated from the University of South Carolina with a degree in electrical engineering. Friends in his retirement community of Southport, North Carolina say that he so loved the athletic teams of his alma mater that he played golf with orange balls he styled “Gamecock eggs.”

FCBA member Greg Vogt, a former colleague in the Mobile Services Division, recalled of Steve: “He was always of good cheer, extremely bright and energetic. He was a problem solver and an excellent manager. He was very much part of the original cellular hearings and lotteries, which changed into auctions.”

Before retiring to Southport, Steve and his wife, Judy, lived in Annandale, Virginia, with their son, Robert, and daughter, Stacey, all of whom survive.

Pursuant to the Office of Government Ethics regulation on widely-attended gatherings (5 C.F.R. 2635.204(g)(2)), the Chairman's Dinner appears to qualify as a widely attended gathering. The value of an individual ticket to the dinner is \$225.00. Most employees of the Federal Communications Commission and the Commerce Department may be directly invited to attend the dinner as guests of individuals and organizations purchasing tables or tickets. In most cases, individuals and organizations may issue invitations to the Chairman's Dinner without the involvement of the FCBA. Some agencies, departments and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics. Individuals who have signed the Administration's Ethics pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. While this event has qualified as a widely-attended-gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's Office of General Counsel. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State must be issued by the FCBA. Contact the FCBA for additional information.
