# Halloween Kick-Off for Communications Law 101 Seminar

The FCBA's two-day annual seminar "Communications Law 101: A Practitioner's Primer" may happen to open on October 31 this year—but the daylight-hours sessions will be devoted to demystifying the subject matter and unmasking any spooky uncertainties about communications regulation. A broad contingent of lawyers and other specialists in government service and the private sector will provide a nuts-and-bolts introduction to the law on October 31-November 1, 2002, in cooperation with the Georgetown University Law Center's Continuing Legal Education Program in Washington, D.C.

The seminar offers participants an overview of traditional areas of practice, such as wireline telephony and broadcasting, as well as insight into leading policy debates such as spectrum management, the transition to digital television, and the interplay between FCC regulation and bankruptcy law. Although the seminar is tailored primarily for new lawyers beginning their careers in firms, government agencies, or communications companies, experienced attorneys also may find the event a useful complement to their practice. All questions are welcome-no matter how rudimentary.

The FCBA also has made an effort to keep fees affordable. Registration this year costs \$250 for lawyers and

#### **DEAR MEMBERS:**

In October the FCBA will present several major events. First, in lieu of a monthly luncheon, we will hold an evening reception on October 24th for the FCC Bureau Chiefs. This is a first for



the FCBA and should provide a great opportunity for our members to meet those Bureau Chiefs they may not know or spend time with those they do. We hope that the Bureau Chiefs will include their deputies and other senior staff.

Second, the Executive Committee Retreat will take place on October 5th. We have invited all of the Chapter Co-chairs to join us for a half-day planning meeting. We intend to discuss the Association's agenda for the rest of the year and whether we are meeting the needs of the membership. Part of our day will be spent in break-out groups discussing the following:

"Are We On Track? A Critical Review of Key FCBA Events" Are FCBA events meeting member expectations? Should changes be made to any of our marquee events? Should any events be dropped from or added to the calendar? What major events are the FCBA chapters planning for the coming year?

"Closing the Budget Gap: Sponsorships and Other Revenue-Generating Activities" How can the FCBA ensure a solid fiscal foundation in an economic downturn? What other actions could/should the Association take to generate revenues and protect our members from dues increases?

"What Else Can We Do? Exploring Alternatives for New Member Services" Should the FCBA develop and provide new services to its members over the coming year? Which new services would have the greatest value, and which ones could realistically be implemented? How can the FCBA better integrate young lawyers and other sectors of the bar into Association activities?

We hope to receive recommendations from each break-out group, and then decide as a whole our priorities for the year. I will report on these recommendations and priorities in a future President's Message.

Third, the CLE committee continues to do a tremendous job in scheduling timely programs for our members. In October, the committee will host a seminar on bankruptcy issues for communications companies and practitioners. Speakers include, among others, the FCC's **John Rogovin** and **Jackie Ruff.** 

Closing out the month, CommLaw 101 will take place at Georgetown University's Law Center on October 31 and November 1. **Rosemary Harold** and **David Sieradzki**, co-chairs of the program, have put together a terrific program with the help of **Carolyn Groves, Christy Kunin** and **Mary Beth Richards**. Once again, the faculty for this program includes FCC officials as well as members from the private sector

#### December 12 – 13, 2002: Annual Telecommunications Conference

For the 20th consecutive year, the FCBA and the Practising Law Institute will co-sponsor an annual Institute on "Telecommunications Policy and Regulation." This year's conference will be held on December 12-13 at The Ronald Reagan International Trade Center, scheduled to coincide with FCBA's Chairman's Dinner on December 12.

The Conference will be keynoted by Senator George Allen (R-VA), a member of the Senate Commerce, Science and Transportation Committee, and FCC Commissioner Michael Copps. Additionally, FCC Commissioner Kevin Martin will be the featured luncheon speaker on December 12. Other program highlights include three panels - conducted in the conference's traditional all question-and-answer format - dealing with developments in wireline telephone, wireless telecommunications, and the Internet. These discussions will be prefaced by tutorials offered by key FCC staff officials: Bill Maher, new Chief of the Wireline Competition Bureau; **Tom Sugrue**, Chief, Wireless Telecommunications Bureau; and **Scott Marcus**, Senior Advisor for Internet Technology, Office of Plans and Policy. Additionally, FCC General Counsel **Jane Mago** and Deputy General Counsel **John Rogovin** will provide a briefing on Commission legal issues.

The program will also include appearances by key Bush Administration communications officials: **Nancy Victory**, Assistant Secretary of Commerce for Communications and Information, NTIA; **David Gross**; Deputy Assistant Secretary of State for International Communications and Information Policy; and **Hew Pate**, Deputy Assistant Attorney General (Antitrust Division). Once again, the Institute's agenda will include a panel discussion on the telecommunications future and a debate – this year, on "Time

for Broadcast Deregulation?", featuring Jim Cicconi, General Counsel and Executive Vice President for Law & Government Affairs, AT&T, and Lauren "Pete" Belvin, Consultant to Qwest. The debate will be moderated by Alexandra Wilson, FCBA President-Elect. FCBA President Peter Shields will open the Conference program, and Henry Rivera, Clark Wadlow and Dick Wiley, of the FCBA's Conferences Committee, will serve as overall chairs. In addition, a number of Association members will moderate various panels.

A full agenda for the 1<sup>1</sup>/<sub>2</sub> day seminar, which is always very well-attended, is attached. As noted, a registration fee discount is available to Association members. See registration form on page 16

#### Raking Up [Email] Leaves

Utilities for Organizing & Archiving Your Messages

It's October, and autumn leaves are falling in full force. It's time to get out your rake and some large trash bags.

Fall is also the time of year that I rake and bag up leaves of another sort: my email messages. I receive hundreds of messages every day, and even though I liberally delete unneeded email, it's easy for me to accumulate over 500 MB of data and over 5,000 messages each year in my email database. As a result, my email program starts to slow down, taking what seems forever to load or, worse, to execute searches. I find it somewhat annoying when it takes over a minute to search for an email, especially when I'm on the phone with a client and need to refer to it or its attachment. I'm sure some clients may be annoyed, too.

Some practitioners just live with the delay, in order to maintain access to old emails. Others ask their IT departments to archive old emails, but these archives are sometimes difficult to access or require further IT assistance to open. This article describes how I use the tools integrated in my email program and two software tools available from third parties to manage my email database.

#### **DO-IT-YOURSELF**

There are a few tasks users can do on their own to enhance their email programs. The first is to clean out what I call "email debris." These include: (1) meeting reminders, (2) notifications about the availability of the day's releases, such as the FCC's Daily Digest or Federal Register; (3) email delivery receipts; and (4) other messages that were timely and critical when received but are no longer worth saving. I usually search these by "sender" and then delete them in batches.

A second task is to create sub-folders in your mailbox for certain categories of email and then move relevant messages out of your primary "inbox" and into these sub-folders. For example, I have sub-folders for specific clients, firm administrative mail, list-serv messages and even the JOTD, to name only a few. You can even get ambitious and create "sub" sub-folders or invoke your "message rules" options to route incoming email directly to these sub-folders. Then when you need to find an email, you would search only the appropriate sub-folder to reduce search time.

One sub-folder I recommend creating in particular is what I have named "Archived Mail." After deleting unnecessary emails and categorizing others, a final task is to move any remaining messages older than, say, six months to this archival sub-folder.

Deleting, categorizing and archiving files should speed the use and search of messages you are likely to need most often: those received during the past few months. On those few occasions when you need to find and open earlier email, you can select the archival sub-folder.

#### HIRED HELP

Another option for managing your messages is to use third-party software. Two programs available on the market today are "Mailbag Assistant" and "Mail Vault."

Mailbag Assistant is a Windows-based tool for organizing, analyzing and searching email messages. It reads and processes current and archived emails whether they are stored on a computer, on networked drives, or on removable media, such as a CD or DVD. More important to me, though, is that Mailbag Assistant complements and supplements my existing email program without interfering with it, leaving my original message files intact.

The program includes advanced features not available with many standard email programs. For example, it allows users to search multiple criteria and for approximate or Soundex (sound-based) matches. In addition, Mailbag Assistant contains filters to isolate emails that contain viruses

and a feature to extract email addresses and traffic statistics.

The user interface is an intuitive grid layout, which allows users to sort emails in a variety of ways just by clicking column headings. Alternatively, you can also use the program's E-mail Wizard and Quick-Match search features.

Mailbag Assistant supports a number of email programs, including Outlook Express, Netscape Messenger. Eudora, FoxMail, Juno and many generic mailboxes. Some mail formats, such as Microsoft Outlook, must be accessed by first importing them into Outlook Express or another supported program.

A trial demo is available at http://www.fookes.com/. Both single-user (\$29.95) and site licenses are available if you decide to purchase.

Message Vault is another Windows-based utility for organizing and searching messages that is similar to Mailbag Assistant, but includes a number of added features. For example, it supports many of the same email programs and has extensive indexing and search capabilities. Users can create a list of key words, then search by that list, message content, or correspondent. Alternatively, users can write a custom filter that will apply assorted criteria.

Unlike Mailbag Assistant, though, Message Vault will allow users to combine messages from more than one email program into one database. It will also allow multiple messages to be viewed in a single window.

Message Vault also offers a variety of archival features not included with Mailbag Assistant. For example, Message Vault employs compression techniques to allow users to store tens of thousands of messages with relatively little disk space. As an option, users can move attachments to offline storage; indeed, attachments typically represent the largest portion of message file databases.

One of the more significant issues in this proceeding is whether the unbundled network element platform, more commonly known as the UNE-P, will or should survive

# Resolution of Federal Communications Bar Association and Federal Communications Bar Association Foundation

WHEREAS, Max D. Paglin was a long-time member and supporter of the Federal Communications Bar Association Foundation (the "Foundation") and the Federal Communications Bar Association ("FCBA"); had a distinguished governmental and private sector law career, including 31 years with the Federal Communications Commission where he served as both General Counsel and Executive Director: served as a mentor and counselor to many communications lawyers through all stages of their careers; was involved in many charitable causes; and was a kind, generous and honorable man beloved by his many friends and colleagues in the FCBA;

WHEREAS, in 1984, in recognition of the 50th anniversary of the Communications Act of 1934, Mr. Paglin founded the Golden Jubilee Commission on Telecommunications ("GJC"), a non-profit organization formed to commemorate the history of telecommunications' role in society during the preceding 50 years;

WHEREAS, under Mr. Paglin's excellent and inspiring leadership, the GJC compiled a two-volume history of the Communications Act of 1934, as amended: A Legislative History of the Communications Act of 1934 (Oxford University Press, 1989) ("Volume I") and The Communications Act: A Legislative History of the Major Amendments, 1934-1996 (Pike & Fischer, 1999) ("Volume II");

WHEREAS, Mr. Paglin passed away June 8, 1999, shortly after the completion of Volume II:

WHEREAS, having completed its work under Mr. Paglin's leadership, the GJC has voted to dissolve and has graciously agreed to donate to the Foundation all of the funds remaining in its possession totaling \$5885.42, which funds were paid to the Foundation on May 24, 2002;

WHEREAS, the GJC has also generously agreed to make the Foundation the beneficiary of any future royalties from Volume II and has so arranged with the publisher;

WHEREAS, the Foundation currently awards a stipend to law students who work in unpaid positions at the FCC or in other governmental agencies working on communications law matters, to help finance their expenses.

NOW,THEREFORE, it is resolved that:

- 1. The Foundation will use the funds donated by the GJC and any royalties generated by sales of Volume II to provide a supplemental stipend of \$600 per year over each of the next ten years to be paid to the most deserving of the Foundation's stipend recipients, as determined by the Foundation. Should additional funds from royalties be paid over to the Foundation in the future, they will be added to the stipend. The winner of the supplemental stipend will be designated the "Max Paglin Intern," in memory of Mr. Paglin's contributions to the practice of communications law, the FCC and his colleagues and friends.
- 2. An original version of this Resolution will be transmitted to Mr. Paglin's family in gratitude for this generous contribution made to the Foundation and in recognition of Mr. Paglin's many contributions to the FCBA, the Foundation, and the practice of communications law.

By vote of the trustees present and constituting a quorum of the Board of Trustees of the FCBA Foundation this 13th day of August, 2002.
