CLE Seminar – “The Wake-Up Call – Telecommunications Policies One September Later”

Only a year ago, in the face of deadly terrorist attacks, New York City and Washington D.C.'s varied public and private telecommunications networks were put to the test. Public safety, public landline, commercial mobile and broadcasting networks experienced major difficulties in completing essential communications or faced challenges in rebuilding destroyed or compromised infrastructure. For example, first responders discovered obvious interoperability issues in their attempts at coordination of rescue and relief. A wide range of other problems surfaced. How are government policy-makers confronting these challenges? How far have we come in a year to assuring adequate network and nationwide capacity on landline and wireless networks, as well as redundancy and surviv-

ability in both commercial and government networks? Is there consensus within the government on how to address the telecommunications readiness aspect of homeland security, or is there contention for scarce resources? How will homeland security change telecommunications policy and network planning?


FCBA Career Night on September 19

The FCBA's Online Membership Directory

The online directory is accessible on the FCBA's website, www.fcba.org. Once you are on the main page of the website, click on the "Members Only" link to bring up the login page. To gain access to the on-line directory, enter your email address and the member password and click Submit. The member password will change on the 10th of each month and will be published as the last line in the masthead on page 2 of the monthly newsletter.

Once you are on the Membership Information page, you can search for members by name or organization. The file structure of the database used is based on the membership information each member submits when joining the FCBA or renewing their membership. You may enter the person's full name, the first name or the last name. For example, if you enter "Rick", you will get 30 matches representing every name in the database that contains that sequence of letters in the first or last name. If you are not certain of how the person has his or her full name listed with the FCBA, you will always get your most efficient search by entering the last name. The same search rules and techniques apply to searching by organization, using the pull down menu on the search line. Rather than typing in a complete firm name, you can enter only one of the names and the search will return all matches to you.

TELECOMMUNICATIONS POLICY AND REGULATION XX: DECEMBER 12-13, 2002

On **December 12-13**, at The Ronald Reagan Building & International Trade Center, our Association and the **Practising Law Institute** will co-sponsor their 20th annual Institute on "Telecommunications Policy and Regulation." The FCBA Chairman's Dinner also will be held on December 13.

Conference keynote speakers include: **Senator George Allen (R-VA)**, Senate Commerce, Science and Transportation Committee; FCC Commissioner **Michael Copps**; and, as luncheon speaker on the first day, FCC Commissioner **Kevin Martin**. Additionally, the seminar line-up includes four panels — conducted in a traditional all question-and-answer format — dealing with the marketplace developments in wireline telephone, wireless telecommunications, Internet and the telecommunications future. The first three panels will be prefaced by tutorials offered by key FCC staff officials: **Bill Maher**, new Chief of the Wireline Competition Bureau; **Tom Sugrue**, Chief, Wireless Telecommunications Bureau; and **Scott Marcus**, Senior Advisor for Internet Technology; Office and Plans Policy. Back to School in Your Virtual Library

Communications Research on the Internet – Part 2

Last month's article identified a variety of sources for communications-related information that practitioners could access via the Internet while on vacation. Now that school has started (at least for those with school-aged children), I would like to expand on that discussion to cover academic resources in greater detail. I would also like to cover email discussion groups.

UNIVERSITY SITES

August's article highlighted what I called the "granddaddy" portal for communications sites, located at china.si.umich.edu/telecom/ and which offers over 7,000 hypertext links to telecommunications resources on the Internet. This site is hosted by the University of Michigan and is maintained by Professor Jeffrey K. Mackie-Mason. Practitioners with an interest in Internet economics and analysis might also want to review his homepage, at <http://www-personal.umich.edu/~jmm/>.

While that site is a worthwhile place to start telecommunications research, there are a number of other academic sites that may be of interest to practitioners. These include:

EMAIL DISCUSSION GROUPS

Practitioners might also find it useful to participate in one or more of the numerous on-line "listservs" to exchange or monitor ideas regarding communications-related issues. Listservs are also referred to as law lists, mailing lists, electronic discussion groups, email lists, e-conferences and, sometimes, bulletin boards. A central computer maintains a list of subscribers, and when a subscriber sends an email to this computer (running the listserv program), the computer will forward it to all subscribers. In this way, membership lists only need to be maintained in one location. Moreover, subscribers are generally able to control the delivery of messages and unsubscribe at any time.

It is advisable, though, to subscribe to the lists one-at-a-time for a week or two to see if the topics discussed are relevant and if the volume of mail generated is reasonable; some lists are relatively quiet, while others can generate over fifty messages a day.


