
Reception to Welcome Commissioner Adelstein to be Held February 13

Commissioner Adelstein was sworn in on December 3, 2002. Before joining the FCC, Adelstein served for fifteen years as a staff member in the United States Senate. For the past seven years, he has been a senior legislative aide to United States Senate Majority Leader Tom Daschle (D-SD), where he advised Senator Daschle on telecommunications, financial services. transportation and other key issues. Previously, he served as Professional Staff Member to Senate Special Committee on Aging Chairman David Pryor (D-AR), including an assignment as a special liaison to Senator Harry Reid (D-NV), and as a Legislative Assistant to Senator Donald W. Riegle, Jr. (D-MI).

Prior to his service in the Senate, Adelstein held a number of academic positions, including: Teaching Fellow in the Department of History, Harvard University; Teaching Assistant in the Department of History, Stanford University; and Communications

Consultant to the Stanford University Graduate School of Business.

Adelstein received a B.A. with Distinction in Political Science from Stanford University, an M.A. in History from Stanford University, studied at the Kennedy School of Government at Harvard University and is a graduate of Phillips Academy in Andover, Massachusetts. He is a member of the National Academy of Social Insurance, the Phi Kappa Phi National Honor Society and the Pi Sigma Alpha Political Science Honor Society.

Adelstein, 40, was born and raised in Rapid City, South Dakota. He now lives in the Washington, D.C. area with his wife Karen and son Adam.

PRESIDENT'S MESSAGE

DEAR MEMBERS:

This month I would like to recognize the FCBA committee cochairs. It has been a privilege to work with a group of energetic and talented leaders. I am pleased to report that our committees are as active as ever, if not more so. We held a midyear co-chairs luncheon on January 28th to assess committee activities this year to date and for the remainder of the year. The officers provided an update on the status of the budget process (Michele Farquhar and Diane Cornell) and transition issues and leadership positions for next year (Sandy Wilson). Lastly, various



co-chairs took the opportunity to inform others of upcoming events, including the February moot court competition, our first daylong FCBA enforcement seminar, and the annual seminar. I want to encourage those of you who want to become more active in the FCBA to contact the committee co-chairs directly to offer your services—it is not too late to get involved.

I want to thank all of our co-chairs and report on a few current projects by some of the committees.

The Marketing & Membership Committee, Chaired by Pam Cooper, Chris Guttman-McCabe and Chuck Keller, are extraordinarily busy with several key initiatives. First, this group is working closely with Heidi to update and improve the FCBA's web site. Specifically, they are working to make the site more user-friendly and considering input from our membership survey and suggestions offered by some of you this year. Soon you will see the fruits of their efforts when you log on to the home page. Second, they are studying membership numbers and growth issues generally. They will coordinate with the Relations With Other Bars Committee, chaired by Roz Allen, Jennifer Manner and Nancy Ory, on membership outreach efforts to other bar associations and similar organizations, but they could use help with this project because it involves interacting with law schools, engineers, corporate counsel organizations, and other institutions. Third, this committee is re-writing the association's brochure—a project long overdue. Finally, the Marketing & Membership Committee is looking for ways to improve this Newsletter, including adding new features. If you have ideas or an interest in helping with any of these projects, please contact Pam, Chris or Chuck.

The CLE Committee co-chairs are doing an exceptional job coordinating and planning programs with the various substantive committees for every month of this fiscal year. You may recall that in some years there is a tendency to group these programs toward the end of the association's year. This year's co-chairs, Laura Phillips, Lauren Van Wazer and Mark Grannis took my mandate to increase the number of programs and spread them throughout the year quite seriously. Nearly every CLE program has been a sellout with attendance at or near 100 members each. And, importantly, we have finally launched a remote access program whereby members who reside outside of D.C. are able to call into our CLE programs. The Executive Committee talked about this issue for years and I am happy to report that this year's committee has begun this program. Special thanks to Executive Committee members Jim Blitz and Joe DiScipio for their oversight in launching the remote access project.

COMPUTERS FOR COMMUNICATIONS PRACTITIONERS

Remedies for Writer's Block

Mouse Ergonomics and Alternative Keyboards

Many will agree that computers are vital tools for communications practitioners. We use them almost daily to type or edit pleadings, maintain or look up addresses and telephone numbers, conduct research via online databases, and navigate our desktops and Internet browsers, to name only a few examples.

Working at a computer for extended periods, however, can sometimes cause discomfort, tightness or numbness in hands, fingers and wrists. Such soreness may be the onset of repetitive strain injury or "RSI." RSI is also known as cumulative trauma disorder ("CTD") and musculoskeletal disorder ("MSD"). One familiar example is carpal tunnel syndrome.

Some of these problems are related to the use of a mouse. Repetitively positioning, clicking and scrolling can overwork small muscles in hands and wrists. This article offers a few tips to help prevent mouse-related RSI, which can become painful (and sometimes irreversible) if not treated. Of course, though, you should see your doctor or physiotherapist for professional treatment and advice.

MOUSE ERGONOMICS

Probably the most important tip is to ensure the proper position and angle of your arm, hand and wrist when you use your mouse. Your mouse should be located on your desk so that you do not have to hold your hand in an unnatural or awkward position. Ideally, your mouse should be placed immediately adjacent to your keyboard, which is directly in front of you so that you do not need to reach too far or angle your wrist to use

either the keyboard or mouse. Your keyboard and mouse should also be positioned at a height that allows your elbows to rest comfortably at your side, with your forearm roughly parallel with the floor and level with your keyboard. ALTERNATIVE KEYBOARDS

Another tip is to get one of the new, enhanced keyboards that help reduce use of a mouse. These keyboards generally include a scroll wheel on the left side of the keyboard (to decrease the need to scroll with your right hand), "one-touch," or "hot keys" to provide quick access to programs or features

(e.g., Word, Excel, Internet, email program, and volume settings), and a palm rest. These keyboards can help avoid RSI significantly. In the coming months, I will cover voice recognition software that eliminates typing altogether.

Alternative keyboards are available from many local retailers as well as from online vendors. While they may cost more than other keyboards, they might save you on doctors' fees. Some practitioners would rather you spend your money on lawyers. On the other hand, some doctors would rather certain lawyers suffered from writer's cramp.


Foundation Benefits From the Bequest of a Longtime Bar Member

IN MEMORIAM

David M. Hunsaker

David M. Hunsaker, a long time member of the FCBA, died on November 29, 2002. David resided in Sterling, Virginia, and practiced communications law as a member of Putbrese, Hunsaker and Trent, P.C. in Sterling for the past 15 years. John Trent described David as an excellent attorney, a gentleman and a good guy. John remarked that during contract negotiations David always had to be the "good guy" because that was simply who he was.
