PRESIDENT'S MESSAGE

DEAR MEMBERS:

Happy New Year! I hope you and your families enjoyed the holiday season.

This month marks the halfway point of my term as President, so I want to use this column to recap some recent FCBA highlights and promote a few events for the new year. Beginning with our most recent major event, we held an extremely successful 16th Annual Chairman's Dinner on December 12th for over 1500 FCBA members and guests. Chairman Powell and his staff put



together an amusing video depicting what things could look like under a few alternate scenarios featuring different FCC Chairmen. Chairman Powell and his wife Jane were joined by all of the other Commissioners, including new FCC Commissioner Jonathan Adelstein, for the evening's festivities. Commissioner Adelstein even participated in the Chairman's video demonstrating that he, like his fellow Commissioners, has a good sense of humor and, importantly for us, supports our Association.

A successful 20th Annual PLI Conference was held on December 12-13 in conjunction with the Chairman's Dinner. Dick Wiley, Henry Rivera and Clark Wadlow put together a terrific substantive program covering many timely topics and including a host of speakers from all sectors of our industry. Our Executive Committee held its annual retreat in October and has since worked in various sub-committees on follow-up items for both short and long-term planning. We will hear from the last of those sub-committees at our January meeting and I will report on some of the new initiatives in future President's Messages. Lastly, our committee co-chairs have done a fantastic job of putting on a multitude of programs and addressing issues relevant to the Bar. In addition, we will hold a reception for members of the new Congress, probably in the February-March timeframe. Our Legislative Co-chairs, Bill Bailey, Larry Duncan and Mitch Rose are already working on this reception and will have details for us in next month's newsletter. I expect that we will hold between two and four lunches during the Winter and Spring months and, of course, our Annual Seminar, Chaired by Celia Nogales, Mike Senkowski and Kathy Zachem will take place on May 2-4 at The Homestead Resort in Hot Springs, Virginia.

Our Executive Committee continues to focus on a balanced budget and on ensuring sound policies for the Association. Sandy Wilson and I will appoint members to a new sub-committee in the next month to begin the transition process to Sandy's presidency. We are attempting to ensure as smooth a transition as possible and believe that a sub-committee of Executive Committee members will help maintain the momentum we have in several areas including fiscal policies, administrative policies and membership and other initiatives.



IN MEMORIAM

L. Reed Miller

L. Reed Miller, long-time FCBA member and former FCBA president (1975-76), died in late November. Reed also was the father of FCBA member Michael Reed Miller. In addition to Michael, Reed was survived by his wife Emilie, whom he married in 1943; by two other sons, George and Clinton; and by a brother and five grandchildren.

Reed was with the firm now known as Arnold & Porter from 1945 until his retirement in 1995. In fact, Reed was the first associate at the firm, which was then Arnold & Wiprud.

Reed grew up in Fairmont, West Virginia and received both his undergraduate and law degrees from West Virginia University. He worked his way through college but still distinguished himself with Phi Beta Kappa honors as an undergraduate and was a law review editor while in law school. After receiving his law degree in 1941, Reed joined the Army and served in a variety

of legal positions during the war. He had achieved the rank of Major by the time the war ended.

According to his colleagues at Arnold & Porter, Reed enjoyed telling the story of how he became a communications lawyer. In the early days of the firm, there weren't enough lawyers to permit anyone to specialize. It was necessary for young lawyers to handle any kind of case that came in - and Reed always handled his share. However, he did have one early opportunity communications law. Reed recalled that Abe Fortas called him in and said: "Reed. go down to the FCC and find out how to get a license for a radio station." Reed said he talked to some staff people at the FCC, talked briefly to another communications lawyer, prepared and filed the application, and obtained a radio station license for Fortas's client.

The next year, Paul Porter joined the firm and had a number of potential communications clients because of his background as former Chairman of the FCC. When Porter said to Abe Fortas, "Who have you got in here who knows anything about communications?" Fortas replied, "We've got Miller."

From that point on, Reed concentrated his practice on communications law, focusing primarily on broadcasting issues. According to his son Michael, Reed worked on all the "bread and butter" broadcasting matters of his time, including major comparative hearings, renewal and revocation proceedings, rulemaking proceedings and day-to-day regulatory issues. Among his long-time clients was the Harte-Hanks group.

Michael Miller also pointed out that Reed very much enjoyed the genuine friendships he developed with other communications attorneys, and enjoyed attending FCBA social events with his wife.

All four members of the Commendations Committee knew Reed and agree with a statement his son Michael made at Reed's memorial service: Reed was always a gentleman, and always considerate, friendly and respectful of others.

Attorneys receive a half-hour overview/orientation beginning at 9:30 a.m. over bagels and juice. Volunteers are expected to assist clients only during the time they are at the clinic. No special legal knowledge is needed — attorneys generally need to keep an eye out for potential legal issues while using their common sense to solve a myriad of questions and make referrals to other organizations. Experienced attorneys on-site will assist FCBA attorneys and other volunteers with any questions. Previous attendees have described this as "the most satisfying volunteer experience I've had as an attorney."

All members of the FCBA and of the DC Bar are welcome to volunteer. Paralegals and law students are also welcome.

The clinic is located at Bread for the City, 1525 7th St., NW Washington, D.C. Metro accessible on the Green line, Howard University Metro station, exit at 8th & R Streets.
