The new rules on telemarketing and unsolicited faxes will be the subject of a CLE seminar designed for practitioners who represent any business or non-profit organization that communicates with existing and prospective customers by phone or by facsimile. These broadranging new rules from the FTC and FCC have already been the subject of court appeals and petitions for reconsideration by the American Society of Association Executives, the National Association of Realtors, the Chamber of Commerce of the United States, and organizations representing travel agents, mortgage bankers, newspaper publishers, restaurant owners, wholesaler distributors, and air conditioning contractors. December 4-5, 2003: 21st Annual Telecommunications Policy and Regulation Conference

For the 21st consecutive year, the FCBA and the Practising Law Institute will cosponsor an annual Institute on "Telecommunications Policy and Regulation." This year's conference will be held on December 4-5 at The Ronald Reagan Center, scheduled to coincide with the FCBA's Chairman's Dinner on December 4.

The Conference will be keynoted by Congressman Robert Goodlatte (R-VA), a Co-Chair of the House Commerce Committee, and FCC Commissioners Jonathan Adelstein and Kevin Martin. Hewitt Pate, Assistant Attorney General, Antitrust Division, Department of Justice, will be the featured luncheon speaker on December 4. Other program highlights include three panels conducted in the conference's traditional all question-and-answer format - dealing with developments in wireline telephone, wireless telecommunications, and the Internet. Additionally, the Institute will feature tutorials by key FCC staff officials: William Maher, Chief of the Wireline Competition Bureau: John Muleta. Chief Wireless Telecommunications Bureau: David Solomon, Chief, Enforcement Bureau; and General Counsel John Rogovin. Donald Abelson, Chief of the FCC's International Bureau, and Janice Obuchowski, Ambassador to WRC, will also provide a discussion on international issues.

Once again, the Institute's agenda will include a panel discussion on the telecommunications future and a debate - this year, on "The Role of Federal vs. State Regulation", with **Bradford Ramsay**, General Counsel of NARUC facing off against **Dorothy Attwood**, Vice President of SBC, and with Harry Martin, FCBA President-Elect, as moderator. FCBA President Alexandra Wilson will open the Institute, and Henry Rivera, Clark Wadlow and Dick Wiley, of the FCBA's Conferences Committee, will serve as overall program chairs. In addition, a number of Association members will moderate various program segments.

AT&T Case In Perspective: A Twenty Year Retrospective Thursday, October 16 3:00 – 7:00 p.m.

Throughout the 1970s and early 1980s, the antitrust case against AT&T appeared to be a quixotic quest. But the perseverance of antitrust enforcers and the effective case management of Judge Harold Greene, as well as the efforts of various other backers in the political and business world, gave rise to the biggest antitrust success of the 20th century. The breakup of AT&T spawned competitive sectors in long distance and equipment manufacturing as well as transformed the nature of the telecommunications industry, ultimately paving the way for the regulatory reform effort launched by the Telecommunications industry and antitrust law, the repercussions of the AT&T case merit close examination twenty years after its settlement went into effect.

ANNUAL REPORT OF THE FCBA FOUNDATION JULY 1, 2002 to JUNE 30, 2003

Having successfully concluded its 12th year, the Federal Communications Bar Association Foundation (the Foundation) remains an important vehicle for community service because of the continued support of individual FCBA members and their firms and companies. The Foundation's official mission remains to:

- Support worthwhile communications-related and educational projects, as well as other community service projects, particularly those directed toward children and students, through financial contributions and volunteer services; and
- (2) Foster greater public awareness and understanding of the development of communications technology, resources and law, and the role of communications law practitioners.

During the past year, the Foundation served these goals in numerous ways. It awarded college scholarships to deserving students at public high schools in the District of Columbia and arranged for mentors from the FCBA membership to help those students in their transition to college. The Foundation also awarded stipends to law students taking unpaid internships in government positions related to communications policy. In addition, the Foundation organized volunteer sessions each month to make meals for the homeless at Martha's Table. and to deliver those meals with McKenna's Wagon; arranged outings with the Martha's Table Youth Group; gathered blankets for a new homeless shelter during a brutally cold winter; and collected holiday gifts for homeless children.

TRUSTEES

A board of 12 Trustees from the FCBA membership governs the Foundation. This year, our Trustees were Diane Davidson, Scott Delacourt, Brian Fontes, Audrey Glenn, Anna Gomez, Donna Gregg, Cheryl Leanza, Ruth Milkman, Greg Vogt, Tom Van Wazer, Kathy Zachem and myself. Anna and Kathy have both completed their final year on the Board, and the Foundation will surely miss their enthusiasm, leadership and generous commitment of personal time. Fortunately, the Foundation will benefit from new Trustees elected by the FCBA membership: James Coltharp, Praveen Goyal, Maureen O'Connell and Mark Van Bergh. In particular, Mark has photographed our volunteer activities for a number of years, and may finally find himself in front of the camera. Tom Van Wazer will serve as the Board's Chair for the coming year.

Special thanks to both Wiley, Rein & Fielding and to Cingular Wireless for hosting the Foundation's monthly board meetings this year. As usual, Stan Zenor and Heidi Kurtz provided us with dedicated and professional support.

SCHOOLS AND SCHOLARSHIPS

The Foundation awarded six college scholarships this year to deserving students from local public high schools. This year's recipients are Thanh Phuc Tran of Francis L. Cardozo Senior High School; Carolina Acevedo and Dawn Jennings of Theodore Roosevelt Senior High School; and David Lloyd, Shanata Harvey and Ashley Williams of Spingarn Senior High School.

The Foundation's college scholarships, which range from \$8,000 to \$20,000 over four years, are awarded based upon a number of criteria, including the student's academic success, attendance record at school, participation in school activities, service to the community, financial need, personal essays and interest in communications, computers or information technology. All of the applications we receive tell unforgettable stories of young people who overcame obstacles in their lives to prosper in school and give back to their community. Each year, our Trustees undertake the time consuming process of interviewing scholarship candidates in person before making our selections. Cingular Wireless and McDermott, Will & Emery generously provided us with facilities to conduct these interviews.

Members of the Foundation's Board of Trustees attended the awards ceremonies at Cardozo, Roosevelt and Spingarn Senior High Schools to present our scholarships in person. At Cardozo High School, we were joined by Mary Brooner of Motorola to present Thanh Phuc Tran with the "Motorola Scholarship" in the amount of \$12,000 over four years.

Once again, WBDC-TV ("WB-50") here in the District of Columbia created a special video presentation featuring this year's scholarship winners, which was shown at the FCBA luncheon on June 25 featuring Chairman Powell. Thank you to Shannon Days of the station and to Tom Van Wazer of the Foundation for coordinating this effort. Most of our scholarship recipients were able to attend the FCBA luncheon, together with teachers and administrators from their schools, to thank FCBA members in person. At the luncheon, Chairman Powell commended the Foundation and FCBA members who made these scholarships possible.

Over the years, the Foundation has awarded more than fifty college scholarships to deserving students from public high schools. The Foundation gratefully acknowledges the past support of **Motorola**, the **SBC Foundation** and the **Verizon Foundation**, as well as the support of individual FCBA members, for its scholarship efforts.

Under the guidance of **Anna Gomez and Scott Delacourt**, the Foundation continued its mentoring program for scholarship winners. Each scholarship recipient is paired with an FCBA member as his or her personal mentor, with whom he or she can share experiences and seek advice during the transition to college and thereafter. Thank you to all FCBA members who volunteered to serve as mentors this year, and to Anna and Scott for coordinating this program.

STIPENDS FOR SUMMER INTERNS

The Foundation also awarded stipends to four law students who took unpaid positions in government this summer to work on communications policy matters. These awards were made from the Chairman Robert E. Lee Scholarship Fund, established in memory of the former FCC Chairman and Commissioner who passed away after nearly thirty years of service at the agency. This year's recipients were Sarah Kenney of American University's Washington College of Law, who interned at the Enforcement Bureau of the FCC; Michelle Kozlov of Boston College Law School, who interned at the Office of the Attorney General of Massachusetts, working on high tech and computer fraud issues; Jerry Brito of the George Mason University School of Law, who interned at the FCC's International Bureau; and Kara Wyrsch of the University of Maryland School of Law, who interned at the Wireless Telecommunications Bureau.

Each of these interns received a stipend in the amount of \$2,500 for the summer to help defray his or her expenses. In addition, the Foundation selected Ms. Kenney to receive an extra stipend as the winner of this year's Max Paglin Award. Mr. Paglin was the former General Counsel and Executive Director of the FCC, and the founder of the Golden Jubilee Commission on Telecommunications, which generously donated royalties from its definitive legislative history of the Communications Act to the Foundation.

COMMUNITY SERVICE AND VOLUNTEER OPPORTUNITIES

Continuing a rich tradition, the FCBA sponsored more than two dozen volunteer events for FCBA members over the past year. Volunteers led by Howard Weiss and myself continued to make meals for the homeless at Martha's Table each month. They were joined by a number of distinguished guests this year, including Commissioner Kathleen Abernathy and her staff; members of the International, Media and Wireless Bureaus: and officials from the National Telecommunications and Information Administration. In addition, volunteers organized by Tom Van Wazer and Cara Sheppard Voth continued to deliver meals to the homeless on the streets of District each month in McKenna's Wagon, a mobile soup kitchen operated by Martha's Table.

Last December, FCBA volunteers again celebrated the holiday season by collecting gifts for needy families. Those gifts were distributed by Families Forward, Inc., a local charity that provides housing, job counseling and related services for families "in transition." Pam Cooper, David O'Neill and Mary Plantamura once again organized our efforts. In the past seven years, the Foundation has donated thousands of dollars worth of gifts to nearly 1,000 people in the DC area. Also last December, the law firm Lampert & O'Connor asked the guests at its annual holiday party to bring children's toys, books and games, which the firm then donated to Martha's Table for distribution to needy children in the community. Thanks you to Donna Lampert and Mark O'Connor for their thoughtfulness.

In January, the local group Families Forward contacted the Foundation regarding their urgent need for blankets



to be used in a new cold weather shelter at D.C. General Hospital, one of the few shelters in the District that provides assistance to families. Given the brutally cold conditions that month, the need for blankets at their new facility had become urgent. Within days of this request, FCBA volunteers, led by Pam Cooper, collected nearly \$2,000 and donated 100 blankets to the shelter. Thank you to Pam and to everyone who helped out with this effort.

The Foundation continued to create special events for the children of the Martha's Table Youth Group. On February 1, FCBA volunteers took the Youth Group skating at the Sculpture Garden Ice Rink on the National Mall. They were joined by members of the Prince William Panthers AA Youth Travel Hockey Team, led by Brian Umansky, son of former Foundation Board Member Barry Umanksy. After skating, we treated the young people to a pizza lunch and awarded them the first ever Stanley (Zenor) Cup. Unfortunately, the sniper crisis last fall forced the Foundation to cancel its annual trip with the Youth Group to a local pumpkin orchard.

At the luncheon on June 25th, the Foundation named Anna Gomez its Volunteer of the year. Anna has led our mentoring program and been an active participant in the Foundation's college scholarship and intern stipend awards, as well as its volunteer events. She made these time commitments despite a demanding schedule as a Deputy Bureau Chief at the Commission. Congratulations to Anna.

FUNDRAISING

Fundraising remained a special concern of the Foundation this year, given the continuing economic downturn and uncertainty during the Iraq war. Because of this, we were particularly grateful for the generous contributions made to support our activities. FCBA members donated \$7,500 to our annual giving campaign and contributed over \$18,000 through the membership dues check-off.

In addition, the Foundation received generous donations of \$12,000 from Motorola and another \$12,000 from the Verizon Foundation in support of our scholarship efforts.

Special thanks to Brian Fontes and Kathy Zachem for coordinating our fundraising efforts in a particularly difficult year.

As usual, the Foundation's fundraising efforts included three regular events: cosponsorship of the Charity Auction, to benefit a different non-profit organization each year; the Chairman's Dinner; and the annual Golf Tournament. Thanks to countless volunteers, each event was a success.

The 13th Annual Charity Auction, held on November 21, 2002, raised over \$50,000 for the non-profit organizations College Bound and Beacon House. College Bound provides mentoring, academic enrichment opportunities, and scholarships to local students to prepare them for college. Since 1999, College Bound has partnered with Beacon House, which works to empower, enhance, and assist local at-risk children and their families in enriching their lives and community. Special thanks goes to Auction Committee members Yaron Dori, Ryan Wallach, Jennifer Warren, Carolyn Groves, Pam Skipakoff, and Cheryl Leanza, Scott Delacourt from the Foundation. Thanks are also due to subcommittee co-chairs Bryan Tramont, Aspa Paroutsas, Chris Bjornson, Denise Coca, David Kirschner, Chuck Keller, Steve Hitchcock, Jason Groves, Amal Abdallah, Rudy Baca, Ray Rothermel, Pete Belvin, Greg Vadas, Jason Scism, Vin Paladini, Kevin Goldberg, Artie Lechtman and Billy Layton.

The 16th Annual Chairman's Dinner honoring FCC Chairman Michael K. Powell was held on December 12, 2002 at the Washington Hilton's International Ballroom. Over 1,500 FCBA members and guests were in attendance. Special guests included FCC Commissioners Kathleen Abernathy, Kevin Martin, Michael Copps and Jonathan Adelstein, as well as Assistant Secretary of Commerce for Communications and Information, Nancy Victory, the Deputy Assistant Secretary of State for Communications and Information Policy, David Gross, and the Chairman of the French Telecommunications Regulatory Authority, Jean-Michel Hubert.
