Online Membership Renewals

It is time to renew your FCBA membership. Your current membership expired June 30, 2011 and by renewing, your membership will be good through June 30, 2012.

TO RENEW ONLINE BY CREDIT CARD AND MAKE A CONTRIBUTION TO THE FOUNDATION:

The primary email and password used to sign in MUST be the same as have been used for online registrations in the past, by the individual who is being renewed. If the password is not known or has never been activated, click on the Forgot your Password? link and follow the instructions to generate a new password.
- To view your renewal invoice, go to the **My Transactions** link. Here you can see a list of all your orders and invoices. **Note: For details on a particular order click on the small box to the left of the order #.
- Go to the **Online Store** link. Make sure **Top 100 Products** is selected in the upper, left-hand pull-down box and click the **Go** button
- Select **FCBA Foundation Contribution**, enter the amount, and click the **Add to Cart** button.
- Click **Check Out**. Select billing information and click **Next**.
- Check the box for the **Dues Renewal Order**. Click **Next** and follow the instructions to process your payment.

- You must include the printed invoice along with your check and mail to the address on the invoice.
- If you would like to make a tax-deductible donation to the FCBA Foundation, please send in a check with your renewal and note the contribution amount.

We have been reminded that some firms/companies prefer to pay for a **group of membership renewals** at one time with one check. In order to do this, each individual member will need to print out his/her own invoice and as with mailed dues invoices in the past, submit it for payment through their internal channels. If we receive one check for multiple renewals, a copy of each individual invoice must be included. If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

While this event has qualified as a widely-attended-gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. **Employees of the Commerce Department** are required to obtain individual ethics clearance through the Department's Office of General Counsel. In many discussions of communications technology, policy, and business, satellite communications is an afterthought. But since the "open skies" policies spearheaded by the Office of Telecommunications Policy's Tom Whitehead and introduced by the FCC in the early 1970s, satellite communications has fundamentally changed all segments of the telecommunications industry video, voice, and data communications. In the case of video communications, the advent of competitive satellite services

fueled the growth of cable networks like HBO and TBS. In the case of voice communications, satellite technology challenged AT&T's long lines - and undersea cable - as the dominant mode of reaching distant locales. More recently, satellite communications, in the form of Direct Broadcast Satellite (DBS), challenged the dominant cable industry, deploying an all-digital system before the cable companies did. Finally, satellite communications is providing broadband Internet access to millions of subscribers around the world.

The rise and continuing role of satellite communications remains an underappreciated topic. Recently, however, policymakers have devoted more attention to satellite communications as a part of spectrum policy. Much of this attention reflects the discussion around Lightsquared's plans to deploy a more terrestrial based system under the "ancillary terrestrial component" regime, raising concerns from the GPS community as to interference with the operations of GPS systems. At the same time, DISH Network is taking a greater interest in acquiring spectrum devoted for satellite communications, recently investing \$2.9 billion in purchases of bankrupt satellite companies. It remains to be seen how

DISH will use this spectrum, but **one report suggested** that it now "has pieces it can use to offer TV video programming in the home via satellite, through the Internet, or wirelessly outside the home to smartphones, tablets or cars."

This conference will address the changing face of satellite communications, evaluating its overall impact, and placing it into context. To do so, it will bring together a range of leading policymakers, policy practitioners, and industry leaders, evaluating the international and domestic trends in satellite communications, with particular attention to its role in broadband communications. In so doing, it will seek to aid policymakers in what the Washington Post called Tom Whitehead's principal mission - "to get the federal government to become 'more anticipatory' in addressing rapid technological changes."

In **MEMORIAM**

James J. Freeman (1940-2011)

James J. Freeman, a communications lawyer for decades, passed away July 13 in Bethesda, Maryland at 70 after a short illness. He is survived by a large and loving family, including his wife Carol, their adult children M'liss, Jeff and Joe, and eight grandchildren. Services were held at the Church of the Little Flower in Bethesda.

Jim was a graduate of Gonzaga High School in D.C., Holy Cross College and Harvard Law School. On graduating from Harvard in the mid sixties, Jim began his legal practice in the communications group of Pierson Ball and Dowd, a D.C. firm with its roots in the era immediately after the passage of the Communications Act of 1934. First as an associate and then partner, he pursued a varied practice at Pierson Ball and Dowd and its successor Reed Smith Shaw & McClay until 1997, when he and two friends joined the Washington office of Kelley Drye & Warren. Jim retired from full-time practice in 2005, continuing occasional consulting from his new Eastern Shore home.

Jim's career as a communications lawyer spanned not only various regulatory areas but also related technical, financial and tax matters. He worked on radio and television regulatory and corporate transaction matters for a wide variety of businesses, including large group owners such as Gaylord and RKO General. He became actively involved in litigating comparative hearings for entities seeking to enter broadcasting, later contributing his litigation talents to a number of the RKO comparative hearings.

As broadcasting became more deregulated, Jim developed expertise in other areas, including assisting in filing the initial comparative applications for cellular telephone systems and leading the initial litigation before the Commission. He later developed a federal and state practice addressing entry, transfers of control, debt financings, and the like for entities ranging from pay phone providers to CLECs to interexchange carriers.

Jim did not seek to follow convention. Mid-life, he bought and rode to work on a roaring motorcycle. Jim was honored by his younger colleagues at Pierson Ball and Dowd with a motorcycle jacket.

The jacket, which Jim wore proudly, said "WIDE LOAD."

Jim's former colleagues note that Jim relished his role as a mentor, both professionally and in his personal life, through Catholic youth organizations.

The counterpoint to Jim's irreverent humor was his passionate and decadeslong attendance at Shakespeare Theater, National Symphony and other performing arts venues. He was a student of the classics and loved to read. He equally loved to garden, raising vegetables and flowers for at least the last 30 years.

Jim's wife Carol and their children were the foundation of his life. He viewed retirement as the opportunity not only to focus on his varied hobbies but also to share more time – and his sense of humor – with his family, and especially his grandchildren, thus spending more time with those very special people who had graced his life, and whose lives he graced.

FCBA REQUESTS PROPOSALS FROM U.S. LAW SCHOOLS TO HOST THE FEDERAL COMMUNICATIONS LAW JOURNAL

For many years, the FCBA has contracted with various U.S. law schools to publish the Federal Communications Law Journal. The FCBA's Law Journal Committee, in close coordination with the FCBA's President and Executive Committee, is issuing the Request for Proposals set forth below seeking submissions from accredited U.S. law schools interested in serving as the host institution for the Journal beginning with academic year 2012-2013. Submissions from interested law schools are due September 15, 2011. We encourage FCBA members to help publicize the RFP process. If you think your alma mater or another law school might be interested in making a proposal to host the Journal, please make that school aware of the RFP.

FEDERAL COMMUNICATIONS BAR ASSOCIATION REQUEST FOR PROPOSALS HOST INSTITUTION OF THE FEDERAL COMMUNICATIONS LAW JOURNAL

The Federal Communications Bar Association ("FCBA"), the official bar association of the communications industry, is undertaking an assessment of potential Host Institutions for its academic journal, the Federal Communications Law Journal ("Journal"). The Journal explores important issues of telecommunications law and policy in analytically rigorous and topical ways and, consistent with past practice, is to be published three times during each academic year. The copyright of the Journal is held, and will continue to be held, by the FCBA.

To this end, the FCBA is issuing this Request for Proposals ("RFP") to solicit proposals from accredited U.S. law schools to host the Journal. Potential candidate law schools should be able to demonstrate the following criteria:

 The law school has a commitment to a telecommunications curriculum such that students working on the Journal will both have some familiarity of the issues and be provided with active guidance from the law school's faculty.

- The law school will provide at least one faculty advisor who has a proven record of expertise and scholarship in the area of telecommunications law and policy. This expertise is essential to help the students evaluate the quality of potential submissions and to provide crucial editorial advice.
- The faculty advisor(s) should be familiar with and active in the telecommunications law and policy debate in Washington, D.C., such that the faculty advisor(s) can provide students with guidance as to which potential submissions are most timely, relevant, and useful to FCBA members and others.
- The faculty advisor(s) will be responsible for working with the FCBA Law Journal Committee and other FCBA members to discuss upcoming issues of the Journal, as well as working with the FCBA to hold conferences, symposia and the like that can result in the publication of the proceedings in the Journal.
- In the event a new host school is selected, the Selectee and its faculty advisor(s) should be able to demonstrate that school's willingness and ability to work cooperatively with the incumbent host school to ensure a smooth transition.
- Law schools submitting proposals are encouraged to state their vision for the Journal and provide any information they think would be pertinent for consideration by the FCBA.

Cost allocation between the FCBA and the host school is as follows:

- Host School: The host school will contribute in-kind services such as office space, library access, web design and hosting, and administrative costs. The students' time would be volunteered.
- FCBA: The FCBA will contribute to the production, printing, and mailing costs at a rate of \$2.50 per FCBA member to

- ensure that each of its members will receive a personal hard copy of each published issue of the Journal.
- Host School and the FCBA will split the residual income from sales of non-FCBA member subscriptions (e.g., law libraries) and from electronic databases such as Westlaw & Lexis on an "as agreed to" basis. Potential candidate schools are encouraged in their submissions to propose a reasonable percentage division of residual income.

Time Frames for the RFP Process:

- Issuance of RFP: May 2011
- Submissions Due: September 15, 2011
- Site Visits (if any) and Consideration of Finalists: October 30, 2011 February 1, 2012. Schools that are chosen as finalists may be asked to pay expenses for FCBA Journal Committee members to visit on-site.
- Selectee Announced: February 1, 2012 (thus allowing transition to occur during the remainder of the academic year while students are still on campus)
- In the event a new host school is selected, control of the Journal would pass to the Selectee at the end of the 2011-2012 academic year. Beginning with the 2012-2013 academic year, the Selectee will publish the Journal three times each academic year.
