Online Membership Renewals

To renew online by CREDIT CARD and make a CONTRIBUTION TO THE FOUNDATION:

The primary email and password used to sign in MUST be the same as have been used for online registrations in the past, by the individual who is being renewed. We have been reminded that some firms/companies prefer to pay for a **group of membership renewals** at one time with one check. In order to do this, each individual member will need to print out his/her own invoice and as with mailed dues invoices in the past, submit it for payment through their internal channels. If we receive one check for multiple renewals, a copy of each individual invoice must be included. If you are paying for multiple renewals by credit card, you must pay each invoice individually online.

The IEEE International Dynamic Spectrum Access Networks Symposium October 14 – 17, 2008 • Chicago, IL

The International Dynamic Spectrum Access Networks (DySPAN) 2008 symposium to be held October 14 - 17 in Chicago, IL, is sponsored by the IEEE (International Electrical and Electronics Engineers) Communications Society with participation from Qualcomm, Microsoft, NSF, Motorola, Alcatel-Lucent and other government and industry giants. In addition to IEEE Communications Society, the general sponsor and the leading worldwide professional organization dedicated to the advancement of communications technologies, the symposium has the following technical co-sponsor: SDR Forum; and is being presented in cooperation with the FCBA. All FCBA members will receive IEEE member registration rates. For program and registration information, visit www.ieeedyspan.org/2008.

Since its launch in 2005, DySPAN has emerged as a preeminent event for expanding the understanding of complex next-generation wireless systems and the efficient use of the RF spectrum. This includes the advancement of cutting-edge technical and multidisciplinary research as well as the practical applications related to commercial smart radio system technologies.

This year, more than 200 economists, engineers, network architects, researchers and academic scholars from the United States, Europe and Asia are expected to discuss the decentralized access of the radio spectrum, its operation in wider bandwidths and the ability to process large amounts of information, while making intelligent decisions. Highlighted during the event will also be the ways in which international regulators can capitalize on these advances to increase spectrum utilization and foster future wireless communications and networks.

On Tuesday, October 14th, the conference will commence with a day of full- and half-day tutorials that will explore "Successful Wireless Experiments and A Survey of Available Platforms," "Networking Cognitive Radio for Dynamic Spectrum Access," "Working with Programmable Platforms Including the GNU/USRP" and "Policy & Technology Intersections: Recent Development in Flexible and Dynamic Spectrum Use."

Extending from October 15th through the 17th, numerous experts representing the wireless industry and government will also share their views on RF spectrum dynamics and its influence on new regulations and wireless communications applications. These scheduled keynote speakers include Christopher B. Galvin, chairman & CEO of Harrison Street Capital LLC; Dr. Gee Rittenhouse, vice president of wireless research at Alcatel-Lucent Bell Labs; Jorge Pereira, principal scientific officer at the European Commission; Dave Borth, vice president, CTO and head of advanced technology, standards and common engineering at Motorola; David Cleevely, chairman of the Communications Research Network; and the Honorable Jonathan S. Adelstein, commissioner of the U.S. Federal Communications Commission.

Additional highlights of the four-day event will also include the presentation of nearly 50 technology and policy track sessions held from October 15th to the 17th as well as the daily presentation of live demonstrations showcasing spectrum systems and networks by world-leading researchers. This year's demonstrations will feature dynamic spectrum access, cognitive radio, and policy-based systems, prototypes, and

critical technology components and algorithms.

September 5, 2008 "Deregulation Revisited: A Tribute to Fred Kahn"

Friday, September 5, 2008 from 8:30 a.m. - 6:45 p.m. to be held at the Wolf Law Building, University of Colorado at Boulder. To say that Fred Kahn is the archetype and inspiration for the deregulatory policies that have transformed a series of network industries over the last thirty years is no exaggeration. His academic leadership and vision, captured in The Economics of Regulation, attracted needed attention and insights to a field long viewed as a staid exercise in natural monopoly regulation. At the New York Public Service Commission, Fred established a standard for leadership and thoughtful policymakers that elevated the role of such commissions across the country and began to change conventional thinking about telecommunications and electricity regulation. Finally, at the Civil Aeronautics Board, Fred Kahn took the helm of an agency on autopilot and reevaluated the wisdom of command-andcontrol regulations that are widely viewed as preventing entry and protecting incumbents. In so doing, he not only helped to transform the regulation of airlines in this country, but made clear that enlightened leadership can make an enormous difference in public policymaking.

Thirty years after the singular accomplishment of spurring the enactment of the Airline Deregulation Act of 1978, it is an opportune occasion to reflect both on the deregulatory initiatives of the last thirty years and, in particular, on Fred Kahn's teachings and contributions to that effort. An increasing number of commentators who previously advocated deregulation "no longer believe that deregulation has

been a complete, an unqualified, success," as Judge Richard Posner recently put it. This judgment begs the question what lessons can we learn from the deregulatory initiative in airlines, what to make of deregulatory efforts in telecommunications and energy, and whether the U.S. economy has indeed outpaced its foreign rivals in part because of its more nimble and less regulated market environment. Friday, October 17, 2008 from 8:30 a.m. – 1:30 p.m. to be held at the Cable Center, Denver, CO. The structure of the video programming industry is facing a perfect storm of technological change, increased competition, and calls for new regulation. Responding to these forces, both producers and distributors of video content are increasingly exploring new business models, ranging from streaming video to same day DVD release to video on demand. In some cases, these business models undermine established patterns of doing business and call into question existing regulatory policies. To explore this set of issues, this conference will bring together a group of industry leaders to examine the intertwined policy, business, and technological issues.

The conference will address the changing industry structure by focusing on three distinct set of themes-the opportunities and challenge of independent networks; the role of access regulation; and the impact of new technologies. In terms of the rise of independent networks, some view the challenges of the NFL Network and claim that the barriers to entry are simply too great. Others, however, suggest that the legacy model of cable networks is unsustainable in the face of continually rising programming costs and opportunities for distribution via the Internet. As to access regulation, the re-authorization of the program access rules and recently initiated proceeding looking at cable network bundling

reflect concerns about market power and vertical integration. For the cable industry, the increasing regulatory attention at a time of increasing competition is difficult to understand. Any new regulatory initiatives (or continuation of old ones) must grapple with the impact of new technologies, particularly those related to the Internet, and the question of whether TV viewing will be liberated from the traditional delivery channels and available in multi-forms and in different media or will continue to rely on intermediaries in a world where viewing habits may well be stubborn and resistant to change.

The Committee is not the "ethics police" for the FCBA. However, it can be a useful resource for members to stay abreast of ethics regulations that have a special impact on communications law practitioners. As in the past, the Committee expects to accomplish at least the following activities: (1) discussing with the Committee and, as appropriate, alerting FCBA members to new developments in ethics rules and relevant court cases that are likely to have a general impact on FCBA members; (2) hosting at least one continuing legal education seminar on ethics; and (3) if necessary, evaluating and responding to ethics-related complaints submitted to the FCBA by clients or others involved in particular matters.

On October 30, 2007, the Professional Responsibility Committee collaborated with the Access to Records Committee and the Legislative Committee in presenting a CLE seminar entitled "Lobbying Rules and Law at the FCC and Congress." The seminar was taught by a distinguished panel of expert practitioners and government officials. The seminar was well attended and well received.

With respect to ethics complaints, the Committee co-chairs are happy to report that there are currently no complaints before them. The Committee has no power to conduct lengthy investigations of, or sanction, members, but it will respond to complaints or inquiries by providing information about the relevant ethical obligations of the Association's members attempting, in appropriate _ circumstances, to mediate complaints and, where warranted, referring complaining parties to other Bar authorities.

The Wagon is a white van that is loaded up with sandwiches, snacks and soup. We meet at Martha's Table at 4:45 pm in comfortable clothes and shoes. Martha's Table is located in a yellow building at 2114 Fourteenth Street, NW, in the District, near the intersection of 14th and U Streets. On-street parking is available. Upon arrival we get assignments (some of us will distribute snacks and sandwiches, others will serve soup), and put on aprons before we depart in the van to 5th and New York Ave., NW (near the new Convention Center). We are driven by one of our experienced volunteers and the trip to distribution location takes about 10-15 minutes.

We serve about 30-75 people per visit including a few mothers who come for food for their families. The area is well patrolled by police. The food distribution is conducted in an efficient, calm and orderly fashion and many of the people we serve are quite appreciative of our efforts. Once we serve all of the food, we do a clean up of the immediate area. Total time for the distribution takes about one hour and we usually return to Martha's Table by or before 6:30 p.m.

In **MEMORIAM**

James Aloysius McKenna, Jr.

Jim McKenna, known to many FCBA members from his long and distinguished career in the practice of communications regulatory law, died on July 23, 2008, at the age of 90 at the Meadow Lakes retirement community in Hightstown, New Jersey. The cause of death was congestive heart failure.

Jim may be best remembered as one of the founding partners of the law firm of McKenna, Wilkinson & Kittner. In addition to the practice of law, Jim also owned radio stations in Minneapolis, Minnesota, Harrisburg, Pennsylvania, and Madison, Wisconsin. In addition, he held a minority interest in a television station in Cleveland, Ohio.

As an owner/businessman himself, Jim developed a keen sense of the practical side of the broadcasting industry. This proved useful both to his clients, including the American Broadcasting Companies, and to many of the younger lawyers in his firm who have gone on to establish themselves as leading practitioners of communications regulatory law in their own right.

Jim was born in Poughkeepsie, New York, and graduated from Catholic University in 1938 with a degree in chemical engineering. He proceeded to pass the District of Columbia bar exam at the age of 22, a year before he graduated first in his class from Georgetown University's law school in 1942. During the Second World War, Jim served as a communications officer. In 1952, he and Vernon Wilkinson founded the law firm that bore their names (and later added Joseph Kittner).

Jim's colleagues at the McKenna, Wilkinson & Kittner firm remember him as a gifted lawyer, a firm and demanding but always fair manager, and an astute businessman. He would on occasion dispatch one of the bright young attorneys in the firm to visit the radio stations that he owned, in order to learn how the stations operated.

One story that his former partners recall is how Jim came to represent ABC. As it happened, Jim was on the opposite side from ABC in a litigation matter, and handled himself and his victorious client with professionalism and courtesy. At the end of the case, Leonard Goldenson – ABC's chairman – approached Jim and asked if he would be willing to represent the network, which led to a relationship that endured for more than 30 years.

Jim was a long-time FCBA member and mentored many of our current members. His wife, Rebekah Rial McKenna, died last year. He is survived by five children, a brother, 13 grandchildren, and four greatgrandchildren.
