FCBA Foundation 2022 AWARD RECIPIENTS

The FCBA Foundation is pleased to announce it has selected 28 students from Washington, DC public high schools for merit and need-based awards and college scholarships to be distributed over four years of matriculation. Also, we will award scholarships to five law school students and stipends to 21 law school students who have accepted unpaid public service internships in communications-related agencies for the summer. None of these awards would be possible without the generous support of the FCBA's members and the organizations in which they work. We thank you for your generosity!

2022 COLLEGE SCHOLARSHIP PROGRAM

Under the leadership of the Foundation's college scholarship committee, **Rizwan Chowdry**, **Delara Derakhshani**, **Erin Griffith**, and **Roger Sherman**, the Foundation reviewed applications from high school students of diverse backgrounds with an interest in communications-related fields, including media, journalism, technology, engineering, or law. Thirty-six high school student applicants were interviewed and 28 of these were chosen to receive FCBA Foundation scholarship assistance funded over four years. Our scholarship recipients this year came from 14 local public high schools: Bell Multicultural, Benjamin Banneker, Capital City, Cardozo Education Campus, District of Columbia International, Duke Ellington, Dunbar, Eastern, E.L. Haynes, Jackson-Reed, McKinley Technology, School Without Walls, Thurgood Marshall Academy, and Washington Latin. All 36 of the applicants who attended interviews will be provided with new laptop computers.

2022 LAW SCHOOL SCHOLARSHIP PROGRAM

The Foundation's law school scholarship committee, **Avonne Bell**, **Anisa Latif Green**, and **Maureen Ohlhausen** led the efforts to review applications from current students at law schools across the country who demonstrated merit and need, as well as an interest in communications law and technology and public service. We received applications from students at schools across the country and awarded five \$5,000 scholarships.

2022 PUBLIC SERVICE INTERNSHIP STIPEND PROGRAM

Under the leadership of the Foundation's internship committee, **Avonne Bell**, **Edward "Smitty" Smith**, **Megan (Sunn) Bolton**, and **Brenda Villanueva**, the Foundation reviewed applications from students at law schools across the country. The Foundation awarded stipends ranging from \$200 to \$7,000 to 21 students who have accepted public service positions for the summer.

AT&T Scholarship (\$15,000)

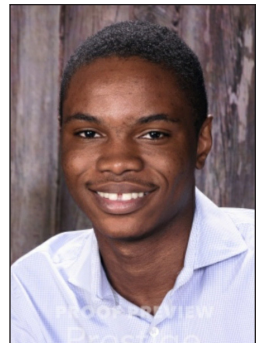

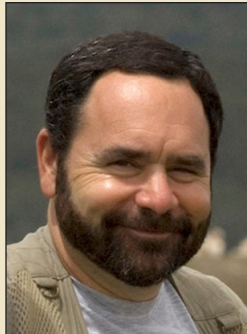

The Mark Van Bergh Scholarship

In 2022, family, friends and colleagues established the Mark Van Bergh Scholarship Fund in his memory. Mark was a long-time supporter of the FCBA Foundation and its mission. Each year, he would review applications, interview students, and photograph the award recipients. He would spend the day with them at the Comcast videotaping, where he would talk with them about their goals and aspirations. Mark had a unique connection with these students and truly cared about helping them to achieve their dreams.



Mark was a regular presence with a camera at Association events. For decades, Mark captured FCBA members at nearly every event that the Association held. More than anything, people remember how genuine he was. He was a friend to all and truly cared about each and every person he encountered.

Mark was also a long-time FCBA member and held virtually every position in the Association other than President, including Secretary, Treasurer, and member of the Executive Committee, and member of the Board and Chair of the FCBA Foundation.

Mark was born in New York City on November 28, 1956. He attended high school in White Plains, and then Syracuse University, graduating in 1978 magna cum laude and Phi Beta Kappa with a B.A. in political science. He then attended George Washington University School of Law, graduating in 1981 with honors. Mark practiced communications law with Jim Edmundson and, later, Richard Waysdorf, and with firms such as Gardner, Carton & Douglas, Roberts & Eckard, and Arter & Hadden. He was a solo practitioner from 2003.

Parallel to his legal career was Mark's work as a photographer. Besides his assistance for the FCBA and FCBA Foundation, Mark photographed many things over the years, including weddings of friends and colleagues, travels to exotic parts of the world, and local events, such as those at the National Zoo, and much more.

In honor of Mark, the scholarship will provide deserving students assistance towards college tuition, a program that Mark whole-heartedly supported for over 25 years. This year, scholarships will be awarded to two students, **Temitola Adeola** and **Dilshad Naher**.

Consumer Technology Association (CTA)[®] Scholarship (\$10,000)

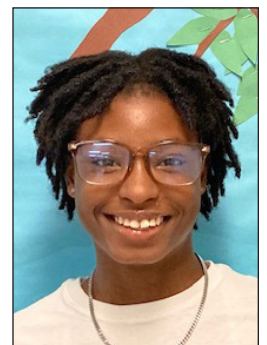

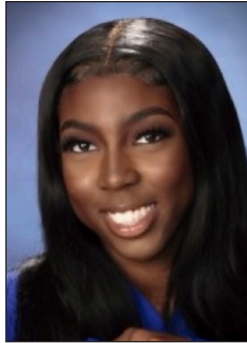

FCBA Foundation Scholarship (\$8,000)

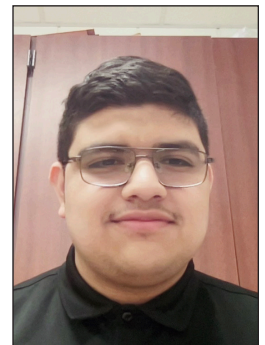

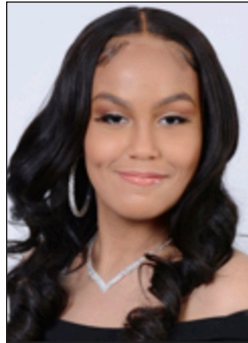

Google Scholarship (\$10,000)

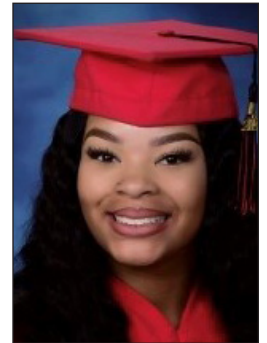

FCBA Foundation Scholarship (\$8,000)

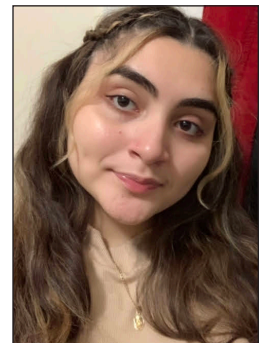

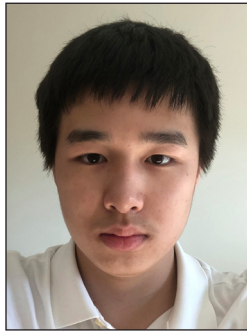

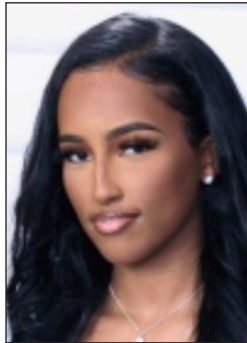

Verizon Scholarship (\$15,000)

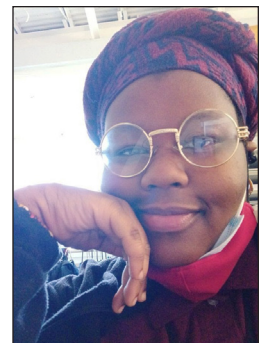
