FCBA Foundation 2023 AWARD RECIPIENTS

The FCBA Foundation is pleased to announce it has selected 24 students from Washington, DC public high schools for merit and need-based awards and college scholarships to be distributed over four years of matriculation. Also, we will award scholarships to five law school students and stipends to 10 law school students who have accepted unpaid public service internships in communications-related agencies for the summer. None of these awards would be possible without the generous support of the FCBA's members and the organizations in which they work. We thank you for your generosity!

2023 COLLEGE SCHOLARSHIP PROGRAM

Under the leadership of the Foundation's college scholarship committee, **Rizwan Chowdry, Erin Griffith, Karen Sprung, and Nicol Turner Lee** the Foundation reviewed applications from high school students of diverse backgrounds with an interest in communications-related fields, including media, journalism, technology, engineering, or law. Our scholarship recipients this year came from 14 local public high schools: Basis DC, Bell Multicultural, Benjamin Banneker, Cardozo Education Campus, Duke Ellington, Dunbar, Eastern, E.L. Haynes, Jackson-Reed, McKinley Technology, School Without Walls, Theodore Roosevelt, Thurgood Marshall Academy, and Washington Latin. All 24 of the recipients will be provided with new laptop computers.

2023 LAW SCHOOL SCHOLARSHIP PROGRAM

The Foundation's law school scholarship committee, **Avonne Bell, Anisa Green, David Grossman, and Brenda Villanueva** led the efforts to review applications from current students at law schools across the country who demonstrated merit and need, as well as an interest in communications law and technology and public service. We received applications from students at schools across the country and awarded five \$4,000 scholarships.

2023 PUBLIC SERVICE INTERNSHIP STIPEND PROGRAM

Under the leadership of the Foundation's internship committee, **Angela Ball, Avonne Bell, Meagan Bolton, and Mike Saperstein**, the Foundation reviewed applications from students at law schools across the country. The Foundation awarded stipends ranging from \$1,000 to \$4,000 to 10 students who have accepted public service positions for the summer.

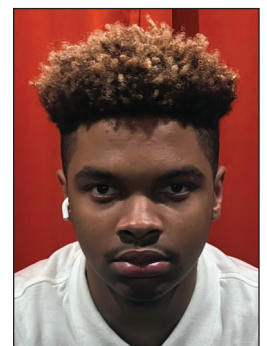

Fox Corporation Scholarship (\$20,000)

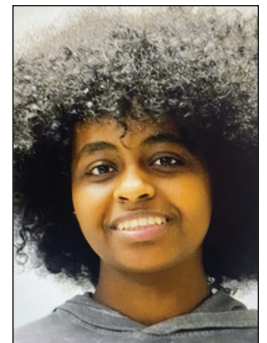

NCTA – The Internet & Television Association Scholarship (\$10,000)

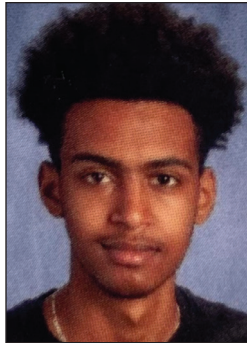

Comcast NBCUniversal Scholarship (\$15,000)

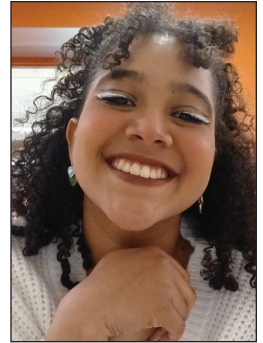

Mark Van Bergh Scholarship (\$10,000)

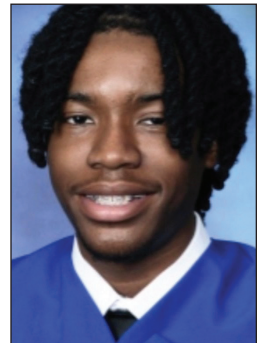

Qualcomm Incorporated Scholarship (\$10,000)

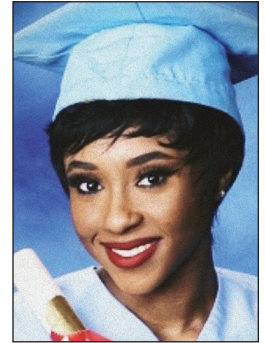

Mark Van Bergh Scholarship (\$10,000)

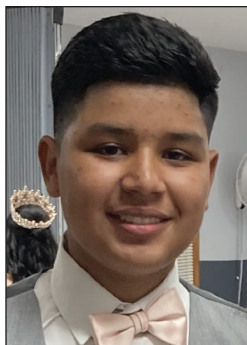

HECTOR RUIZ

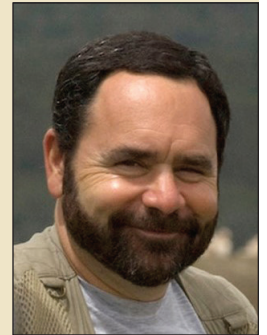
FCBA Foundation Scholarship (\$8,000)

In 2022, family, friends and colleagues established the Mark Van Bergh Scholarship Fund in his memory. Mark was a long-time supporter of the FCBA Foundation and its mission. Each year, he would review applications, interview students, and photograph the award recipients. He had a unique connection with these students and truly cared about their aspirations and achieving their goals. Mark was known to many as FCBA's 'photographer-in-residence,' an unofficial title earned by virtue of his regular presence with a camera at Association events. For decades, Mark not only captured FCBA members at our events, but he was a friend who genuinely cared about everyone.

Mark was born in New York City on November 28, 1956. He attended high school in White Plains, and then Syracuse University, graduating in 1978 magna cum laude and Phi Beta Kappa with a B.A. in political science. He then attended George Washington University School of Law, graduating in 1981 with honors. Mark practiced communications law with Jim Edmundson and, later, Richard Waysdorf, and with firms such as Gardner, Carton & Douglas, Roberts & Eckard, and Arter & Hadden. He was a solo practitioner from 2003.

Mark was also a long-time FCBA member and held virtually every position in the Association other than President, including Secretary, Treasurer, and member of the Executive Committee, and member of the Board and Chair of the FCBA Foundation.

Parallel to his legal career was Mark's work as a photographer. Besides his assistance for the FCBA and FCBA Foundation, Mark photographed many things over the years, including weddings of friends and colleagues, travels to exotic parts of the world, and local events, such as those at the National Zoo, and much more.

In honor of Mark, the scholarship will provide deserving students assistance toward college tuition, a program that Mark whole-heartedly supported for over 25 years. This year, scholarships will be provided to two students, **Keilyhan Suahily Echevarria Padilla** and **Jordan Mongardini**.

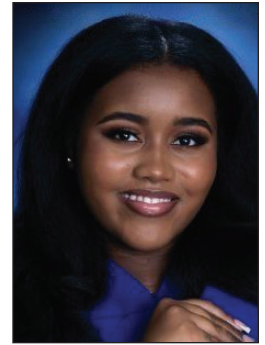


SHAKAYLA SMITH

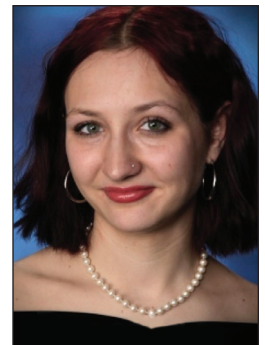

FCBA Foundation Scholarship

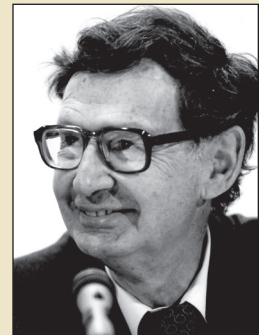

The Henry Geller Internship Stipend

The FCBA Foundation honors Henry Geller, a legend in the telecommunications field. Known for his encyclopedic institutional knowledge, Henry was an innovator, advocate and visionary who nurtured generations of communications talent. His energy and impact extended across a wide range of policies, from a Fairness Doctrine proposal that resulted in the end of cigarette ads on TV and radio to a successful challenge of the equal-time doctrine that led to a rule allowing televised debates among major presidential candidates.



His more than 50-year professional career included serving as general counsel of the Federal Communications Commission and the first administrator of the National Telecommunications and Information Administration as assistant secretary of the Commerce Department. Henry always advocated for the public interest, often against powerful corporations. He worked tirelessly to foster minority ownership of broadcast facilities and relentlessly pursued a 2% spectrum fee to provide support for public broadcasting.

Prior to joining the FCC in 1987 Diane began her career at the law firm Squire, Sanders and Dempsey (now Squire Patton Boggs). Between Diane's two stints at the FCC she served as vice president at CTIA and Inmarsat where she led regulatory and government relations departments. Diane also served as FCBA President from 2007-2008.

Diane's unique combination of keen intellect and transformative work ethic leave behind a legacy as a lawyer, policy maker, advocate, and passionate public servant that most can only imagine.

Internship: FCC, Wireless Telecommunications Bureau, Mobility Division

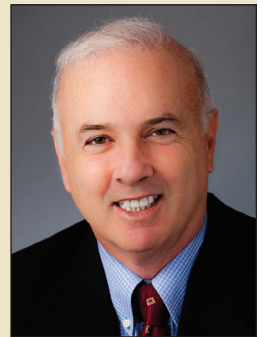
Recipient of the Diane Cornell Internship Stipend
