There remain in the United States remote geographical areas that are difficult to reach with traditional terrestrial networks. As part of the effort to bring ubiquitous connectivity to everyone, everywhere, the FCC recently adopted a regulatory framework for Supplemental Coverage from Space (“SCS”) to help close these gaps in connectivity. These rules will facilitate collaboration between satellite operators and terrestrial service providers to provide satellite-based connectivity directly to consumer devices using spectrum previously allocated only for terrestrial use. This has significant implications for public safety, as it expands the availability of emergency communications like 911 to remote, unserved, and underserved communities. It also poses some challenges, including avoiding harmful interference for existing operators in the relevant bands, that are critical to resolve so that SCS may realize its potential.

This CLE will include speakers from the FCC’s Space Bureau and Public Safety and Homeland Security Bureau, Intrado, Iridium, T-Mobile, and other key stakeholders. The first panel will focus on the FCC’s recently adopted SCS order and how the new rules will be implemented. The second panel will cover the FCC’s Further Notice, which seeks comment on additional proposals for public safety within the SCS context.

The President's October 30, 2023 Executive Order (EO) on artificial intelligence (AI) advances a whole-of-government approach to promote AI safety and responsibility. Ambitious and sweeping, the EO, among other things, establishes principles to guide future regulatory frameworks and directs numerous federal agencies to develop AI standards and policies.

The first session includes a panel of federal policymakers from key affected agencies to discuss how they have implemented the EO, their ongoing and future work to meet the EO's milestones, and their assessment of related issues, such as the latest thinking around the federal government's use of AI. The second session brings together a cross section of stakeholders from industry to discuss how the EO is changing their outlook on assorted issues of business and legal risk, including commercial priorities,

compliance, and best practices, and future legislative or regulatory changes.

Alan Davidson leads NTIA, the President's principal advisor on telecommunications and information policy. As NTIA Administrator, Alan oversees a federal agency with more than 500 employees working to close the digital divide, manage federal spectrum resources, and build a better Internet.

Alan has spent the last 25 years working at the intersection of Internet technology, public policy, and the law. In his roles in government, public interest groups, and companies, Alan has focused on how society makes choices about the technologies we build.

Before joining NTIA, Alan worked at Mozilla Foundation, a global nonprofit that promotes openness, innovation and participation on the Internet. As Mozilla's Vice President of Global Policy, Trust and Security, he led public policy and privacy teams promoting an open Internet and a healthy web. Alan served in the Obama-Biden Administration as the first Director of Digital Economy at the U.S. Department of Commerce. He started Google's public policy office in Washington, D.C., and as

Director of Public Policy, led government relations and policy in North and South America for seven years until 2012.

Alan has been a long-time leader in the Internet nonprofit community, serving as Director of New America's Open Technology Institute where he worked to promote equitable broadband access and adoption. As Associate Director of the Center for Democracy and Technology, Alan was an advocate for civil liberties and human rights online in some of the earliest Internet policy debates.

He is a graduate of the Massachusetts Institute of Technology and the Yale Law School, and is a member of the District of Columbia Bar.

clean opinions on its financial statements. Mr. Stephens has also served as a special advisor for the Universal Service Fund Oversight in the Wireline Competition Bureau, and as a senior audit manager and systems accountant in the Wireline Competition Bureau among other roles and responsibilities. In his over 32 years of experience at the FCC, Mr. Stephens has been in the Senior Executive Service for more than half of that time. Prior to joining the Commission, Mr. Stephens worked as an auditor with Grant Thornton LLP, and served in the United States Navy. He is a CPA and holds a Master's Degree in Telecommunications from the George Washington University and a Bachelor's Degree in Business Administration with an Accounting concentration from Loyola College.

New England Chapter Event on March 26

On March 26, 2024 at the Boston offices of Verrill Dana, LLP and virtually, the FCBA New England Chapter gathered with approximately 50 members and friends for a lunch-and-learn focused on pole attachments and infrastructure siting issues. The discussion featured practitioners' perspectives on how federal and state pole attachment regulations have evolved during a time of unprecedented broadband funding and with the introduction of new attachers. Geoff Why (Partner, Verrill Dana and Chapter Steering Committee member) moderated the discussion.

Jim White (Senior Director of Regulatory Affairs, Comcast) explained the industry's approach to pole attachment rate calculation and the development of regulations in our six-state region, where all states except Rhode Island have certified their own pole attachment rules. Jim explained how even minor changes in rate formulas can lead to significant cost increases or decreases. Jim described how New England states address issues like disputes between pole owners and attachers, and the importance of publicly-available data on factors implementing rates.

Paul Vasington (Senior Director of Public Policy, Verizon) summarized legislation adopted in approximately two dozen states to expedite small cells and collocated wireless facilities on existing structures. He outlined the 2018 FCC Wireless Infrastructure Order and associated legal challenges. Paul also provided an update on recent litigation in which Verizon and other providers successfully challenged the City of Rochester, NY's attempt to raise revenue via fees for pole attachments on municipal infrastructure.

Mike Watson (Vice President and Deputy General Counsel, Extenet Systems) explained how the FCC's December 2023 Pole Attachment Report and Order attempted to expedite broadband



deployment through an expedited dispute resolution process and a requirement that pole owners maintain and provide to attachment applicants periodic pole attachment inspection reports. He outlined questions raised by pole owners regarding how the FCC proposes to treat attachments in place before the Order, and attachers' requests to expedite applications for large numbers of pole attachments. Mike cited skilled labor shortages as a continued challenge for attachers.

Jody McColman (Deputy General Counsel, Maine Public Utilities Commission) summarized Maine's decade-long effort (involving six Commission inquiries and four rulemakings) to enhance

long standing pole attachment rules through both formal rulemaking and a collaborative process among pole owners and attachers. He described the state's new database for pole attachments.

The group then discussed questions about the future of pole attachments in light of new market entrants and significant federal and state broadband funding programs.

The New England Chapter thanks Geoff Why and Verrill Dana for their hospitality and lunch provided for the in-person attendees, our speakers for sharing their expertise, and our members and guests for joining us in Boston and online.

Brita Strandberg

I was fortunate this month that I was able to get a bit of time with Brita Strandberg, the founder of her own consulting and law firm, Strandberg Strategy. While Brita has had great success as a communications lawyer in private practice, several years ago she was offered the opportunity to join a corporate board, and after some consideration, Brita decided to accept the offer and start her own consulting and legal practice. Brita now focuses on providing strategic advice to telecom and SaaS companies while also serving as an independent director on the Aircall and Numeracle boards of directors. We talked about lots of things, including how board service works, as that is not a common gig for FCBA members.



Q: What attracted you to the field of communications?

A: Prior to finding communications as my chosen field I worked in other areas as an attorney and for one reason or another, I knew the fit was not going to be right over the long term. A few years after law school, when I was searching for a different law position, the opportunity to work in communications came up at a small communications boutique where I learned so much about communications technology and policy. I found there that I loved working with the innovators and engineers deploying new services, translating many of their brilliant ideas into FCC policy advocacy. It was and continues to be a thrill to support providers of emerging technologies, to help them navigate regulatory requirements, and advocate for public policy that supports innovation and competition. In addition to the day-to-day satisfaction of providing important regulatory counseling, I also have had some really great results for clients in high profile FCC Universal Service and numbering proceedings. Who would not love that?

Q: Tell us about the various places you've worked through the years.

A: I started in DC as an appellate lawyer and saw after a couple of years that while I was on track for partner, the amount of consistent, sustained high-octane effort required and the relative happiness of the partners I knew well made me question whether keeping on

keeping on was the right path for me. I then spent some time working as a civil rights lawyer defending employees and I learned a lot in doing that work. Honestly however, that role did not play to my strengths, and I decided I wanted to find something different. I was so fortunate to then find my way to communications law. Most of my telecom career has been spent at HWG, which is a wonderful firm – full of astoundingly smart and supportive colleagues serving interesting clients. About two years ago I left to start my own shop – Strandberg Strategy – so that I could focus on serving on corporate boards along with my legal work. I have to say that the boss at the new place can be a little demanding, but at least I know how to manage her!

Q: Have things unfolded in your career more or less the way you planned?

A: No and that's a good thing! One lesson I've learned is that the best opportunities are sometimes entirely unplanned, and it is important to be alert to them. You don't have to say yes to everything, but being open to change, to me at least, has been a critical part of my career development as a lawyer and now as a board member.

Q: What's the most interesting or challenging thing that you've done in your current position?

A: I serve on two corporate boards. As a board member, you have a fiduciary

duty to the company, and it is important to understand as much as possible about the business and to focus relentlessly on its success. To be a good board member, I must constantly learn, ask questions, evaluate challenges and opportunities, and effectively engage with management. Assuming this new role has been both exciting and challenging, and every day is different – which I have loved. I've particularly valued being a part of the hard conversations that can happen at the board level, and I find that being a good listener and communicator – core lawyer skills – can be useful as we navigate difficult decisions.

Q: Is or was there something interesting or someone who surprised or impressed you during your career and why?

A: I can think of a couple of examples – John Nakahata, my former colleague at HWG, continues to amaze me with his encyclopedic knowledge of communications law and his ability to use that knowledge to support his clients. Rebekah Johnson, the CEO at Numeracle, blows me away with how she has turned her vision for trusted communications into a successful and exciting company. And as for inspiring, I would have to call out all my former colleagues who have dedicated themselves to public service – folks like Stephanie Weiner, Austin Bonner, Sam Walsh, Shiva Goel, Susannah Larson, Scott Blake Harris, and Randy Sifers, among many others.

Q: What do you enjoy reading?

A: My favorite recent fiction read is *Demon Copperhead*, Barbara Kingsolver's stunning novel. It was magnificent and it spurred me to read *David Copperfield*, as the author uses the basic Dickens plot to retell the tale in an entirely new era and setting. And I love a good mystery. On the nonfiction side, I really enjoyed *American Rambles*, which recounts the author's walk from Capitol Hill to New York's Central Park.

Q: Is there something (a hobby or other tidbit) people don't know about you that you are willing to share?

Q: Can you share your perspective on the pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: In terms of career advice, in addition to being open to opportunities, I'd suggest considering zigging when everyone else zags. A number of years ago there was a moment when we needed to staff a Universal Service Fund audit for a client and I volunteered, and promptly had to find my way around numerous spreadsheets, understand client P&Ls, billing systems and other seemingly very

arcane stuff. I get that USF isn't always seen as the most interesting work. But it is very important to clients as a lot can be at stake for them – and my willingness to dig into USF has served me very well over the years.

Taking that a step further, given the pace of change in technology, there are constantly new areas that you can immerse yourself in so that you can be the next expert in cloud computing, AI, or something else. And don't ever assume that a project that may look at first like a slog is really that at all. It may end up being a great way to advance and at worst you will have learned something new.

Q: How has your life changed as a result of COVID-19 and what are you looking forward to doing next?

A: Without Covid I might not have been as open to a big career change – joining corporate boards and starting my own practice – and I'm very glad that I made that change. That change has also meant more travel and a greater variety of work. Right now, I'm looking forward

to continuing my work with clients and companies that make communications better.

Q: How long have you been an FCBA member, and what to you is the value of FCBA membership?

A: It feels like forever! I have been a member since before my kids were born, certainly, and they are in college now. I've benefited tremendously from my FCBA membership. The FCBA offers terrific continuing education opportunities, sometimes allowing younger professionals a new platform to showcase what they know and to be mentored by others outside of their own organizations. The FCBA has also helped me get to know any number of smart lawyers who are generously willing to share their insights and advice. And the events are fun, too!
