



## TMT LAW & POLICY CERTIFICATE PROGRAM

FCBA – The Tech Bar is committed to expanding access to opportunities within the legal profession across the technology, media, and telecom (TMT) sectors. To help advance this commitment, the FCBA TMT Law & Policy Pipeline Committee launched two groundbreaking initiatives in 2020: the TMT Law & Policy Pipeline Internship Program and the TMT Law & Policy Certificate Program. The Committee later strengthened these efforts by adding the Summer Series and Mentorship Program. Together, these programs aim to attract, train, and support first-year law students with a wide range of experiences and interests who aspire to build careers in TMT law and policy.

The FCBA TMT Law & Policy Pipeline Program (“Pipeline Program”) is a competitive internship and legal skills development initiative designed to prepare law students for impactful careers in TMT law and policy. The Pipeline Program creates pathways into the field by connecting students with paid internship opportunities through the TMT Law & Policy Pipeline Internship Program, introducing them to foundational concepts through the TMT Law & Policy Certificate Program, and offering continued support and professional development through the Summer Series and Mentorship Program.

The Pipeline Program’s primary goal is to expand access to the TMT field by building a pipeline of talented law students who are well-equipped to pursue careers in this sector. By increasing exposure to TMT law and policy early in students’ legal education and supporting their success in meaningful internships, the Program fosters long-term engagement in the field and helps strengthen the future of the FCBA and the broader TMT legal community.

The TMT Certificate Program consists of eight (8) virtual learning sessions that cover the following substantive areas of law: Administrative Law, Antitrust, Artificial Intelligence, Media and Content Regulation, Broadband (Wireline and Wireless) Regulation, Privacy, Data and Cyber Security, and other regulatory and legislative issues impacting the TMT industry sector. In addition, the Certificate Program includes a separate module on various styles of oral and written communication, advocacy, and workplace and client interactions.

Participating students also engage in a mock comment drafting and ex parte meeting exercise, designed to provide a practical, hands-on introduction to both written and oral regulatory policy advocacy at a federal agency. This exercise allows students to practice delivering their presentations to practitioners in a small group meeting and receive valuable feedback.

While completion of the TMT Certificate Program is required for TMT Law & Policy Pipeline Program Interns, it is open to all TMT Law & Policy Pipeline Program applicants. Upon satisfactory completion of the TMT Certificate Program requirements, participants receive a Certificate of Achievement from the FCBA.

### **Attendance Requirements**

All Student Participants can pursue a TMT Certificate, regardless of whether a student secures an internship through the Program. Student Participants offered an internship must fulfill the certificate program

requirements. To obtain a TMT Certificate, students must: (1) attend 75% of the virtual sessions; (2) complete a short writing exercise; (3) complete a mock comment drafting and advocacy exercise; and (4) participate in a survey of the sessions. Upon completion, Student Participants will receive an FCBA TMT Certificate of Completion.
